

The SN74LV32A-EP performs the Boolean function Y = A + B or  $Y = \overline{A \cdot B}$  in positive logic.

This device is fully specified for partial-power-down applications using  $I_{off}$ . The  $I_{off}$  circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.


