

# AFE4404 Development Guide

This user's guide describes the characteristics, operation, and use of the AFE4404 EVM demonstration kit. This demonstration kit is an evaluation module for the AFE4404 device. The family of devices are fully-integrated AFE, ideally suited for Optical Heart Rate monitoring and Pulse Oximeter applications. The EVM is intended for prototyping and evaluation. This user's guide includes a complete circuit description, schematic diagram, and bill of materials.

# 1 AFE4404 EVM Overview

# 1.1 Important Disclaimer Information

### **CAUTION**

The AFE4404 EVM is intended for feasibility and evaluation testing only in laboratory and development environments. This product is not for diagnostic use. This product is not for use with a defibrillator.

Only use the AFE4404 EVM under the following conditions:

- The AFE4404 EVM demonstration kit is intended only for electrical evaluation of the features of the AFE4404 devices in a laboratory, simulation, or development environment.
- The AFE4404 EVM demonstration kit is not intended for direct interface with a patient, or patient diagnostics.
- The AFE4404 EVM demonstration kit is intended for development purposes **only**. It is not intended to be used as all or part of an end-equipment application.
- The AFE4404 EVM demonstration kit should be used only by qualified engineers and technicians who
  are familiar with the risks associated with handling electrical and mechanical components, systems,
  and subsystems.
- The user is responsible for the safety of themselves, fellow employees and contractors, and coworkers when using or handling the AFE4404 EVM. ### 2 Overview

# 2.1 Introduction

The EVM is intended for evaluating AFE4404 device. The family of devices consist of a low-noise receive channel, the LED transmit section, and diagnostics for photodiode short fault detection. The AFE4404 supports three LEDs and a single photodiode. The AFE4404 has a highly-configurable timing controller, enabling complete control of the device's timing characteristics. The device can be clocked by an external clock or by internal oscillator. The device communicates to an external host processor using the I<sup>2</sup>C interface. The purpose of the EVM is to expedite evaluation and system development activities related to AFE4404 devices. The demonstration kit is shown in Figure 1.

Throughout the document, the term demonstration kit is synonymous with AFE4404 EVM.

# 2.2 AFE4404 EVM Kit Contents

- AFE4404 EVM Demonstration Kit
- USB-to-micro USB cable
- 10 pin to 10 pin sensor cable
- AFE4404 sensor board

# 2.3 Features Supported in This Version

- 1. Acquire data at up to 1000 sps in evaluation mode
- 2. USB-based power and PC application connectivity
- 3. Access to all AFE4404 registers via an easy-to-use GUI
- 4. Built-in time domain, histogram, and FFT on the PC application
- 5. USB-based firmware upgrade option

# 2.4 AFE4404 EVM Evaluation

Use the following steps as a quick start guide for AFE4404 EVM reflective sensing:

- 1. Install the PC application software
  - (a) Before installing the software, make sure the AFE4404 EVM is **not** connected to the PC.
  - (b) Run the executable and follow the prompts to install the software.
  - (c) The default installation directory will be:
    - On a Microsoft® Windows® XP machine C:\Program Files\Texas Instruments\AFE4404 EVM
    - On a Windows 7 machine C:\Program Files(x86)\Texas Instruments\AFE4404 EVM GUI

- (d) The detailed steps for installing the USB drivers are outlined in Section 3.3.
- 2. Install the USB driver
  - (a) The communication interface between the AFE4404 EVM board and PC is through the USB, using the CDC profile. A one-time installation of the USB driver is required for the communication between the AFE4404 EVM and PC application.
  - (b) Plugin the USB-to-mini USB cable to J1 of AFE4404 EVM and the other end to the USB port on the PC.
  - (c) Update the driver software from the Device Manager. The USB driver file AFE44xx.inf is located in the following directory:
    - On a Windows XP machine C:\Program Files\Texas Instruments\AFE4404 EVM GUI\USB Driver
    - On a Windows 7 machine C:\Program Files(x86)\Texas Instruments\AFE4404 EVM GUI\USB Driver
  - (d) The detailed steps for installing the USB drivers are outlined in Section 3.3.
- 3. Update the MSP430 firmware:
  - (a) Run AFE4404 EVM GUI.exe which is found in the chosen installation directory
    - On a Windows XP machine C:\Program Files\Texas Instruments\AFE4404 EVM GUI
    - On a Windows 7 machine C:\Program Files(x86)\Texas Instruments\AFE4404 EVM GUI
  - (b) Click on File at the top left of the window followed by *Firmware Upgrade*. A window pops up, click the **Continue** button.
  - (c) Click the **Browse** button and choose the desired hex file. This file should have a .txt extension (example: AFE4404\_EVM\_FW\_V1.0.txt).
    - On a Windows XP machine C:\Program Files\Texas Instruments\AFE4404 EVM GUI\Firmware Updater
    - On a Windows 7 machine C:\Program Files(x86)\Texas Instruments\AFE4404 EVM GUI\Firmware Updater

# 4. Test setup:




Figure 2. NJRC NJL5513R Sensor Board LED Connections

(a) The AFE4404 sensor board has two optical sensor modules: NJRC NJL5513R and OSRAM SFH7050. The NJRC sensor has two green LEDs and 1 red LED that are connected in parallel. Note that when in parallel, both LEDs represent LED1 and the red LED represents LED2. The OSRAM sensor has one infrared, one red, and one green LED. This sensor is configured in pushpull (common anode) mode. If the NJRC sensor is to be used, then make sure resistors R2, R4, R6, R8, and R10 are installed. If the OSRAM sensor is to be used, then make sure resistors R1, R3, R5, R7, and R9 are installed. By default, the NJRC sensor is used as shown in Figure 2. The sensor board also has an option to use the BMA280, which is an accelerometer. This is uninstalled by default.

(b) Connect the sensor module to the EVM. Make sure that the sensor is connected in the correct orientation – pin 1 should line up with the marking on the cable.




Figure 3. Setup for Obtaining Measurements from the Wrist

(c) Place the sensor side of the sensor board on the wrist and tie it snugly. Figure 3 shows the sensor board being held with a velcro strap. Holding the sensor down with a finger is not recommended because a high level of motion noise is likely to occur due to small movements and changes in pressure.




Figure 4. Pin 1 Connections




Figure 5. Connections




Figure 6. Sensor On with Black Electrical Tape

Note: Black tape is used to provide ground isolation.




Figure 7. Setting Sensor Board on the wrist



# 5. Capturing data

- (a) Run the AFE4404 EVM GUI found in the installation directory
- (b) Click on the ADC Capture & Analysis tab near the top of the window




Figure 8. Sample Waveform of Green LED Captured on the Wrist With NJRC NJL5513R

- (c) Click the Capture button to begin capturing data. Figure 8 shows a sample waveform:

# 3 Software Installation

The latest AFE4404 EVM PC application software (GUI) is available at <a href="www.ti.com">www.ti.com</a>. Download the latest file.

# 3.1 Minimum Requirements

Before installing the software, verify that your PC meets the minimum requirements outlined in this section.

# 3.1.1 Required Setup for AFE4404 EVM Demo Software

- IBM PC-compatible computer
- Pentium® III/ Celeron® 866 MHz or equivalent processor
- Minimum 256MB of RAM (512MB or greater recommended)
- Hard disk drive with at least 200MB free space
- Microsoft Windows XP SP2 operating system or Windows 7 operating system
- 1280 x 1024 or greater display screen resolution



# 3.2 Installing the Software (PC Application)

Before installing the software, make sure the AFE4404 EVM is **not** connected to the PC. If using a machine with Windows 7 OS, TI recommends having administrator rights to avoid problems during installation. Double click the executable to install the software. Unless otherwise specified during the install process, the software installs at the following location:

- On a Windows XP machine C:\Program Files\Texas Instruments\AFE4404 EVM GUI
- On a Windows 7 machine C:\Program Files(x86)\Texas Instruments\AFE4404 EVM GUI

The following steps ensure proper installation of the PC application.

- 1. Double click the executable from the Volume directory and follow the prompts to continue with the installation process.
- 2. Choose whether or not to create a Desktop Icon and click Install




Figure 9. PC Application Installation – Installation Directory

Select the destination directory and click the **Next >>** button to begin the installation.






Figure 10. PC Application Installation – Installation Directory

3. Accept the license agreement and click the **Next >>** button.






Figure 11. PC Application Installation – License Agreement

4. Click Next>> button to continue






Figure 12. Adding or Changing

5. The application software is now installed. Once the installation is complete, click the **Next>>** button to continue with the installation of Python v2.7. Once Python v2.7 is installed, click the **OK** button.






Figure 13. PC Application Installation – Installation Complete

Click Close. The PC application is now ready to use.






Figure 14. PC Application Installation – Installation complete

# 3.3 Installing the USB Drivers

The communication interface between the AFE4404 EVM board and PC is through the USB, using the CDC profile. A one-time installation of the USB driver is required for the communication between the AFE4404 EVM and PC application.

Using the following steps ensures proper installation of the USB drivers:

- Plugin the USB-to-mini USB cable to J1 of AFE4404 EVM and the other end to the USB port on the PC.





Figure 15. USB Driver Installation - Screen 1 (Windows 7 OS only)

- 2. Windows XP OS starts up the *New Hardware Wizard* to enable the user to install the USB driver for the new hardware. The Windows 7 OS attempts to find the driver for the *new hardware found* automatically and if the driver is not found, there is no pop-up message to indicate that the driver installation failed. In the Windows 7 OS, click on *Device Manager*, right click on *MSP430-USB* example under *Other devices* and click on *Update Driver Software* as shown in Figure 15. This step is not required for the Windows XP OS.

3. Select the Browse my computer for driver software option






Figure 16. USB Driver Installation - Screen 2




Figure 17. USB Driver Installation - Screen 3

- 4. As shown in Figure 17, navigate to the directory where the *AFE44xx.inf* file is located by clicking the **Browse** button. The file is located at the following path:
  - On a Windows XP machine C:\Program Files\Texas Instruments\AFE4404 EVM GUI\USB Driver
  - On a Windows 7 machine C:\Program Files(x86)\Texas Instruments\AFE4404 EVM GUI\USB Driver

Click the **Next** button to continue. The Driver file is copied to the system directory after clicking the **Next** button.

5. There may be a warning that Windows cannot verify the publisher of this driver software, as shown in Figure 18. Choose to install the driver software anyway to proceed.




Figure 19. USB Driver Installation - Screen 4

6. Click the **Close** button once the driver installation is complete (Figure 19).




Figure 20. Device Manager Screen

7. The AFE4404 EVM is now recognized as Virtual COM Port under the Device Manager as shown in Figure 20.

The USB driver installation is now complete and the EVM is ready to use.



# 3.3.1 Windows 8 Installing Unsigned Drivers

Perform an advanced startup sequence to let Windows 8 install unsigned drivers.




Figure 21. Windows 8 Installing Unsigned Drivers - Screen 1

Move the cursor to the top right of the screen, click settings, then power, then HOLD SHIFT and click Restart as shown in Figure 21.




Figure 22. Windows 8 Installing Unsigned Drivers - Screen 2

After a loading screen, three options appear. Choose Troubleshoot as shown in Figure 22.




Figure 24. Windows 8 Installing Unsigned Drivers - Screen 4

Choose startup Settings as shown in Figure 24.




Figure 25. Windows 8 Installing Unsigned Drivers - Screen 5

Next a list of options displays. Click Restart at the bottom right as shown in Figure 25.

After the computer restarts, the following screen appears (see Figure 26). Press F7 to disable driver signature enforcement.

# Startup Settings Press a number to choose from the options below: Use number keys or functions keys PI-F9. 1) Enable debugging 2) Enable boot logging 3) Enable low-resolution video 4) Enable Safe Mode 5) Enable Safe Mode with Networking 6) Enable Safe Mode with Command Prompt 7) Disable driver signature enforcement 8) Disable early launch anti-malware protection 9) Disable automatic restart after failure

Press F10 for more options Press Enter to return to your operating system

Now, the user can install unsigned drivers. A warning may appear as shown in Figure 27; choose *Install this driver software anyway*.

Restart the computer again to re-enable driver signature enforcement after the installation is complete.

# 4 Running the Software

Run the AFE4404 EVM GUI software by selecting the AFE4404 EVM GUI.exe which is found in the chosen installation directory (by default this is C:\Program Files(x86)\Texas Instruments\AFE4404 EVM GUI). Unless the hardware has been disconnected, observe messages that confirm the connection has been established and the program waits in idle mode for user input.

If the connection to the AFE4404 EVM board is not established, the program prompts to continue to run the GUI in *Simulation* mode, or to Stop and Close the GUI and check if the AFE4404 EVM is connected to the PC.

## 4.1 Overview of the Features

This section provides a quick overview of the various features and functions of the AFE4404 EVM software GUI. The GUI allows the user to easily configure the various functions of the AFE, such as receiver gain, bandwidth settings, LED current settings, and timing/clocking control settings.

Operations in the GUI should only be performed after the status bar (located at the bottom of the GUI) displays **Ready For New Command**.

The main tabs consist of:




Figure 29. Product Safety Warnings, Restrictions, and Disclaimers

- Product Safety Warnings Product Safety Warnings, Restrictions and Disclaimers (see Figure 29).
- Device Configuration Configures all the AFE4404 user registers in a series of related subtabs.
  - Global Settings
  - Tx Stage
  - Rx Stage
  - Timing Controls
  - Low Level Configuration
- ADC Capture & Analysis For viewing and analyzing the raw data.
- Save For writing data samples and analysis results to a file.

# 4.1.1 Device Configuration Tab

The Device Configuration tab allows configuration of the various registers of the AFE4404 device. This subtab contains five subtabs: Global Settings, Tx Stage, Rx Stage, Timing Controls, and Low Level Configuration.

# 4.1.1.1 Global Settings Subtab




Figure 30. AFE4404: Device Configuration: Global Settings

The Global Settings subtab for the AFE4404 device shown in Figure 30 has the following features:

- 1. View the Device ID and Firmware Revision
- 2. **Device Reset** button that resets the device. (Please note that after a device reset is issued, the AFE4404 device registers must be programmed correctly for the PC application GUI to function properly. See **Reset to EVM Defaults** on how to issue a device reset and also program the AFE4404 registers to the EVM default register settings.)
- Reset to EVM Defaults button that resets the device and sets up the board to the EVM default register settings.
- 4. Enables the user to set or reset:
  - (a) Powerdown AFE
  - (b) Powerdown RX
  - (c) Four controls for dynamic powerdown
  - (d) Enable CLKOUT Generation
  - (e) Clock Mode
  - (f) Clock divider ratio for external CLK, PRF, and CLK output
- 5. Enables the user to control the clock divider ratio settings. When the user enters an input clock, the GUI will automatically choose a divide by value so that the output clock is within 4–6 MHz

# 4.1.1.2 Tx Stage Subtab




Figure 31. AFE4404: Device Configuration: Tx Stage

Figure 31 shows the Tx Stage subtab under the Device Configuration tab consisting of the settings to:

1. Set LED1, LED2, and LED3 currents in mA or current settings in codes (6-bit)

# 4.1.1.3 Rx Stage Subtab




Figure 32. AFE4404: Device Configuration: Rx Stage

Figure 32 shows the Rx Stage subtab under the Device Configuration tab consisting of the settings to:

- 1. Enable separate gain mode
- Set feedback resistance and capacitance for the trans-impedance amplifier with separate gain mode disabled
- 3. Set feedback resistance and capacitance for the trans-impedance amplifier with separate gain mode enabled
- 4. Set ambient DAC current and polarity for LED2, LED3 (LED2 Ambient for dual LED), LED1 Ambient, and LED1.

# 4.1.1.4 Timing Controls Subtab




Figure 33. AFE4404: Device Configuration: Timing Controls

The *Timing Controls* subtab under the *Device Configuration* tab, shown in Figure 33, consists of the following settings:

- 1. Enter the Pulse Repetition Frequency (PRF) to find the Pulse Repetition Count
- 2. Manually control timing settings for on time, sample time, conversion time, ADC reset time, and power down cycle time by changing the numbers on the left
- 3. Save the timing settings based on PRF and duty cycle to a configuration file
- 4. Load the timing settings based on PRF and duty cycle from a configuration file
- 5. Load a preset configuration file from a list of options in the drop-down menu
- 6. Timer Enable selector
- 7. Timer Counter RESET button
- 8. Set Number of Averages

# 4.1.1.5 Low Level Configuration Subtab

The Low Level Configuration subtab under the Device Configuration tab is used to directly configure the various registers of the AFE4404 devices. Refer to the AFE4404 data sheet (SBAS689) for the register details of the chip.




Figure 34. Device Configuration: Low Level Configuration

Figure 34 shows the low-level configuration registers of the AFE4404 devices. The *Register Map* portion of the sub-tab shows the EVM default values of the registers after the GUI is loaded. From the *Register Map* section, when any register is selected, the bit-level details about the register are explained in the *Register Description* section. The ability to read and write the register and modify the individual bits of the register are changed by clicking on the desired bit. The values of all the registers are read by clicking the **Read All** button.

When a selection is made on any of the tabs on the GUI, multiple fields of various registers are modified. Click on the lower-left corner of the GUI to view the registers that are modified when a selection is made.

# 4.1.2 ADC Capture and Analysis

The ADC Capture and Analysis tab consists of various analysis routines and displays. This tab is used to:

- · Set the capture mode to finite or continuous
- · Set the number of samples (block size) in Finite Capture mode
- · Set the display to volts or codes
- Set the filter type to None or Notch
- Set the Notch Freq to 50 or 60 Hz when the filter type is set to Notch
- Set Analysis Type to All Domain or Time Domain only
- · Auto save after capture selector
- Acquire the data by clicking the Capture button
- When the user selects the auto save after capture selector under the ADC Capture & Analysis tab, the GUI uses the settings selected under Analysis to Save, Channels to Save, Data to Save, and Save File Settings. A Results saved successfully! notification is given after every capture.

The captured data can be analyzed in time domain and frequency domain; the data can also be displayed in a histogram format. The ADC Capture and Analysis tab is shown in Figure 35.




Figure 36. Scope Analysis: Test Results

By selecting the Time Domain plot, the data are displayed in time domain format. The units can be converted from codes to volts using the drop-down window in the top-left corner of the GUI. For the time domain plot, the mean voltage, root mean square (RMS) voltage, and peak-to-peak voltage are displayed in the *Test Results* section, which is a pop-up window that opens when the **Scope Analysis** button is clicked. The Scope Analysis: Test Results section pop-up window is shown in Figure 36.

By selecting the FFT plot, the data are displayed in the frequency domain by performing an FFT on the channel selected. Details of the FFT (including SNR, THD, and so on) are shown in the Test Results section located in the left side of the GUI.

Selecting the Histogram plot displays the data in a histogram format for the channel selected. The data are arranged in the total number of histogram bins set within the tab following acquisition. The histogram analysis (shown in the *Test Results* section of the GUI) is used to view the mean voltage, root mean square (RMS) voltage, and peak-to-peak voltage.

Four plot modes can be selected: Single Plot mode, Double Plot mode, Three Plot mode and Four Plot mode. In Single Plot mode, only one plot (Time, FFT, or Histogram) can be viewed and analyzed for post processing. In Double Plot mode, any two plots (Time, FFT, or Histogram) can be viewed and analyzed. In Three Plot mode, any three plots and in Four Plot mode, any four plots (Time, FFT, or Histogram) can be viewed and analyzed.

The following algorithms have been used to find the # of samples for FFT calculation:

- (a) # of samples for FFT calc. which is power of 2 ≤ min ( (Data rate (sps) x N where N is the value in the Show data for the last N secs column), No. of samples )
- (b) If ( (# of samples for FFT calc. == No. of samples) && (Filter Type == "None") ) then # of samples for FFT calc. = No. of samples
- (c) If ( (# of samples for FFT calc. == No. of samples) && (Filter Type == "Notch") ) then # of samples for FFT calc. = No. of samples / 2. This is to allow for filter settling.
- (d) If (# of samples for FFT calc. < 32 samples) then an error msg "Insufficient # of samples for FFT calculation" will be displayed.</p>

# **Examples:**

1. No. of samples = 3

Data rate (sps) = 500

Show data for the last 5 secs

Then # of samples for FFT calc. which is power of  $2 = 2048 \le \min((500 \times 5), 8192)$

### 4.1.3 Save Tab




Figure 37. Save Tab

The Save tab shown in Figure 37 provides provisions to save the analysis or data to a file. By default, the data are saved to the following location:

- On a Windows XP machine C:\Program Files\Texas Instruments\AFE4404 EVM GUI\Log
- On a Windows 7 machine C:\Program Files(x86)\Texas Instruments\AFE4404 EVM GUI\Log

Use the *Directory to Save Files* option to select the folder where data are to be saved. In the pop-up window, navigate to the folder where the data file is to be saved and select *Use Current Folder*. Then select *Save to File* to save the file.

When the user selects the auto save after capture selector under the *ADC Capture & Analysis* tab, the GUI uses the settings selected under *Analysis to Save, Channels to Save, Data to Save,* and *Save File Settings.* A *Results saved successfully!* notification is given after every capture.

#### 5 AFE4404 EVM Hardware

#### **CAUTION**

Many of the components on the AFE4404 EVM are susceptible to damage by electrostatic discharge (ESD). Customers are advised to observe proper ESD handling precautions when unpacking and handling the EVM, including the use of a grounded wrist strap, bootstraps, or mats at an approved ESD workstation. Safety glasses should also be worn.

The key features of the AFE4404 Analog Front End demonstration board are:

- Based on MSP430F5529
- Acquire data at up to 1000 Hz in evaluation mode
- I2C Data interface

The AFE4404 EVM board can be used as a demo board for pulse oximeter and heart rate applications. The bill of materials (BOM) is provided in Section 10. The printed-circuit boards (PCB) are shown in Section 11.1, Section 11.2, and the schematics are shown in Section 11.3.

MSP430F5529 is the microcontroller used on the board. For more details of the MSP430F5529 visit <a href="http://focus.ti.com/docs/prod/folders/print/msp430f5529.html">http://focus.ti.com/docs/prod/folders/print/msp430f5529.html</a>.




Figure 38. AFE4404 EVM Block Diagram

The following sections explain the main hardware components available on the EVM. Figure 38 shows the functional block diagram for the EVM.

## 5.1 Power Supply

AFE4404 can operate from 2.0-V to 3.6-V Rx analog supply (RX\_SUP), 1.8-V to 3.6-V IO digital supply (IO\_SUP), and 3.0-V to 5.25-V Tx Control supply (TX\_SUP).

The power for the board is derived from the USB input (J1) through a forward-biased diode (D1) to avoid reverse current flow. The USB data bus is ESD protected using Tl's ESD protection diode array TPD4E004DRYR (U5). The USB VBUS is fed to the integrated Li-Ion linear charger and system power-path management module, bq24032ARHLR (U3), which generates greater than 4.2-V output (VCC\_BAT). This output is fed to Tl's low-input boost converter with integrated power diode and input/output isolation, TPS61093 (U7), for generating a boosted voltage of 8.97 V. This output is fed to low-noise voltage regulator LP3878-ADJ (U9) for generating 5 V for TX\_SUP. The VCC\_BAT is also fed to the ultralow-noise linear voltage regulator TPS7A4901DGN (U6) for generating 3 V for the MSP\_DVCC, MSP\_AVCC, RX\_SUP and IO\_SUP.

Series jumper resistors are provided to make sure the power supplies to the board are correct.

#### 5.2 Clock

The EVM has the option to use the internal clocking using the on-chip 4-MHz oscillator (EVM default) or the clock for the AFE4404 from the MSP430 (Device default). In oscillator mode, the internally generated clock from the AFE4404 can be accessed through an accessible via labeled CLKOUT. The frequency of the output clock can be set using a programmable divider.

#### 5.4 USB Interface

The EVM has a micro-USB interface for PC application connectivity requiring a standard micro-USB to USB cable for connection. The AFE4404 EVM is designed to work in the slave mode.

## 5.5 On-Board Key Interface

The EVM has 2 switches. The function of each switch is defined in Table 3.

Table 3. AFE4404 EVM Switches

Switch Number	Description
SW1	This switch is used for hard reset of the board. The board resets and starts again with the firmware loaded.
SW2	This switch is used to enable boot strap loader (BSL) MSP430 firmware. (1)

<sup>(1)</sup> To enable BSL, disconnect device and then reconnect while holding down SW2. The device will appear as an HID device in the device manager.

#### 5.6 Visual Indication

The blue LED (LED1) indicates the USB power connection. The blue LED (LED3) indicates that the microcontroller is busy servicing the requests from the PC application.

## 6 USB-Based Firmware Upgrade

The firmware on the AFE4404 EVM can be changed from the PC application by selecting the *Firmware Upgrade* menu option on the PC application. At the end of the firmware upgrade, the system issues a reset command and reloads with new firmware. The firmware upgrade process steps are represented in the following screen shots:

- From the PC application, click on File →Firmware Upgrade




Figure 39. PC Application Firmware Upgrade - 1

- A pop-up window opens as shown in Figure 39. Follow the instructions to continue to Firmware Upgrade or to cancel the operation.




Figure 40. PC Application Firmware Upgrade - 2




Figure 41. PC Application Firmware Upgrade - 3




Figure 42. PC Application Firmware Upgrade – 4

Use the following steps to upgrade the AFE4404 EVM firmware without the GUI:

- Open the firmware loader application by clicking the BSL\_USB\_GUI.exe located at the following location:
  - On a Windows 7 or Windows 8 operating system (OS): "C:\Program Files(x86)\Texas Instruments\AFE4404 EVM GUI\Firmware Updater"
  - On a Windows XP OS: "C:\Program Files\Texas Instruments\AFE4404 EVM GUI\Firmware Updater"




Figure 43. Firmware Loader Application: Select Firmware

- 2. Click the **Browse** button and load the AFE4404 firmware. Figure 43 shows the firmware loader application with the appropriate firmware selected. The firmware is located in the "C:\Program Files\Texas Instruments\AFE4404 EVM GUI\Firmware Updater" directory.




Figure 44. Firmware Loader Application: Found Device




Figure 45. Firmware Loader Application: Programming Status




Figure 46. USB Micro Connector Pin Outs




Figure 47. 10-Pin Connector

## 9.1 ADC\_RDY Signal




Figure 48. ADC\_RDY Waveform at 100-Hz PRF




Figure 49. Setting Font Size on Windows 7 Operating System

## 9.4 Windows 8 Support for Device GUIs




Figure 50. Broken Arrow Error

At GUI Start up, sometimes the GUI might show a broken arrow as seen in Figure 50. One of the reasons for this issue may be due to a missing update of Microsoft .NET Framework 3.5 (includes .NET 2.0 and .NET 3.0).

The .NET Framework 3.5 is needed for the GUI to:

- Check if Python is Installed
- Checking and setting environment variables needed for the scripting feature in the GUI

#### Points to Remember:

- There is no download for the .NET Framework 3.5 for Windows 8 or Windows 8.1. The user must enable the .NET Framework 3.5 in Control Panel by following the instructions provided in this article.
- Use the .NET Framework 3.5 for apps built for versions 2.0 and 3.0 as well as 3.5.
- Installing a Windows language pack before installing the .NET Framework 3.5 will cause the .NET Framework 3.5 installation to fail. Install the .NET Framework 3.5 before installing any Windows language packs. (Source: <a href="http://msdn.microsoft.com/library/hh506443">http://msdn.microsoft.com/library/hh506443</a>(v=VS.110).aspx).

There are two methods to resolve this.

## 9.4.1 Method 1 (Enabling the .NET Framework 3.5 in Control Panel)

In Control Panel, choose Programs and Features, choose Turn Windows features on or off, and then select the .NET Framework 3.5 (includes .NET 2.0 and 3.0) check box. This option requires an internet connection. The user does not need to select the child items.




Figure 51. Method 1 (Screen 1)




Figure 52. Method 1 (Screen 2)




Figure 53. Method 1 (Screen 3)




Figure 54. Method 1 (Screen 4)




Figure 55. Method 1 (Screen 5)




Figure 56. Method 1 (Screen 6)

## 9.4.2 Method 2 (Enabling .NET Framework 3.5 on Windows 8 in Offline Mode)




Figure 57. Method 2 (Screen 1)




Figure 58. Method 2 (Screen 2)




Figure 59. Method 2 (Screen 3)




Figure 60. Method 2 (Screen 4)

## 9.5 COM Port

It has been observed that on certain machines, the GUI will not work for lower COM ports. When the GUI and the USB drivers are installed correctly and the Device Manager shows the AFE44x0SPO2EVM recognized as a virtual COM port, but the GUI cannot establish communication to the AFE44x0SPO2EVM and shows the Device Communication Error, change the COM port to a higher number (greater than 25).




Figure 61. AFE4404 EVM Top Overlay




Figure 62. Top Solder






Figure 63. Top Copper (Layer 1)




Figure 64. Bottom Copper (Layer 4)






Figure 65. Bottom Solder




Figure 66. Bottom Overlay




Figure 67. Sensor Board Top Silk Screen




Figure 68. Sensor Board Top Solder Mask




Figure 69. Sensor Board Top Copper




Figure 70. Sensor Board Bottom Copper






Figure 71. Sensor Board Bottom Solder Mask




Figure 73. AFE4404 EVM Schematics (1 of 4)




Figure 74. AFE4404 EVM Schematics (2 of 4)







Figure 75. AFE4404 EVM Schematics (3 of 4)




Figure 76. AFE4404 EVM Schematics (4 of 4)




Figure 77. Sensor Board Schematic
