


## Introduction

The LM26EVM allows users to evaluate the performance of the LM26 factory present temperature switch and temperature sensor. The EVM comes with an unpopulated LM26 landing pad. Samples to populate the landing pad can be ordered from the <u>Texas Instruments website</u>. The EVM board features a test point header for easy probing of the LM26 pins and a hysteresis select header to change the hysteresis setting.

- J2.P1-P2: Jumper header to select hysteresis setting


## Operation


- 1. Connect a power supply to the VDD and GND pins labeled on the test point header J1.

- 3. Measure VTEMP, SHDN, or HYST on J1.




