## 1 Description

The LM34936EVM features a four switch buck-boost converter based on TI's LM34936 wide  $V_{\rm IN}$  buck-boost controller. This converter is designed to operate from input voltage from 6 V to 24 V (42-V transient) and provide a 12 V regulated output with a load current of up to 6 A. The board specifications are listed in Table 1.




Figure 1. LM34936Evaluation Board

## 2 Setup

This section describes input and output connectors on the EVM and the step-by-step procedure for setting up and using the LM34936 Evaluation Board.

## 2.1 Input/Output Connector Description

REF	NAME	DESCRIPTION	
TP1	VIN	VIN sense terminal	
TP2	VOUT	VOUT sense terminal	
J1	VIN	Positive input power terminal for the EVM	
J2	VOUT	Positive output from the converter	
TP3	GND	Input ground sense terminal	
TP4	GND	Output ground sense terminal	
J3	GND	Return input power terminal for the EVM	
J4	GND	Ground or return terminal for the output	
J5	ENABLE	3 terminal ENABLE selections. Short pin 1 and 2 to disable the DC/DC converter. Removing the short allows the converter to start up depending on the EN pin voltage.	
J6-6	GND	Unpopulated	

## 2.2 Test Points

J6-2	VCC	Internal VCC regulator output	
J6-3	MODE	MODE pin voltage. See LM34936 data sheet for details on this pin	
J6-5	PGOOD	Power good indicator. There is a 10-kΩ pullup to VCC on the board.	
J6-1	SYNC	External frequency synchronization input terminal (SYNC). This is connected to the RT/SYNC pin of the LM5175 controller IC through a 100-pF capacitor on the board.	
J6-4	COMP	Output of the LM5175 GM error amplifier.

## 2.3 Test Bench Setup




Figure 2. Test Bench Setup


A typical LM34936 test bench setup is shown in Figure 2. The power supply and the load should be capable of handling the input and output voltage and current rating of the board. Follow these steps to get started with the LM34936EVM.

- 1. Connect the power and ground connectors VIN (J1) and GND (J3) to the power supply.
- 2. Connect an ammeter in series with the input if needed.
- 3. Connect a voltmeter across the input terminals (TP1, TP3).
- 4. Connect a resistive load or an electronic load across terminals VOUT (J2) and GND (J4).
- 5. An ammeter can be inserted in series with the load to observe the load current.
- 6. Connect a voltmeter across the output terminals (TP2, TP4) to observe the output voltage.
- 7. With the load initially set to no load, set the power supply between 6 V and 24 V and turn on the power supply. Check for 12 V at the output.
- 8. Once the output is at the expected target (12 V), increase the load gradually within the operating range.








Figure 12. LM34936EVM Schematic




Figure 13. Top Overlay




Figure 14. Top Layer




Figure 15. Top Solder




Figure 16. Mid Layer 2




Figure 17. Mid Layer 3




Figure 18. Bottom Layer




Figure 19. Bottom Solder




Figure 20. Bottom Overlay
