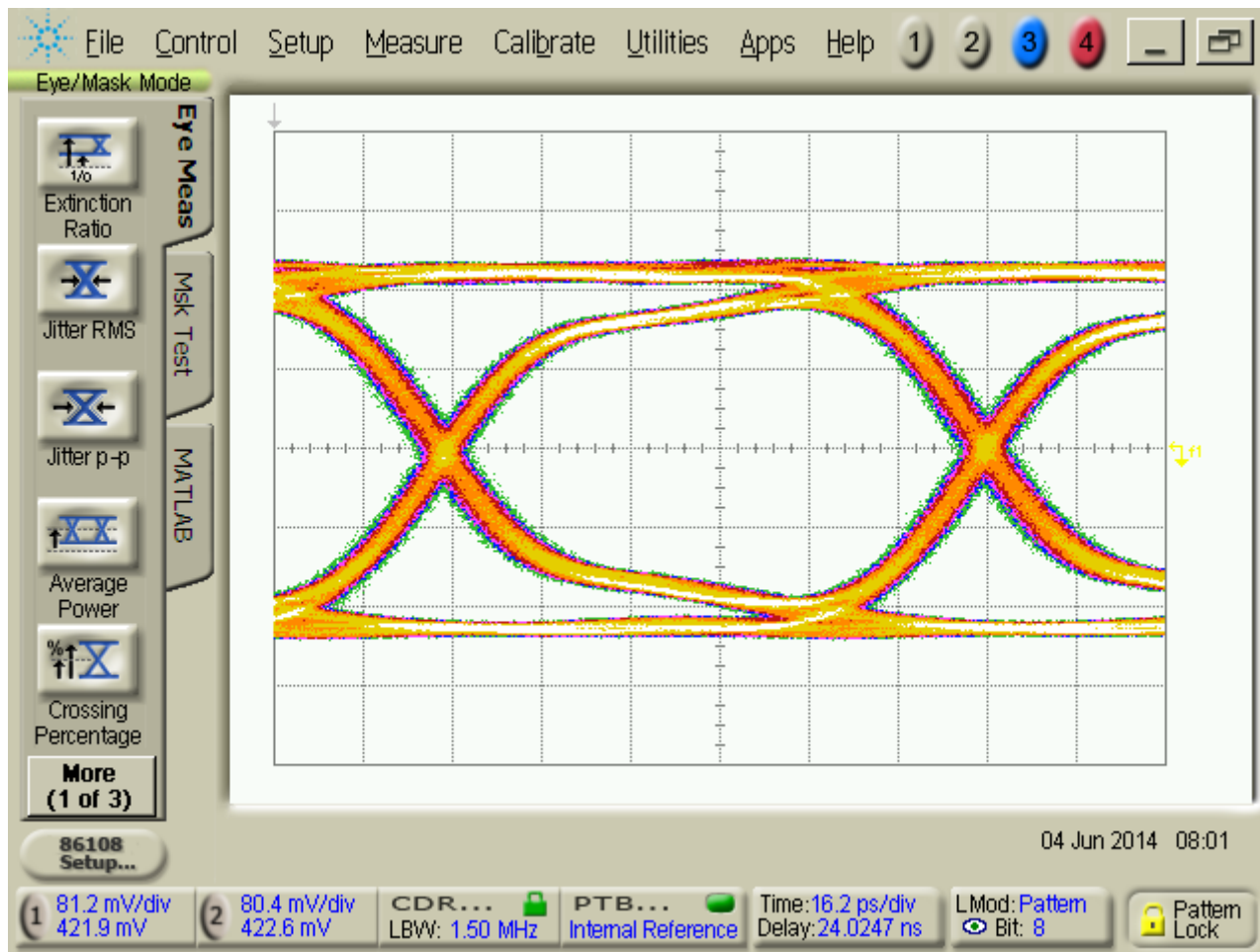

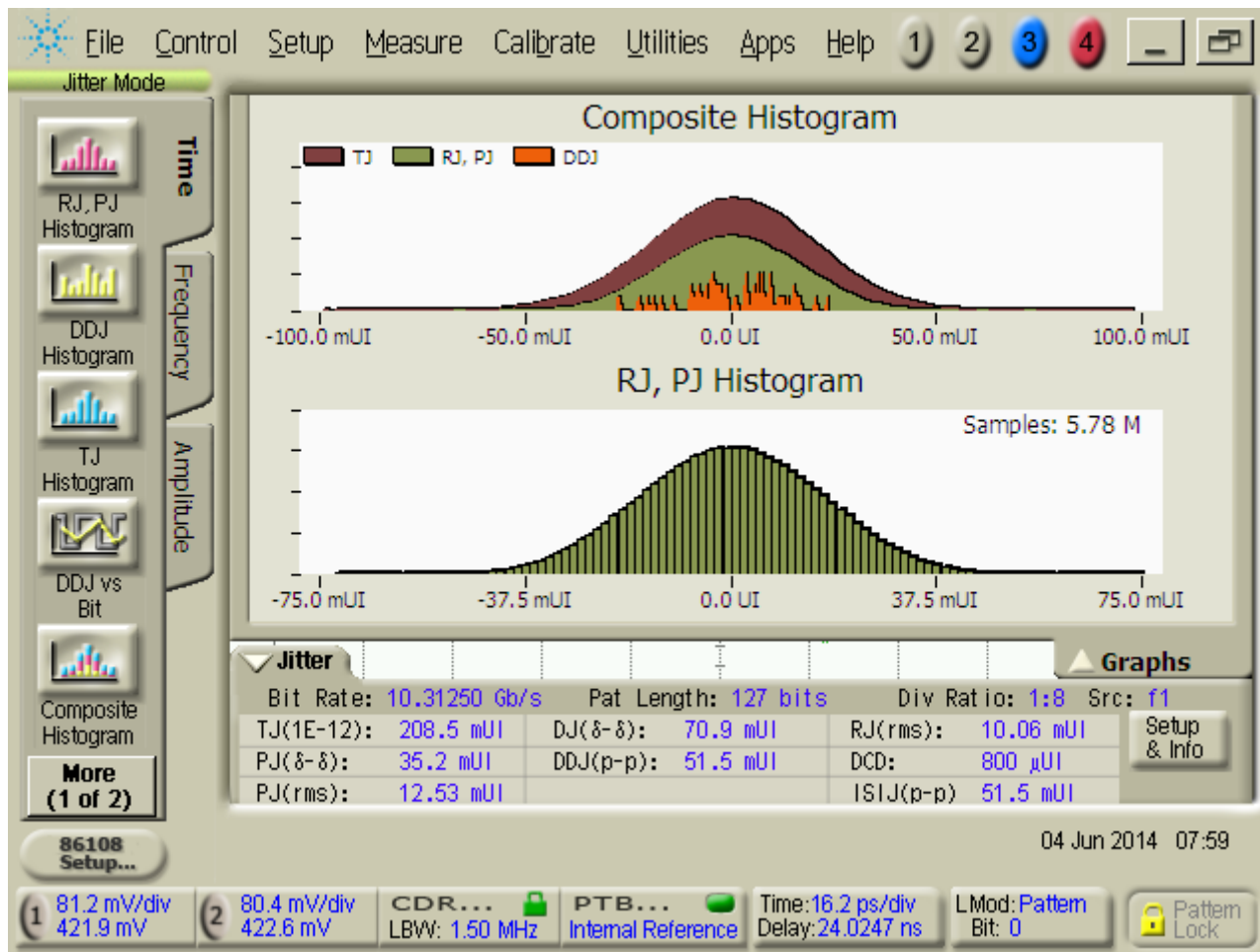

The table above shows testing that was done with different cables and board traces. Slides 7-19 show the channel losses for each of these conditions. The channel loss, when applied to the transmitter eye diagram shown on slide 4 is then received at the TLK10081 de-aggregator. BER Achieved : 3x10⁻¹² indicates that the TLK10081 receiver is able to recover a transmitter eye when passed through the wide range of loss profiles as shown in pages 7-19.

TLK10081 Transmitter Eye Diagram

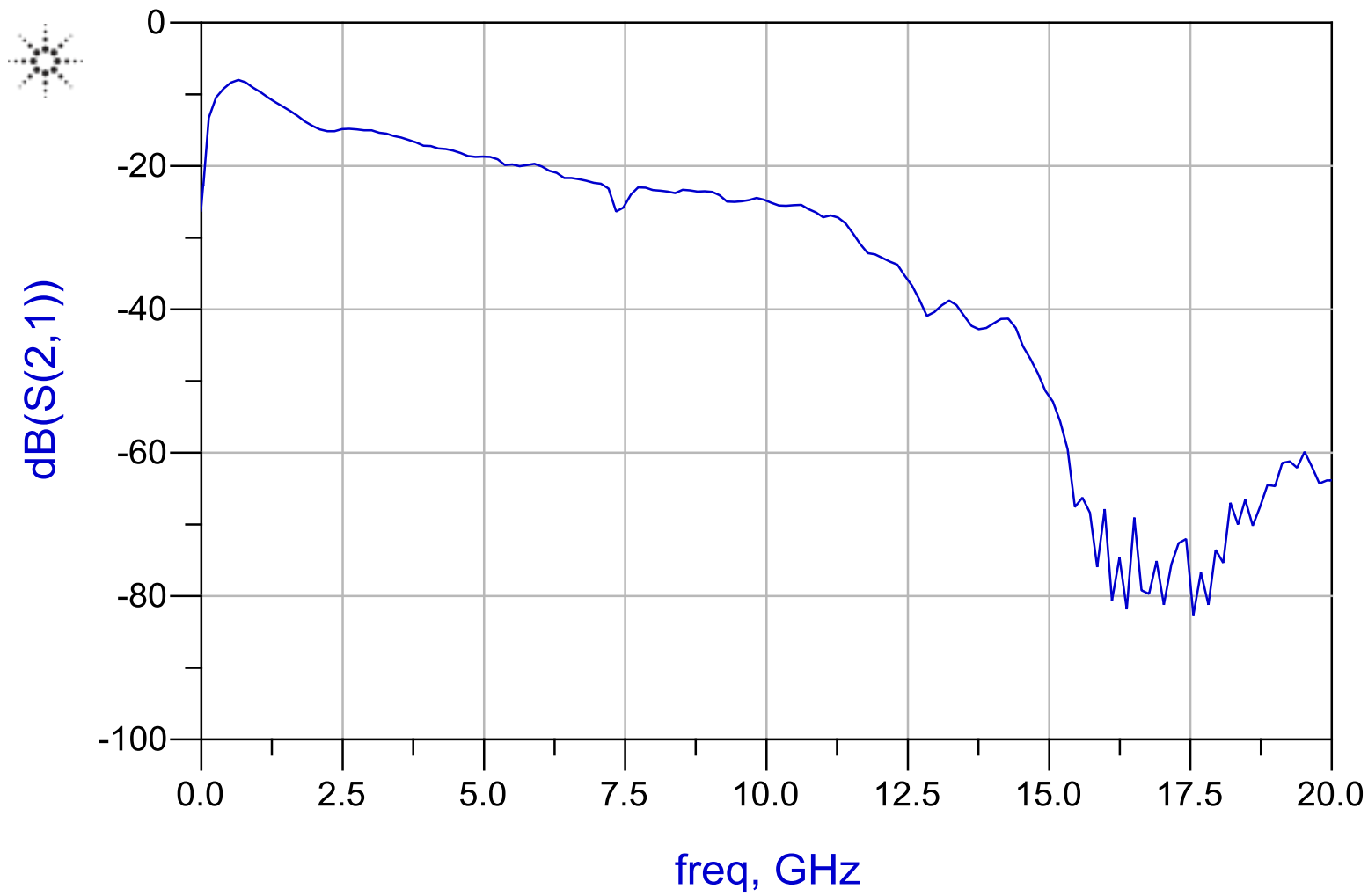


TLK10081 Transmitter Jitter Data

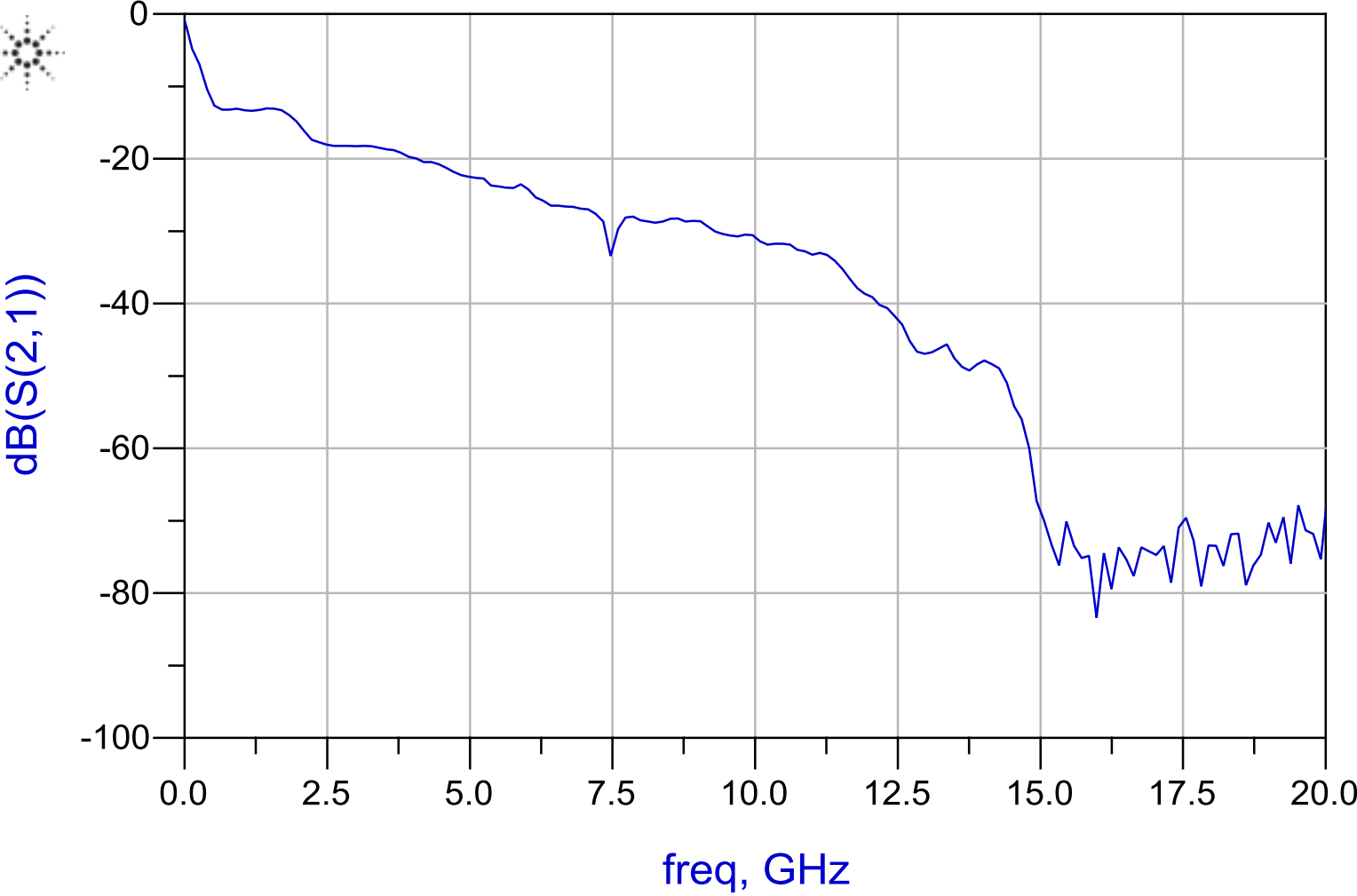

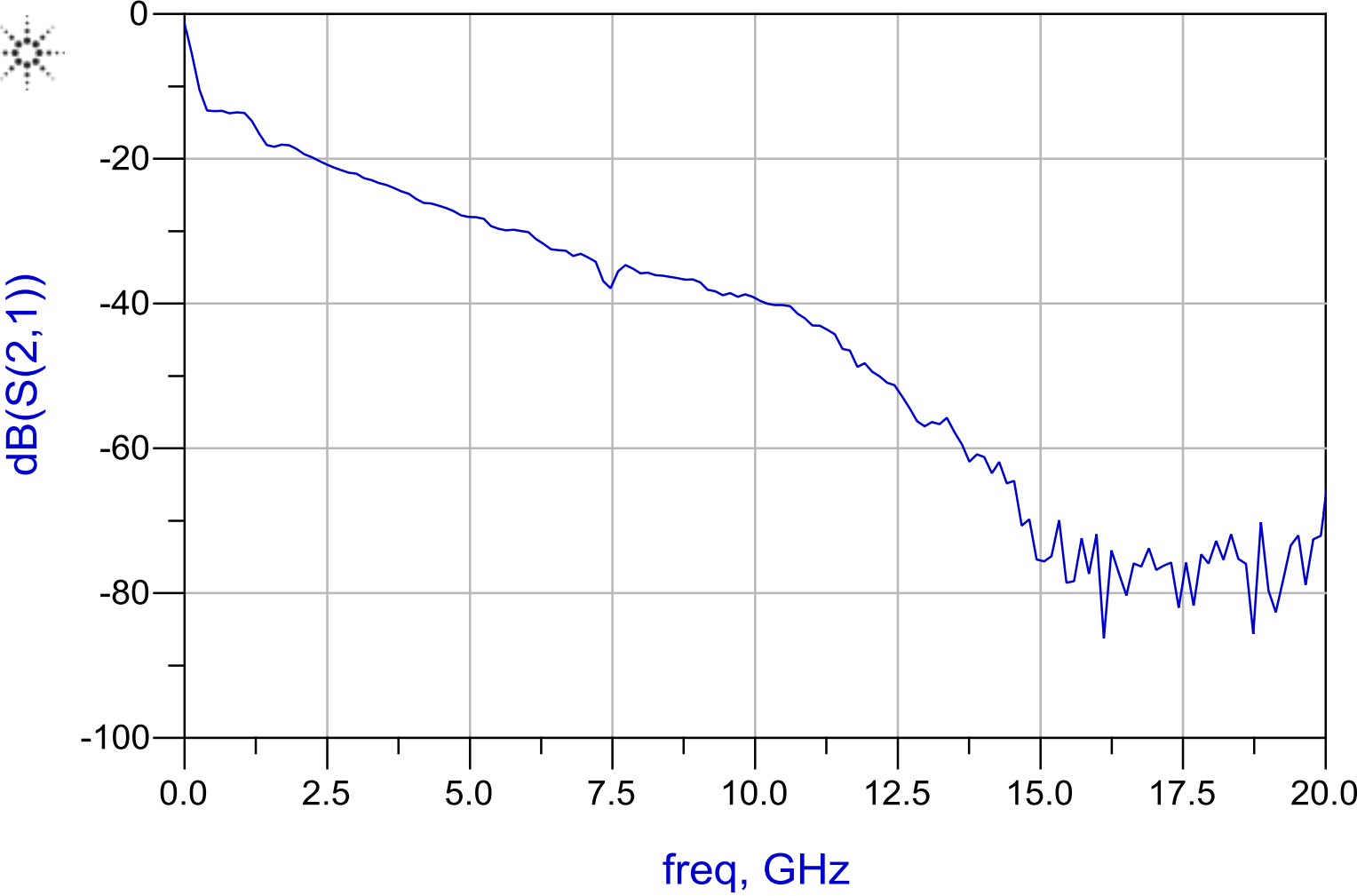
3 Meter DAC Cable



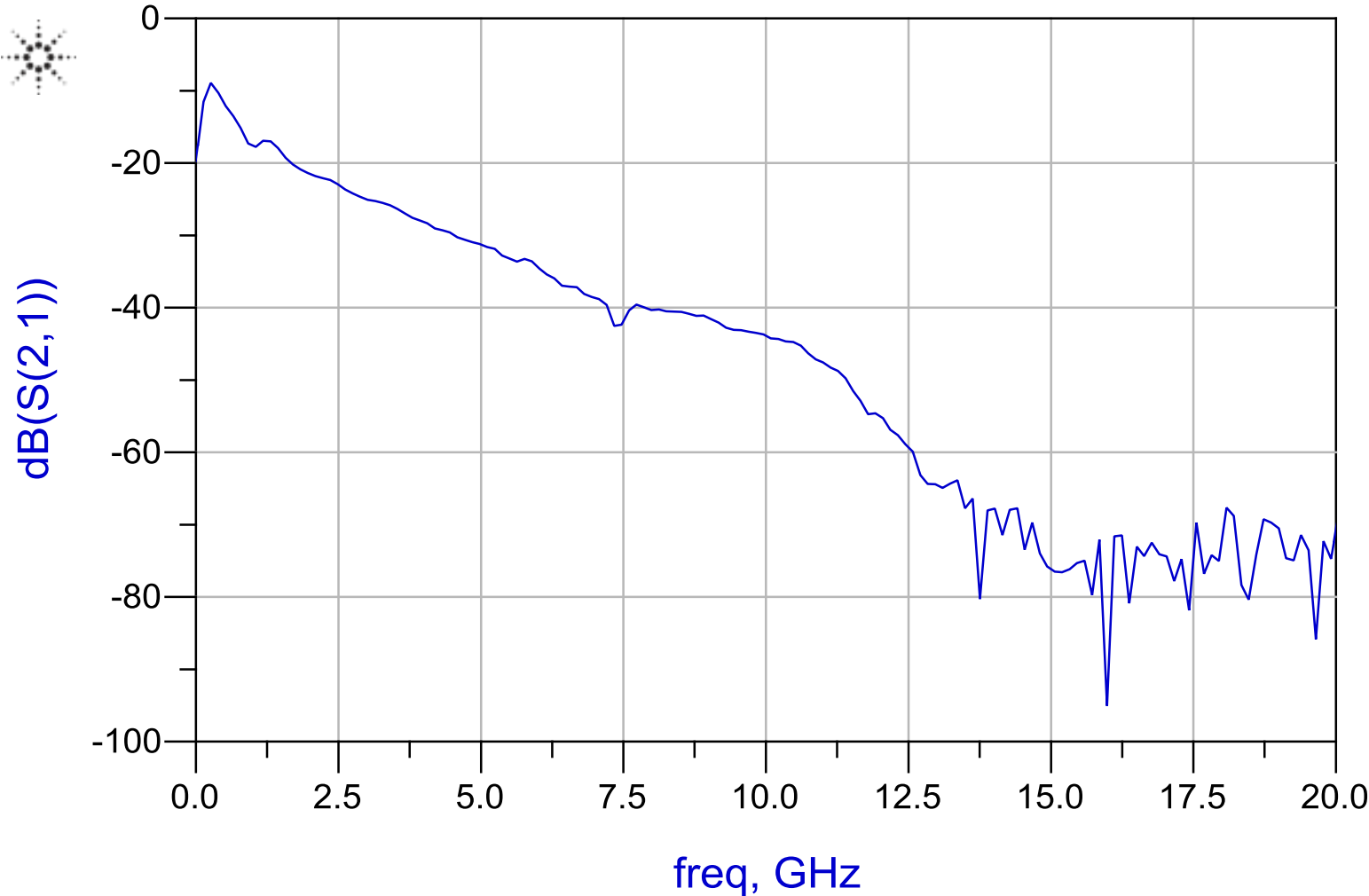
5 Meter DAC Cable



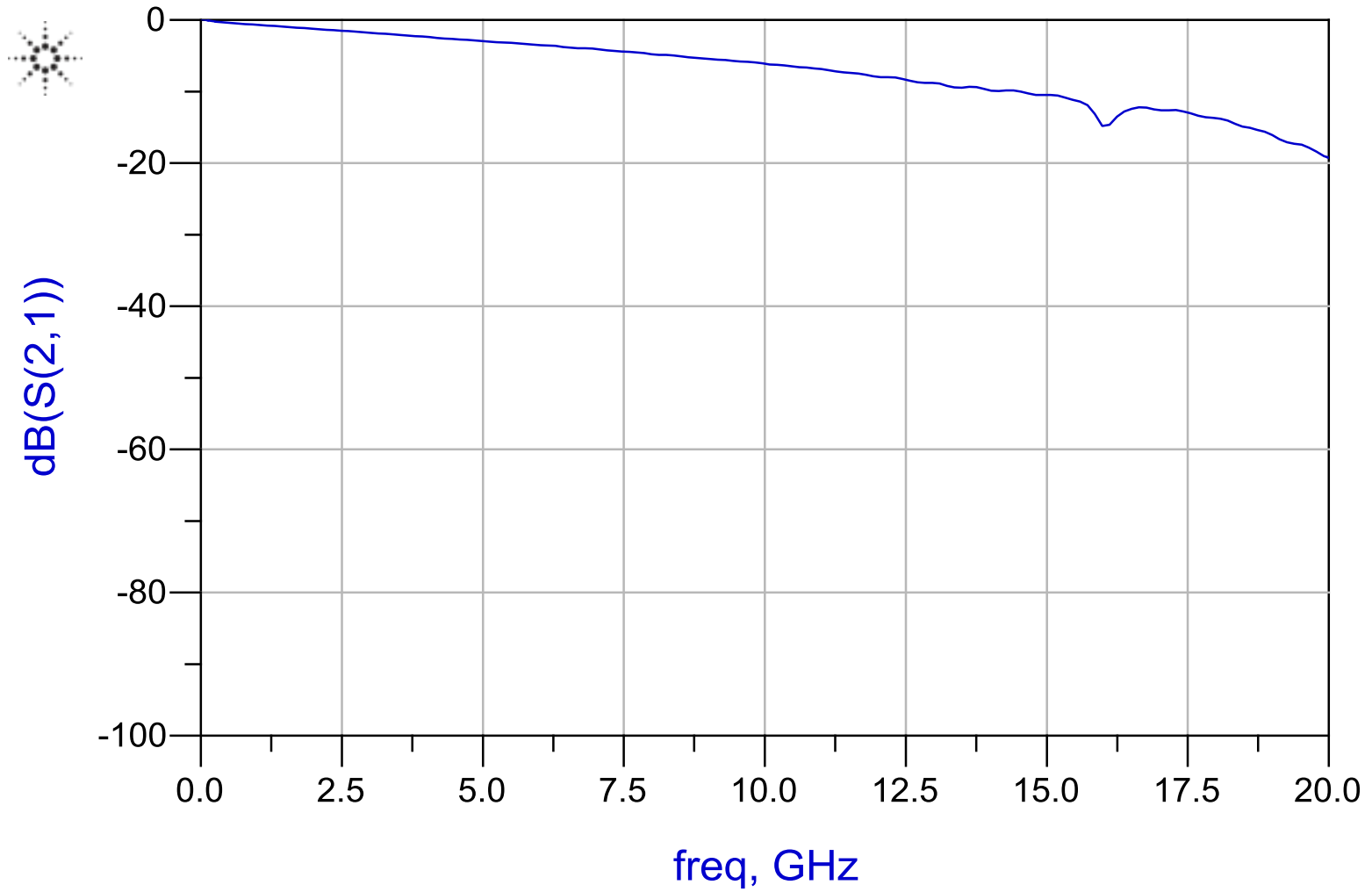
6 Meter DAC Cable



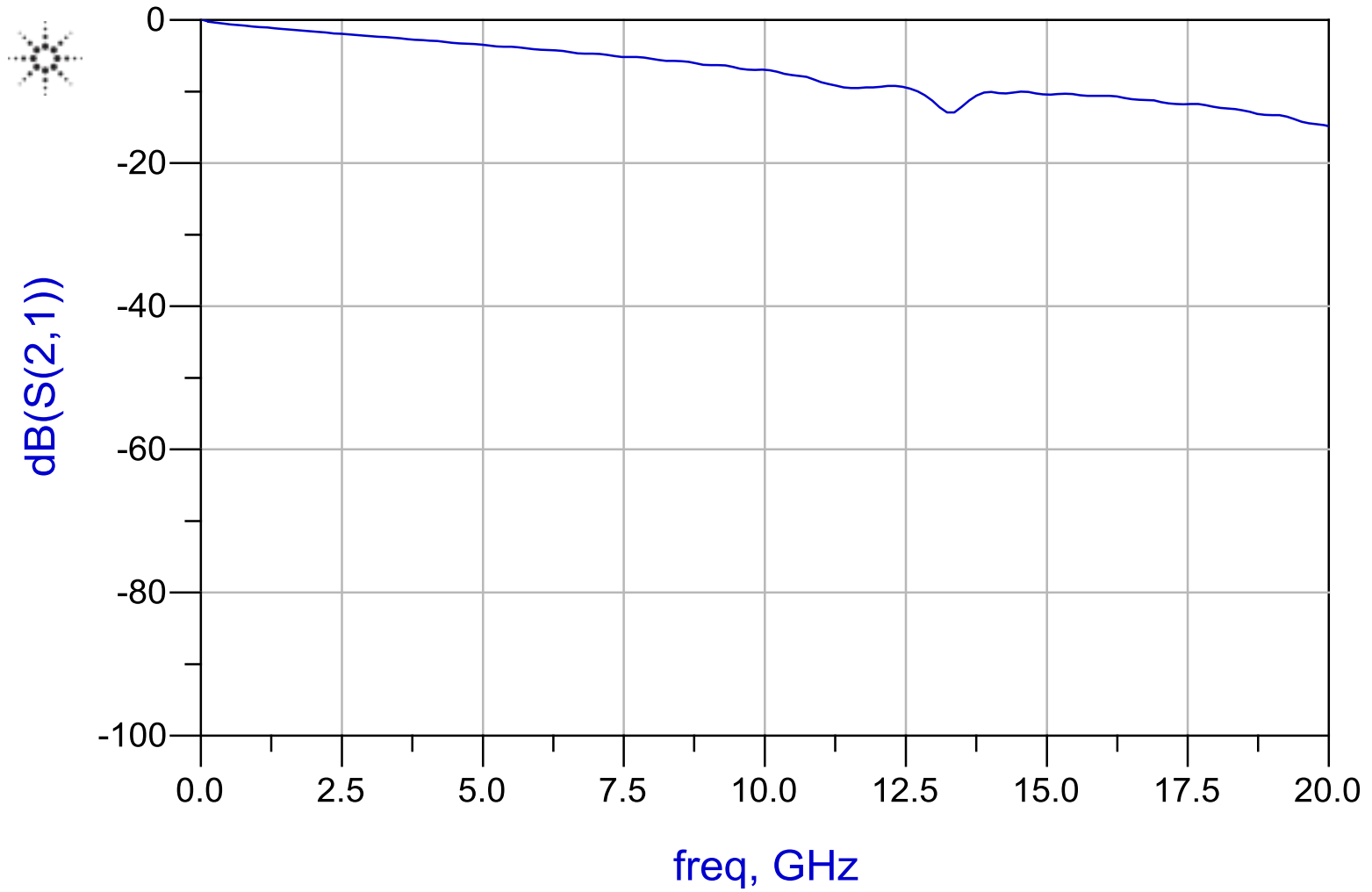

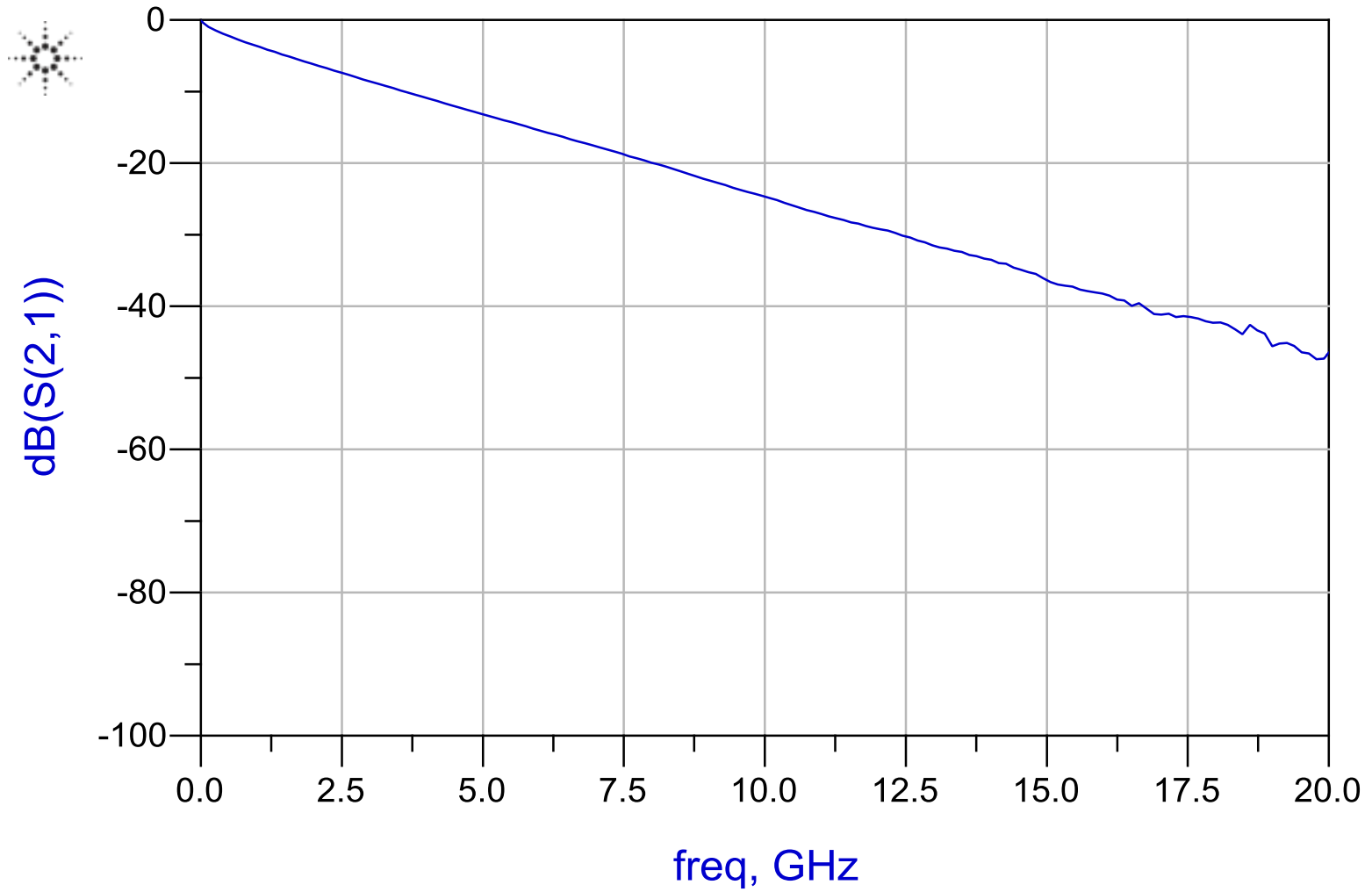

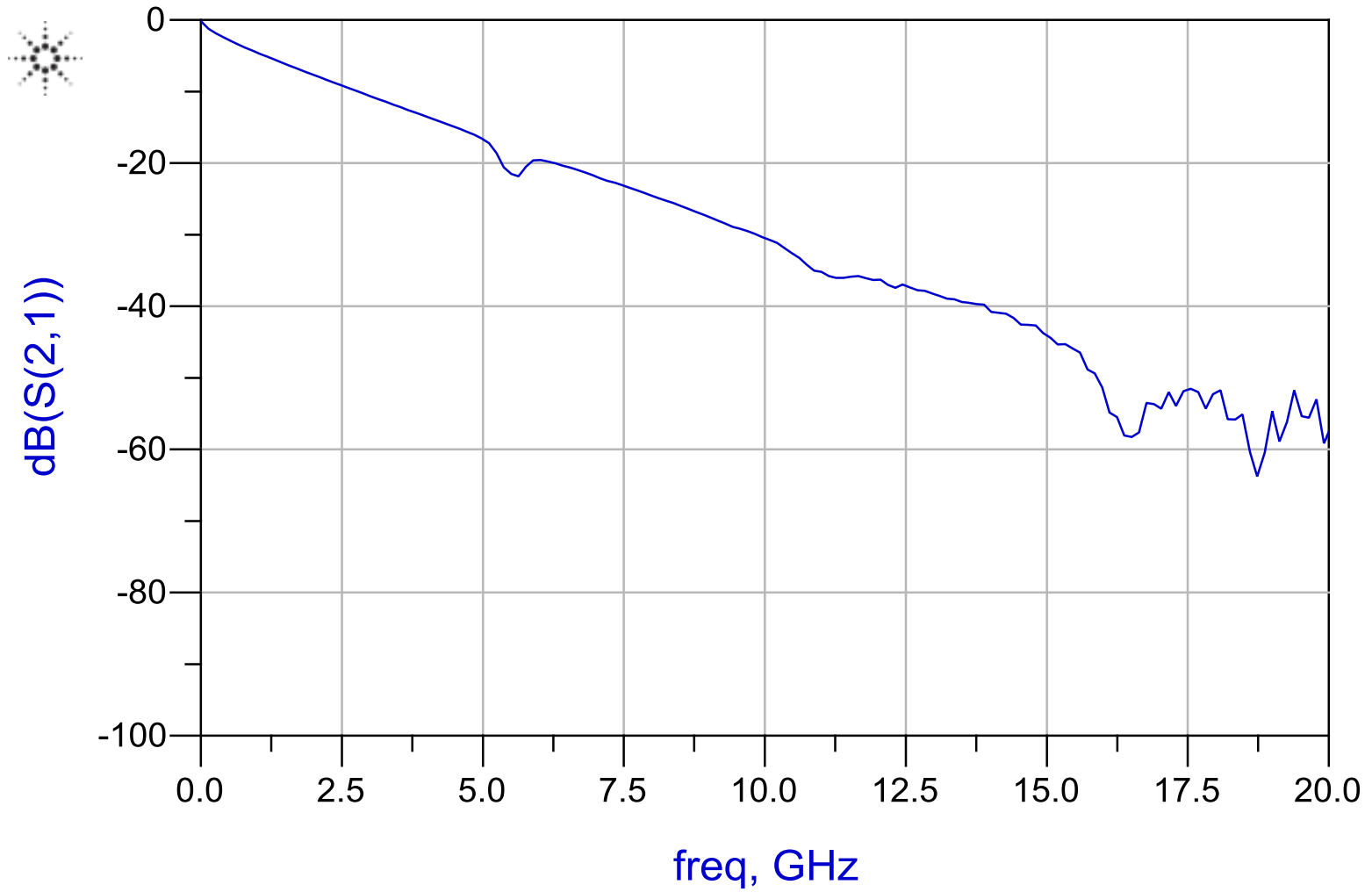

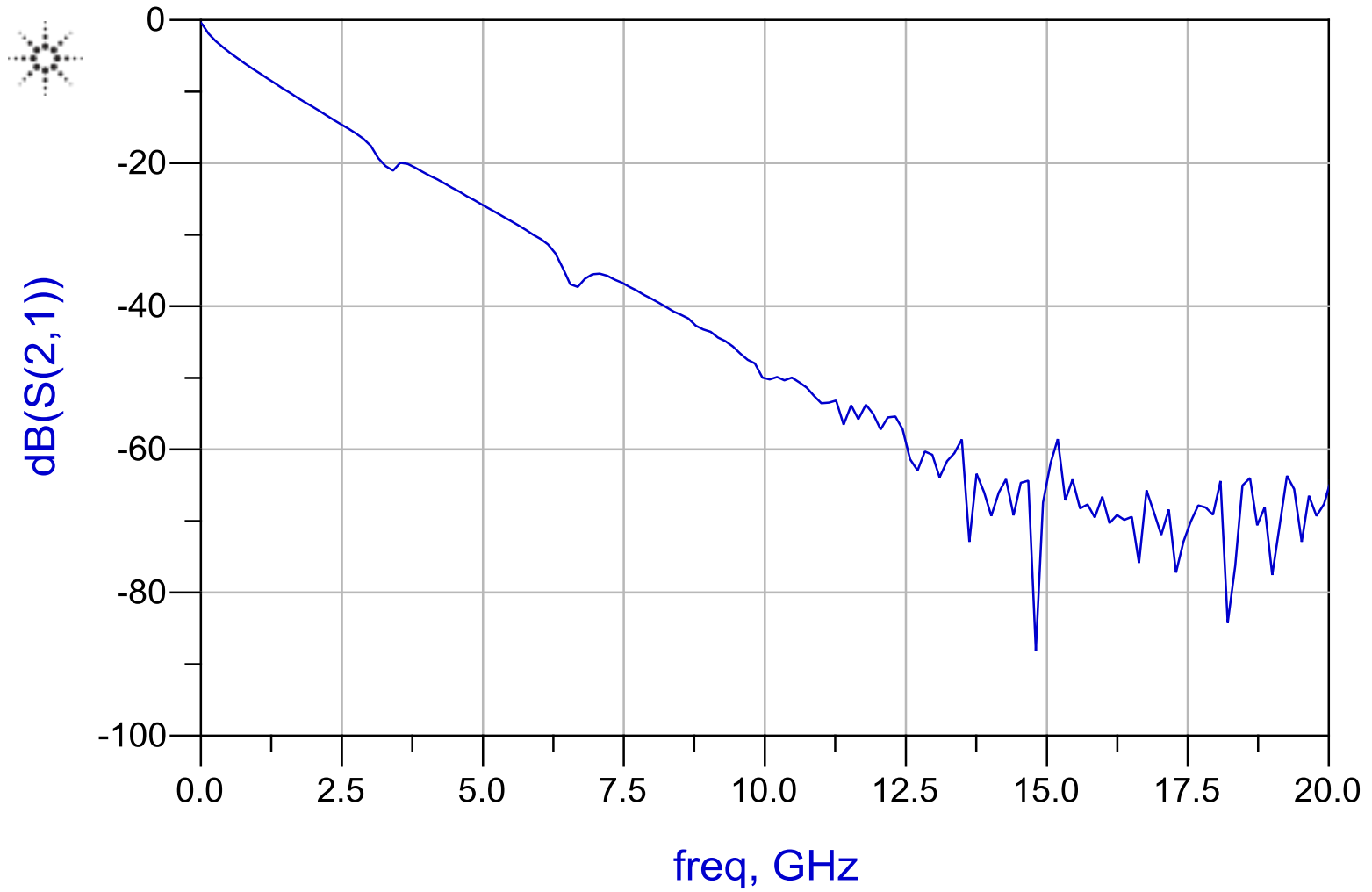

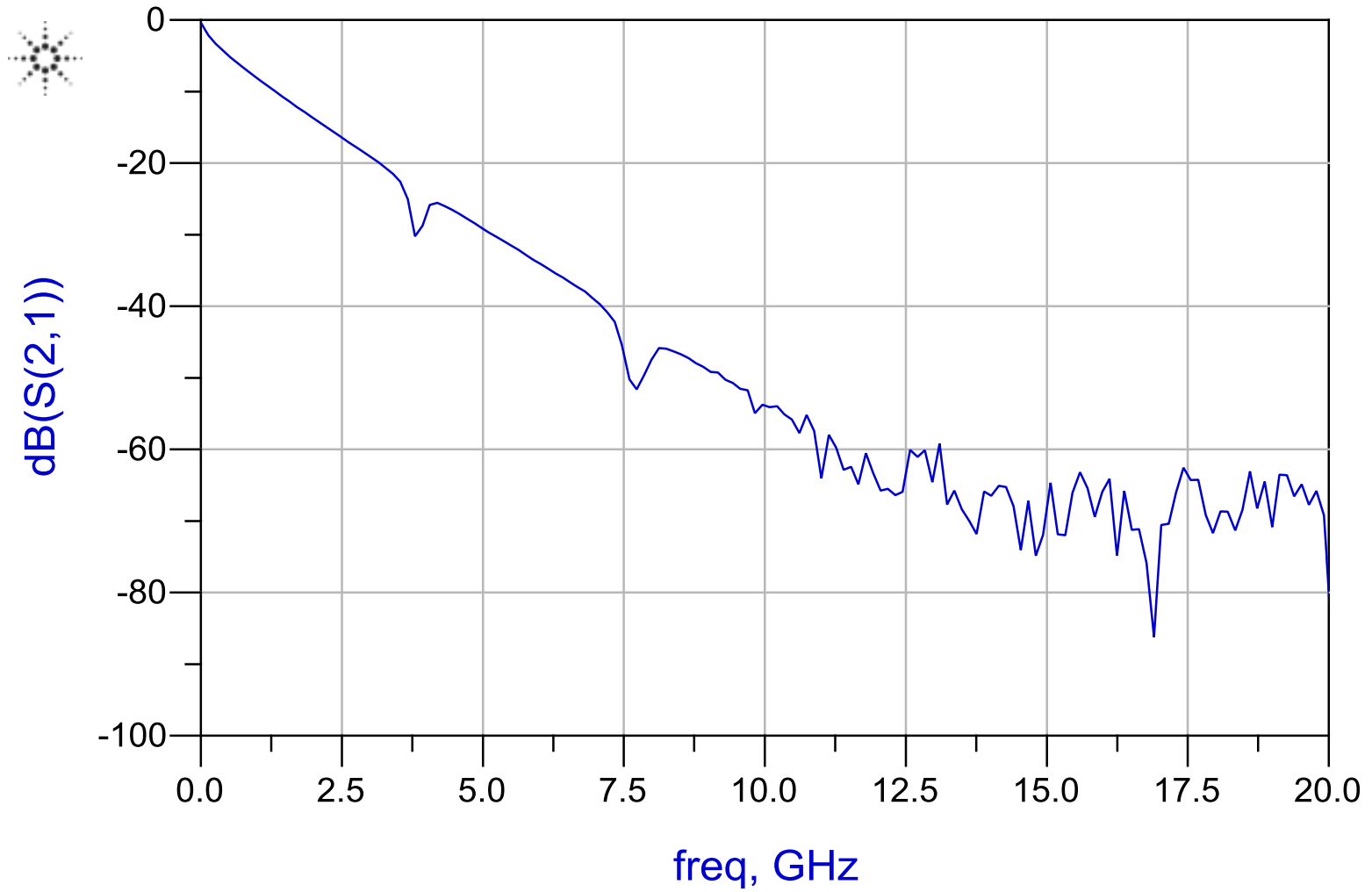
FR4 Test Trace Board 20 in | 4 mil



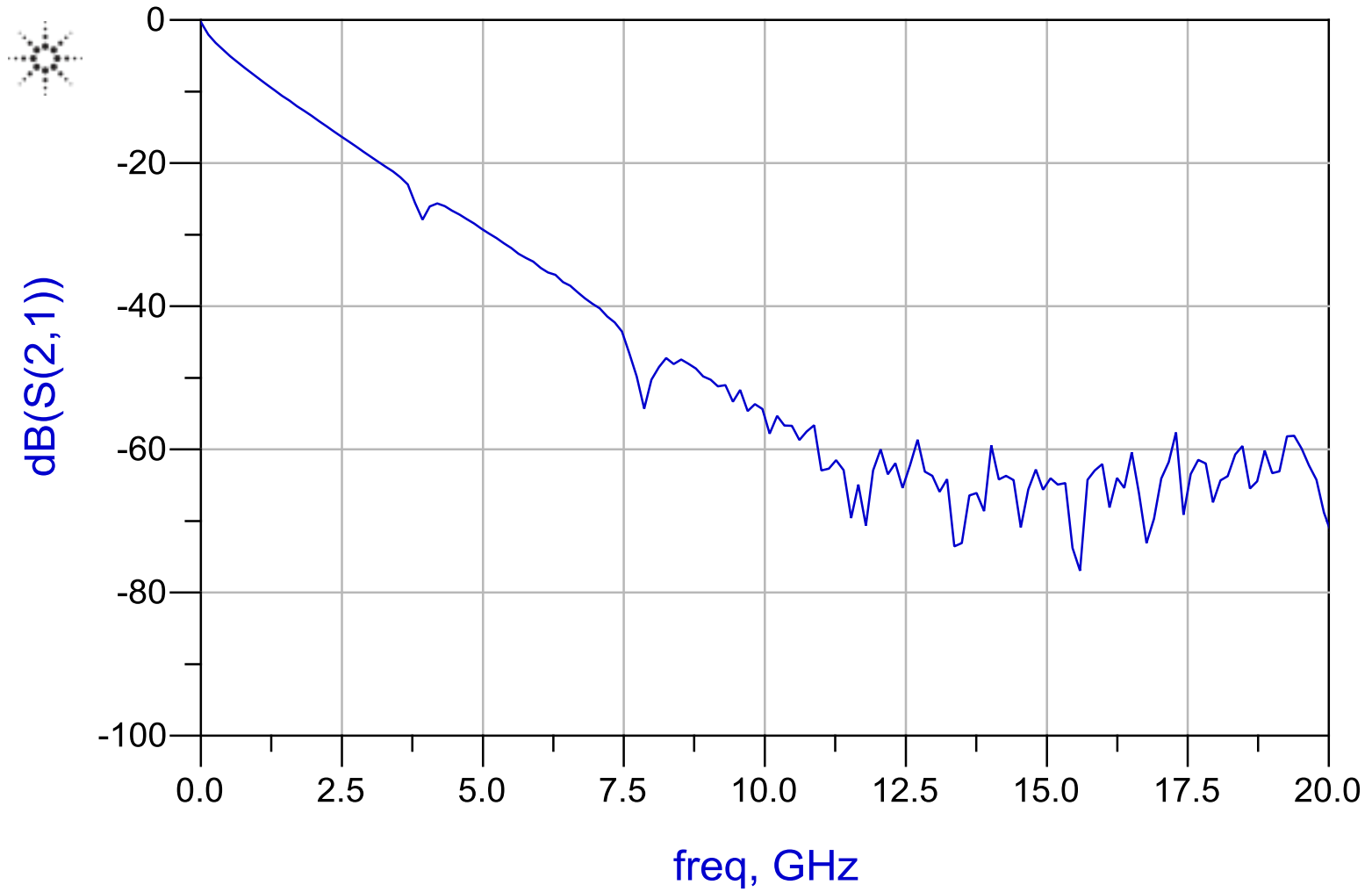

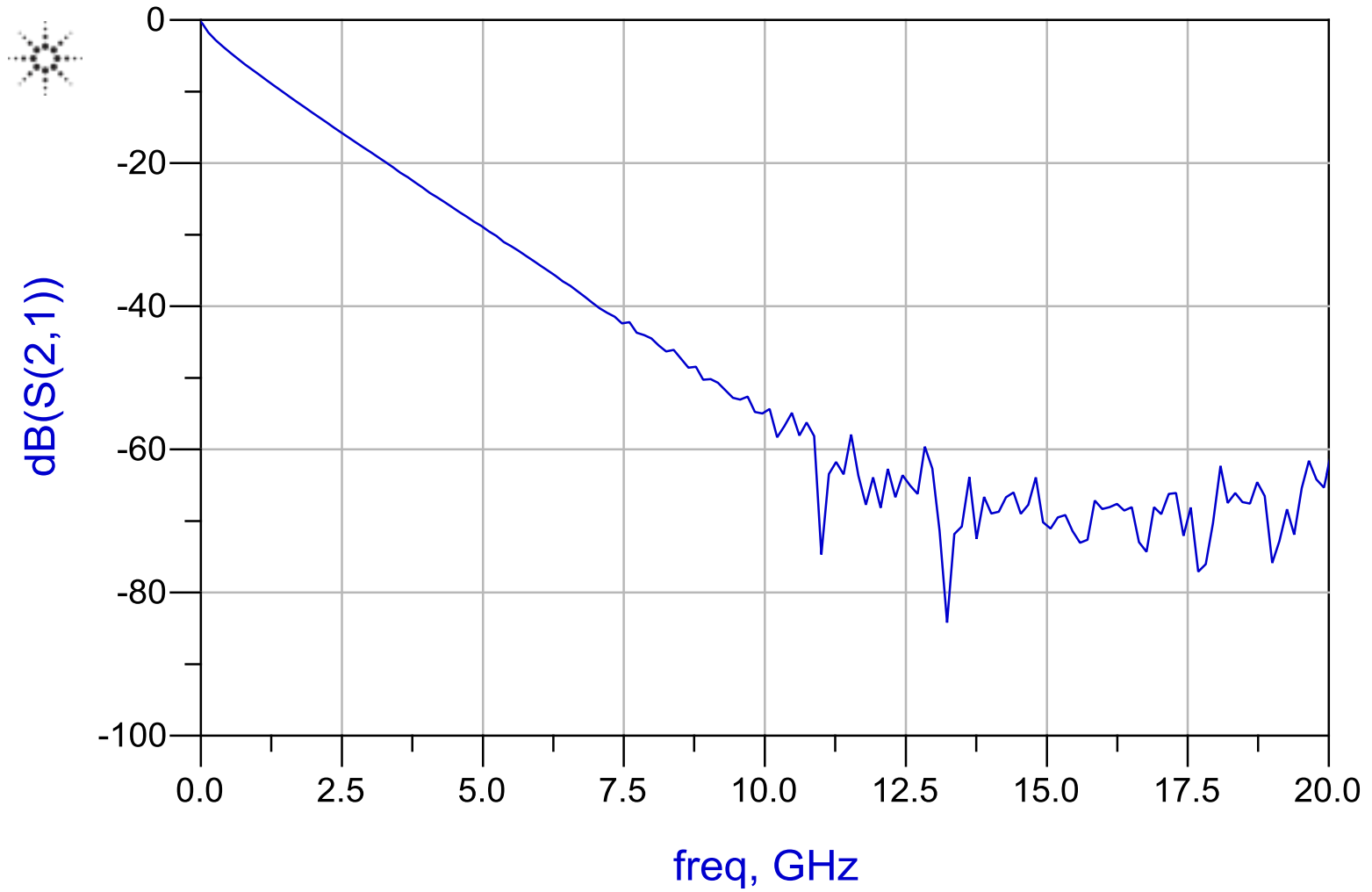
FR4 Test Trace Board 36 in | 4 mil



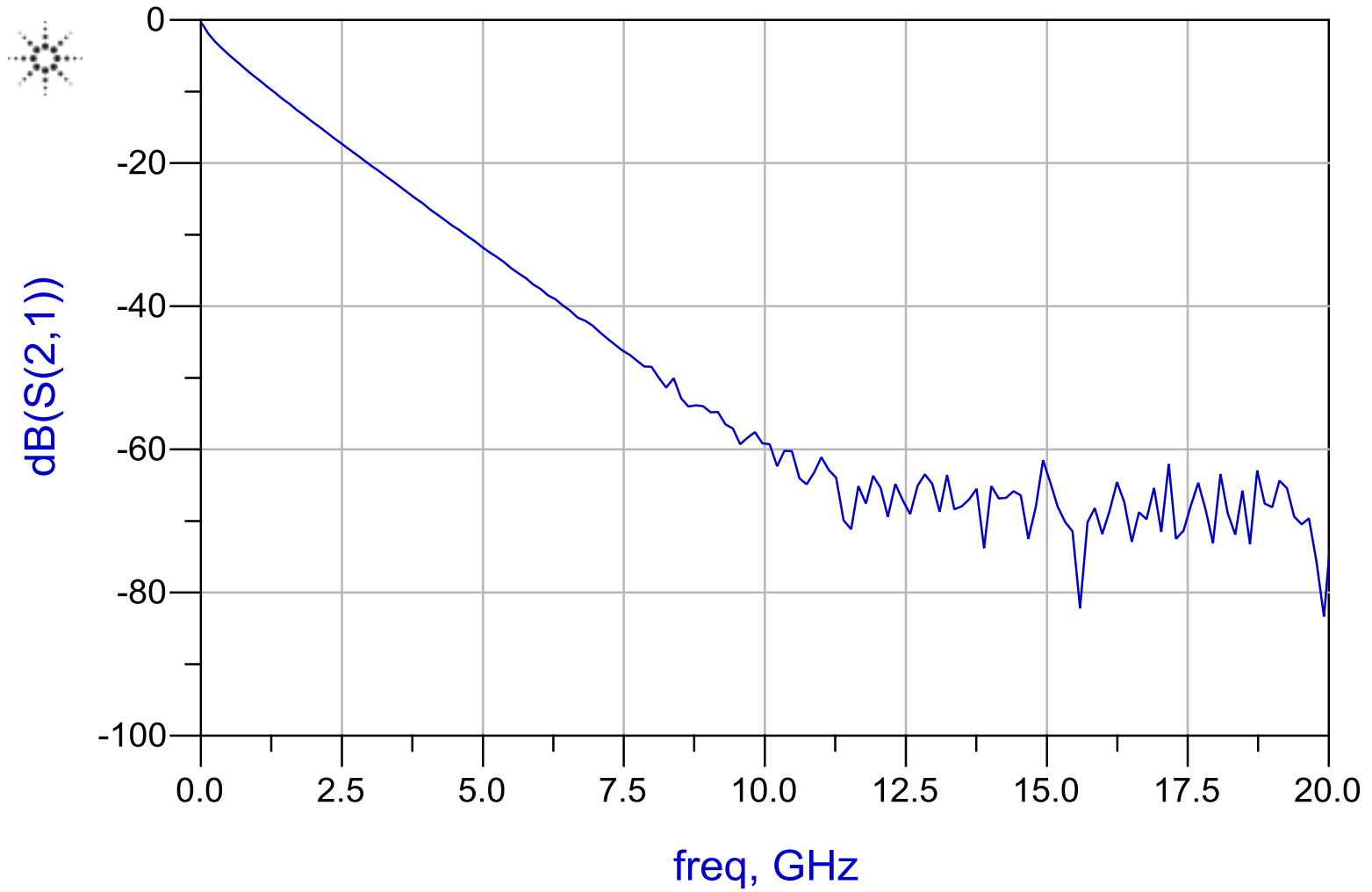
FR4 Test Trace Board 40 in | 6 mil
