

WITHDRAWAL NOTIFICATION of SELECTED COMMERCIAL PLD DEVICES

Texas Instruments Semiconductor Products Division offers 124 Programmable Logic devices. Occasionally, TI discontinues versions of products that have low or zero activity, or products that are no longer being fabricated because of low or zero activity. This letter is notification that TI is discontinuing 7 selected Programmable Logic Devices.

Please note that this withdrawal includes all package types, all speeds and all process levels, including die/wafers, as well as all Customer Drawings and programmed devices derived from the selected devices listed on the following pages. Shipments during this lifetime buy period will be sourced from a die bank. Orders will be processed in the order of receipt up to the total quantity of the packaged units supported by this die bank. Unless otherwise noted, devices to be discontinued are listed in the left-hand columns; and direct or suggested replacements that continue to be available are listed in the right hand columns. **TI continues to offer all other PLD parent products currently available.**

TI offers all customers an opportunity to place last purchase orders for "lifetime buy" requirements. Unless otherwise specified herein or required by a specific contract provision, orders for lifetime buy quantities must be received by **April 30, 2002**. All shipments must complete by **July 31, 2002**. Orders are non-cancelable, non-reschedulable, and non-returnable.
