

ISO7821 Dual Digital Isolator Evaluation Module

This user's guide describes the ISO7821 Dual Digital Isolator Evaluation Module (EVM). This EVM allows designers to evaluate device performance for fast development and analysis of isolated systems. The EVM supports evaluation of any of the TI dual-channel digital isolators in a 16DW package.

CAUTION

This evaluation module is made available for isolator parameter performance evaluation only and is not intended for isolation voltage testing. To prevent damage to the EVM, any voltage applied as a supply or digital input/output must be maintained within the 0 V to 5.5 V recommended operating range.

1 Introduction

This user's guide describes EVM operation with respect to the ISO7821 dual-channel digital isolators. However, the EVM may be reconfigured for evaluation of any of TI's dual-channel digital isolators in a 16DW package. This guide also describes the available channel configurations within the ISO7821 family, the EVM schematic, and typical laboratory setup. A typical input and output waveform is also presented.

2 Overview

The ISO7821 is TI's new digital isolator family capable of galvanic isolations up to 8000 Vpk. The devices are certified to meet reinforced isolation requirements by VDE and CSA. These isolators provide high electromagnetic immunity and low emissions at low power consumption, while isolating CMOS or LVCMOS digital I/O's. The ISO7821 digital isolators have logic input and output buffers separated by a silicon oxide (SiO2) insulation barrier. Used with isolated power supplies, these devices block high voltages, isolate grounds, and prevent noise currents on a data bus or other circuits from entering the local ground and interfering with, or damaging sensitive circuitry.

3 Pin Configurations of the ISO7821 Dual-Channel Digital Isolators




Figure 1. ISO782x Dual-Channel Digital Isolator Pin Configurations

Figure 1 illustrates the ISO782x dual digital isolator pin configurations.




Figure 2. ISO7821 EVM Configuration

Figure 2 shows the board configuration for evaluation of the ISO7821 dual-channel digital isolator.

5 EVM Setup and Operation




Figure 4. Basic EVM Operation

This section describes the setup and operation of the EVM for parameter performance evaluation. Figure 4 shows the configuration for operating the ISO7821 Dual-channel Digital Isolator EVM using two power supplies.




Figure 5. Typical Input and Output Waveforms

Figure 5 shows typical input and output waveforms of the EVM for a 1-MHz clock. The input is shown as channel 1, and the output is shown as channel 2.

7 EVM Schematics and Layout




Figure 6. ISO7821 EVM Schematic






Figure 7. ISO7821 PCB Layout

Separate orderable EVMs are available for each dual-channel device in the ISO782x family of digital isolators. The EVMs need to be modified only in the placement of $50-\Omega$ termination resistors at the input, and 10-pF capacitive loads at the output (only if needed) of each channel. Figure 6 shows the ISO7821 EVM schematic and Figure 7 shows the printed-circuit board (PCB) layout.
