SMP-TPS7A1650-MVK MAVRK Submodule User's Guide

1 Introduction

This document discusses the Modular and Versatile Reference Kit (MAVRK) <u>TPS7A1650</u> low-dropout <u>linear regulator</u> (LDO) submodule. After reading this guide, a developer should understand the features of the <u>SMP-TPS7A1650-MVK</u>. For more information on the MAVRK system, see the <u>MAVRK Introduction page</u>.

2 EVM Overview

The <u>SMP-TPS7A1650-MVK</u> highlights the <u>TPS7A1650</u> LDO with enable and power good. This submodule is intended for converting up to 60 V DC down to 5 V on <u>MAVRK PMU</u> modules, such as the <u>PMU-CARRIER-MVK</u> and <u>PMU-BAT-MVK</u>.

2.1 EVM Description




Figure 1. SMP-TPS7A1650-MVK MAVRK Submodule

Figure 1 shows the SMP-TPS7A1650-MVK MAVRK submodule.

The <u>SMP-TPS7A1650-MVK</u> contains the <u>TPS7A1650</u> integrated circuit and all other onboard components necessary to generate 5 V from a source of up to 60 V. The <u>SMP-TPS7A1650-MVK</u> can be used with a <u>MAVRK PMU</u> carrier board to evaluate the <u>TPS7A1650</u> performance as part of a power-management system. An onboard I²CTM temperature sensor can report the board temperature to the carrier board.




Figure 2. SMP-TPS7A1650-MVK Block Diagram

3 Hardware Description

3.1 Power Requirements




Figure 3. TPS7A1650 Dropout Voltage Versus Output Current

The <u>SMP-TPS7A1650-MVK</u> can accept an input of 5 to 60 V from the carrier board, and generates a fixed 5-V output. The minimum input voltage required for regulation is the 5-V output plus the dropout voltage of the LDO, shown in Figure 3.

The output current of the $\underline{\sf SMP-TPS7A1650-MVK}$ must not exceed 100 mA. Due to the small PCB area of the $\underline{\sf SMP-TPS7A1650-MVK}$, it is recommended not to exceed 0.75 W of power consumption on the board. The power consumption can be estimated as $(V_{\text{IN}} - V_{\text{OUT}}) \times I_{\text{OUT}}$. The onboard temperature sensor can be used to measure the temperature rise at different power levels.

The <u>SMP-TPS7A1650-MVK</u> can be used in a breadboard if pin 4 of CONN_1 (PMU_3_3V) is tied to a pullup voltage within the enable (EN) voltage range of the device. To avoid damage to the onboard temperature sensor, this voltage must not exceed 3.6 V. For connector pinout information, see the Hardware Design Guide for MAVRK PMU DC/DC Modules.

3.3 Getting Started: Configuring the EVM

The <u>SMP-TPS7A1650-MVK</u> must be connected to a DC-DC converter slot on a <u>MAVRK PMU</u> carrier board, such as the <u>PMU-CARRIER-MVK</u> or <u>PMU-BAT-MVK</u>. Do not exceed the carrier board voltage and current limits when using this module. For detailed setup information, see the <u>Configuring Power Submodules on a PMU Carrier Board page</u>.




Figure 4. SMP-TPS7A1650-MVK Board Layer 1 - Top Side




Figure 5. SMP-TPS7A1650-MVK Board Layer 2 – Ground Plane




Figure 6. SMP-TPS7A1650-MVK Board Layer 3 - Ground Plane




Figure 7. SMP-TPS7A1650-MVK Board Layer 4 – Bottom Side




Figure 8. SMP-TPS7A1650-MVK Board Solder Mask - Top Side




Figure 9. SMP-TPS7A1650-MVK Board Solder Mask – Bottom Side




Figure 10. SMP-TPS7A1650-MVK Board Silkscreen - Top Side




Figure 13. SMP-TPS7A1650-MVK Board Layer 4 - Bottom Side




Figure 14. SMP-TPS7A1650-MVK Schematic




Figure 15. SMP-TPS7A1650-MVK Fabrication Drawing
