

Texas Instruments DLP® Trademark Guidelines for NIRscan™ and LightCrafter™ Evaluation Modules



Who do these guidelines apply to?

These guidelines are for TI DLP® Products customers, licensees, and other parties who develop with DLP technology and wish to use DLP trademarks, service marks or images in promotional, advertising, instructional, or reference materials, or on their websites, products, labels, or packaging. Use of DLP trademarks may be prohibited, unless expressly authorized.

1. Always place Texas Instruments DLP or TI DLP with proper mark before NIRscan and LightCrafter with TM in the first occurrence in headlines and body copy with the approved noun (DLP® NIRscan™ evaluation module; DLP® LightCrafter™ evaluation module). Second and later uses in the body copy can drop Texas Instruments DLP and/or TI DLP and the TM symbol but must still be followed with an approved noun or a generic noun of a product or service (NIRscan development kit; LightCrafter development tool).
2. It should always be referenced in the fine print on literature or on the web as follows:
DLP® and the DLP logo are registered trademarks of Texas Instruments.
NIRscan™ is a trademark of Texas Instruments.
LightCrafter™ is a trademark of Texas Instruments.

 - a. “evaluation module”
 - b. “development kit”
 - c. “development tool”

The TI DLP® LightCrafter™ evaluation module is a compact tool for assessing DLP products for video and data display applications, and optical sensing.

Approved description of NIRscan in any promotional, advertising, instructional, or reference materials, or on websites, products, labels, or packaging.

The TI DLP® NIRscan™ evaluation module is a complete tool to design a high performance, affordable near-infrared spectrometer.
