



**Notes:**

1. Float pins 9 and 10.
2. EN3 – Enable pin for internal 3.3V LDO. Float to turn-on, ground to turn-off.
3. EN1 – Enable pin for the 5V output. Tie to V5FILT to turn-on, ground to turn-off.
4. EN2 – Enable pin for the 3.3V output. Tie to V5FILT to turn-on, ground to turn-off.
5. EN3 must be floating with EN1 and EN2 pulled to V5FILT for both outputs to be turned on.
6. For standby S5 connection, connect S5 net signal to VREG5 pin. Ground EN1, EN2, and EN3 pins.
