

#### **DESCRIPTION/ORDERING INFORMATION**

The SN74LVC08A quadruple 2-input positive-AND gate is designed for 2.7-V to 3.6-V  $V_{CC}$  operation.

The device performs the Boolean function in  $Y = A \bullet B$  or  $Y = \overline{A} + \overline{B}$  positive logic.

Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of this device as a translator in a mixed 3.3 V/5 V system environment.






