




Figure 4-3. Transfer Characteristics

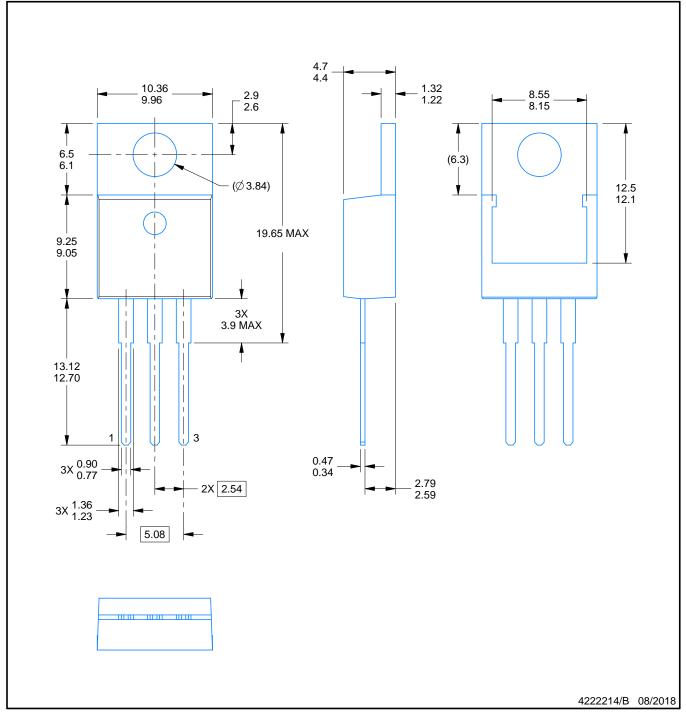

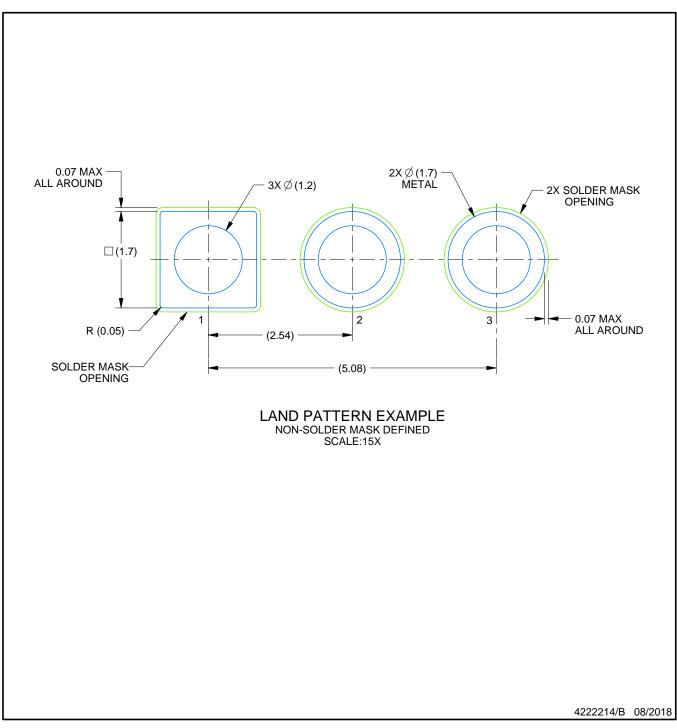
