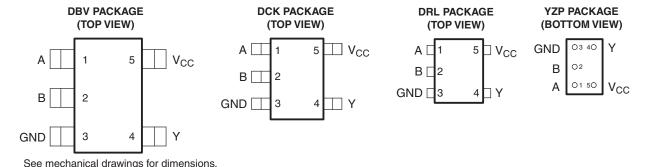

### **DESCRIPTION/ORDERING INFORMATION**

This single 2-input positive-NOR gate is operational at 0.8-V to 2.7-V  $V_{CC}$ , but is designed specifically for 1.65-V to 1.95-V  $V_{CC}$  operation.

The SN74AUC1G02 performs the Boolean function  $Y = \overline{A + B}$  or  $Y = \overline{A \bullet B}$  in positive logic.

NanoFree™ package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using  $I_{off}$ . The  $I_{off}$  circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.







DIE SIZE BALL GRID ARRAY

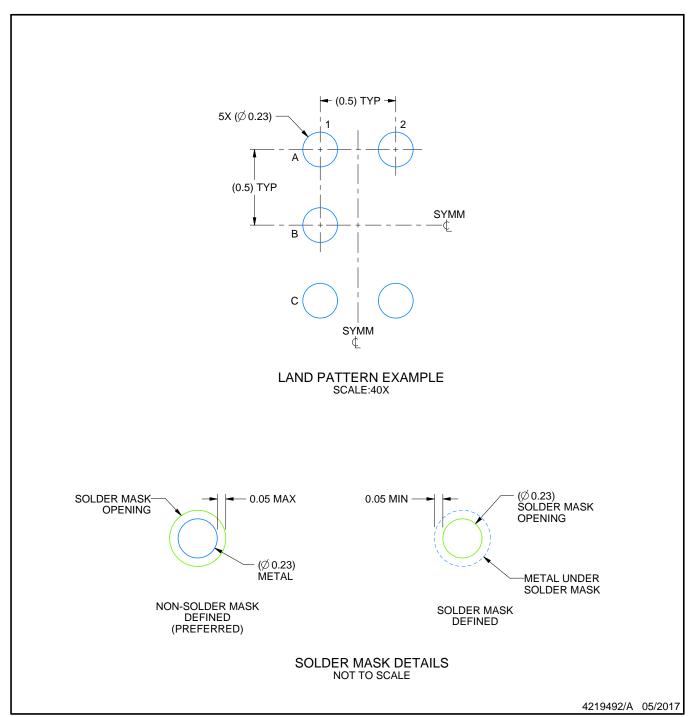

DIE SIZE BALL GRID ARRAY





PLASTIC SMALL OUTLINE



PLASTIC SMALL OUTLINE


