

## **EDERC2014 Presentation Guidelines**

### **Oral Presentations**

Each oral presentation is allocated a 20 minute time slot. This includes time required for introduction of the speaker, as well as time for questions from the audience. Therefore authors are advised to prepare a 16-minute talk leaving time for questions at the end. Each Session Chair will strictly enforce this timing.

Authors should meet their session Chair in the presentation room 10 minutes before the beginning of the session, when the presentation can be uploaded onto the presentation PC. You are required to bring your presentation to the conference on a USB stick. All presentation PCs will have up-to-date versions of PowerPoint and Adobe Acrobat Reader installed. Technical support can be provided if required.

If you have special presentation requirements (such as audio equipment) then you must inform the conference secretariat Katja Palsson [d-wicks@ti.com](mailto:d-wicks@ti.com) as soon as possible.

### **Poster Presentations**

Poster areas (1m wide, 2m tall) will be available. We recommend that posters are of maximum width 90 centimetres, and height in the range 0.8 metre to 1.2 metres (A0 size). Material will be provided at the conference to mount posters onto the poster area. The presenters are to report to the Poster Session Chair and put up their posters before the start of the session. All posters must be removed at the end of the particular day. Authors are requested to be present for at least 1.5 hours during the poster/special demo session.
