The IEC 62474 database (IEC 62474 DB) is the worldwide regulatory list of restricted substances, applications and thresholds as they apply to electronic products. The database is maintained by the IEC 62474 Validation Team committee. This list is typically updated on a bi-annual basis to meet the latest regulatory updates.

This list was the Joint Industry Guide (JIG) JIG-101 which was sunset in 2012 and became the IEC 62474 DB at that time.

TI products that are compliant to RoHS requirements and REACH requirements are also compliant to the additional substances and thresholds defined in the IEC 62474 Database.
