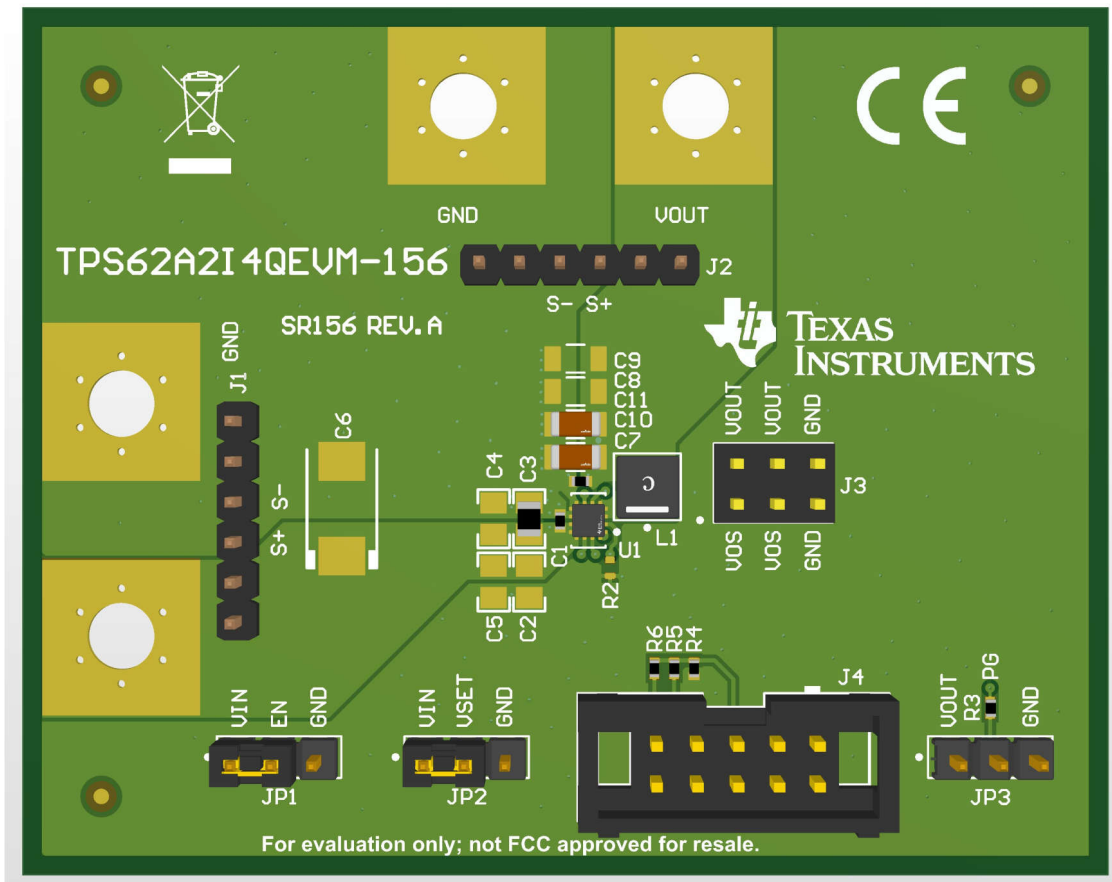

1 Evaluation Module Overview

1.1 Introduction

These EVMs are designed to help the user easily evaluate and test the operation and functionality of the TPS62A2I1-Q1, TPS62A2I2-Q1, TPS62A2I3-Q1 and TPS62A2I4-Q1 buck converters. EVMs convert a 2.75-V to 6-V input voltage to a regulated 0.75-V output voltage that delivers up to 4-A maximum. This user's guide describes the characteristics, operation, and use of TI's TPS62A2I1-Q1, TPS62A2I2-Q1, TPS62A2I3-Q1 and TPS62A2I4-Q1 evaluation modules (EVM). The document includes setup instructions for the following:

TPS62A2I4QEVM-156 has TPS62A2I4AQWRZXRQ1 IC on board, this EVM is also valid for the 1A, 2A and 3A variants. One need to change the IC on board only.

1.4 Device Information

The PCB for this EVM is designed to accommodate I2C version of IC TPS62A204Q.

- Default output voltage of IC on board is 0.75V. Other voltages can be set using I2C interface.
- Additional input and output capacitors can be added on C4, C5, C8 or C9.
- On the EVM, desired output voltage, mode, soft start time, spread spectrum and switching frequency can be adjusted by communicating with device through I2C interface.
- There are 16 compensating settings available for this device TPS62A2I4Q. Any of the available compensation can be selected through I2C interface.

2 Hardware

2.1 Setup

This section describes how to properly use the TPS62A2I4QEVM-156.

2.1.1 Connector Descriptions

J1, Pin 1 and 2 – VIN	Positive input voltage connection from the input supply for the EVM
J1, Pin 3 and 4 – S+/S–	Input voltage sense connections, measure the input voltage at this point
J1, Pin 5 and 6 – GND	Input return connection from the input supply for the EVM
J2, Pin 1 and 2 – VOUT	Positive output voltage connection
J2, Pin 3 and 4 – S+/S–	Output voltage sense connections, measure the output voltage at this point
J2, Pin 5 and 6 – GND	Output return connection
JP2– VSET	A resistor to GND on this pin defines the target output voltage value of the converter. This pin can also be directly connected to AGND or VIN. Connect this pin to AGND if not used
JP1 – EN	EN pin jumper. Place the supplied jumper across ON and EN to turn on the IC. Place the jumper across OFF and EN to turn off the IC.
JP3 – PG Pullup Voltage	PG pin pullup voltage jumper. Place the supplied jumper on JP2 to connect the PG pin pullup resistor to the output voltage. Alternatively, the jumper can be removed and a different voltage can be supplied on pin 5 to pull up the PG pin to a different level. This externally applied voltage must remain below 5.5 V.

2.1.2 Hardware Setup

To operate the EVM, set jumper JP1 to the desired positions per [Connector Descriptions](#). Connect the input supply to J1 and connect the load to J2.

2.2 Modifications

The printed-circuit board (PCB) for this EVM is designed to accommodate some modifications by the user. Additional input and output capacitors according to the output voltage can be added. Also, the output voltage can be changed with I2C interface. Please follow datasheet for all available I2C settings.

2.2.1 Input and Output Capacitors

C4, C5 is provided for an additional input capacitor. This capacitor is not required for proper operation but can be used to reduce the input voltage ripple.

C8, C9 are provided for additional output capacitors. These capacitors may not be required for proper operation but can be used to reduce the output voltage ripple and to improve the load transient response. The output capacitance must remain within the recommended range in the device datasheet for proper operation.

3 Hardware Design Files

3.1 Schematic

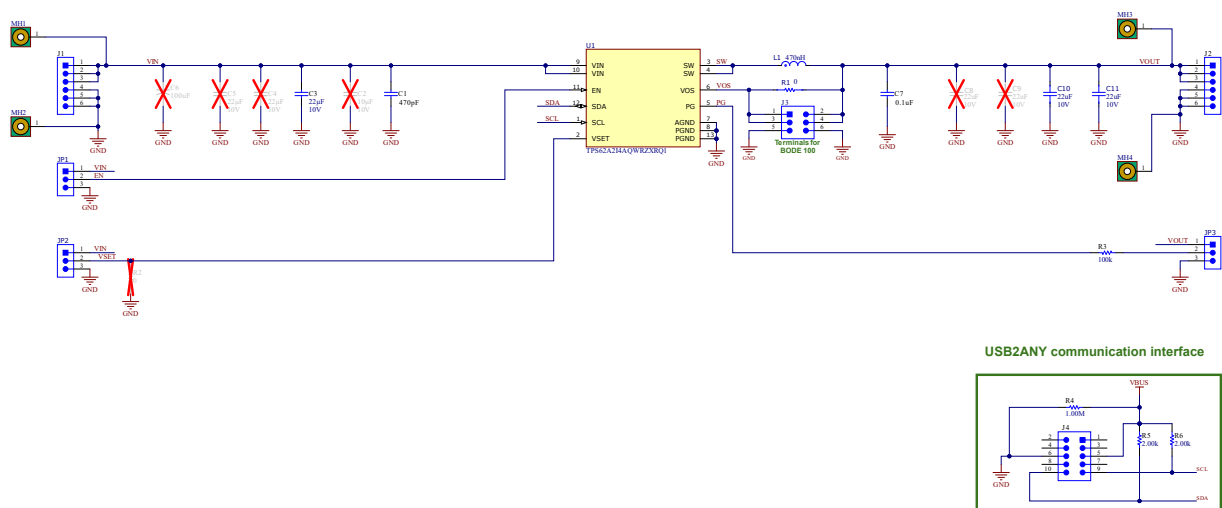


Figure 3-1. TPS62A2I4QEVM-156 Schematic

Figure 3-1 illustrates the EVM schematic of TPS62A2I4QEVM-156, which is also valid for the TPS62A2I1-Q1, TPS62A2I2-Q1, and TPS62A2I3-Q1 variant.

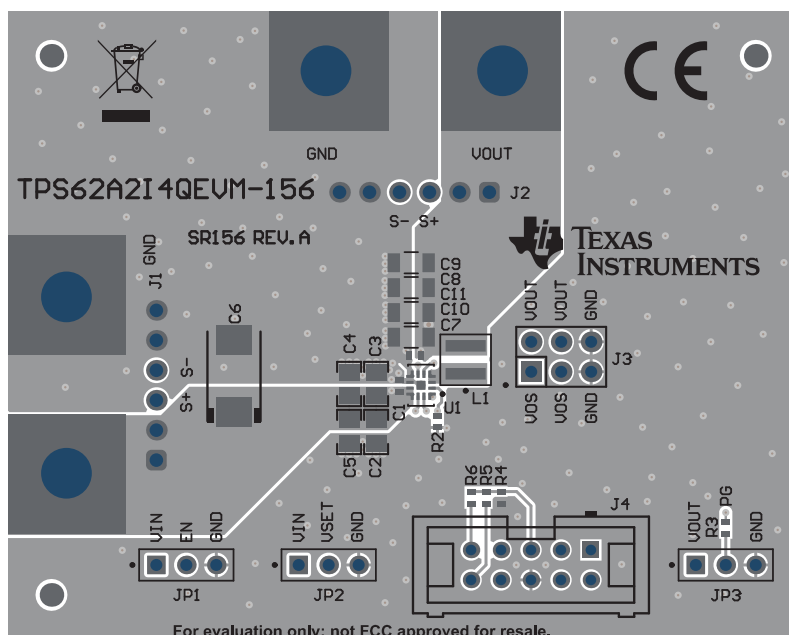


Figure 3-2. Top View Mask

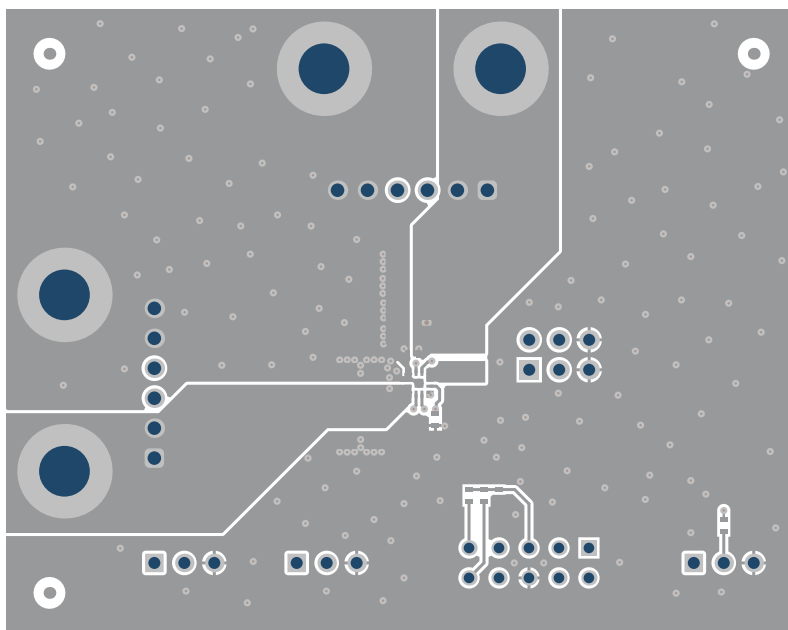


Figure 3-3. Top Layer

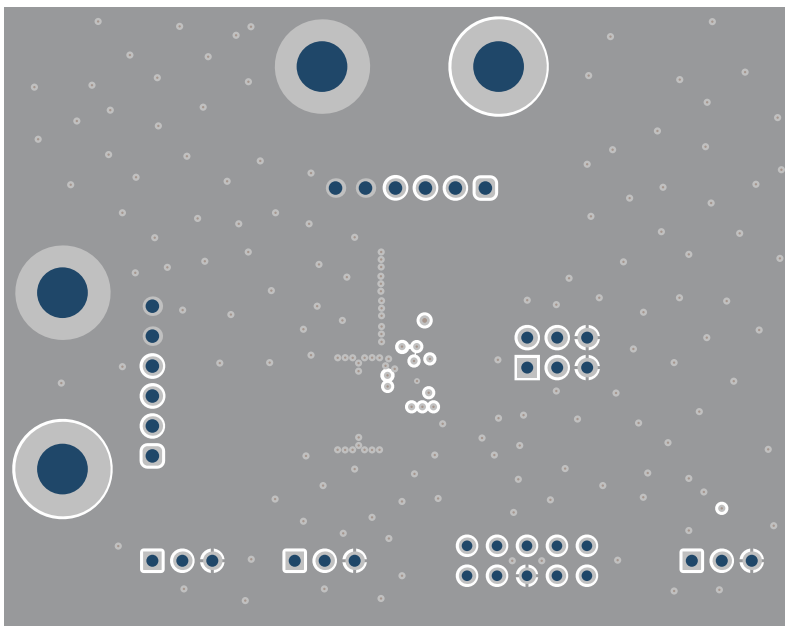


Figure 3-4. Signal Layer 1

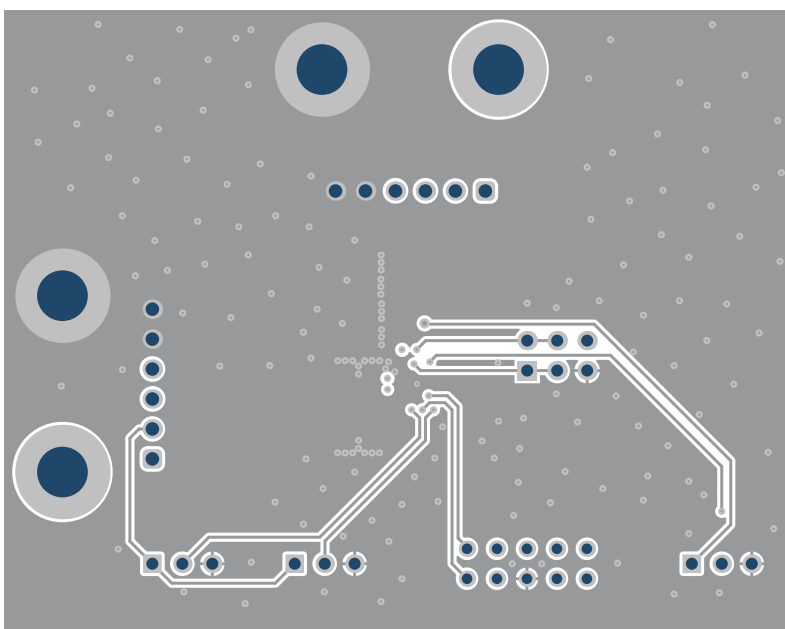


Figure 3-5. Signal Layer 2

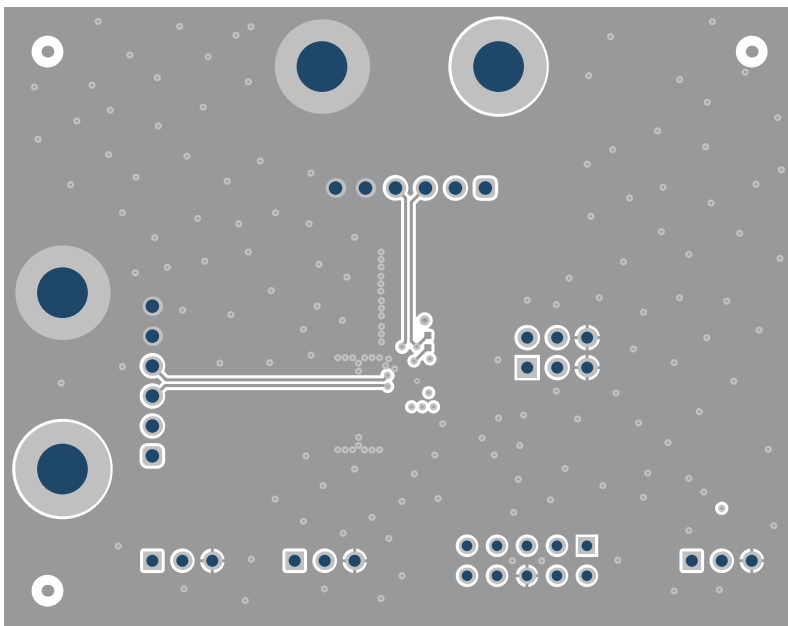


Figure 3-6. Bottom Layer
