TMUX-8RQX-EVM



ABSTRACT

This document is the EVM user's guide for the TMUX-8RQX-EVM. This board is designed for TI's mid-voltage analog switch and multiplexers in an 8-pin RQX package, which includes devices such as TMUX7219.

1 Introduction

This user's guide describes the TMUX-8RQX-EVM evaluation module (EVM) and its intended use. This board allows for the quick prototyping and DC characterization of TI's mid voltage switches and multiplexers in an 8 Pin RQX package, which includes, but is not limited to, devices like the TMUX7219.




Figure 1-1. TMUX-8RQX-EVM Top Side




Figure 1-2. TMUX-8RQX-EVM Bottom Side

3 Features

The EVM has the following features:

- 1 power supply decoupling apacitor from VDD to ground (3.3 µF, 6 mm × 5 mm)
- 2 additional power supply decoupling capacitor pads from VDD to ground (6 mm × 5 mm)
- 1 power supply decoupling capacitor from VSS to ground (3.3 μF, 6 mm × 5 mm)
- 2 additional power supply decoupling capacitor pads from VSS to ground (6 mm × 5 mm)
- Pads available near VDD and VSS input for TVS Diodes (L × W: 8.13 mm × 6.22 mm)
- 1 pad for switches and multiplexers in the 8-pin RQX package.
- 8 generic 6-pin headers for power, analog or digital signals being switched, and control signals.
- All 8 generic signal pathways have 2 0805 size 0 Ω resistors installed between IC pad and header.
- All 8 generic signal pathways have 0603 sized pads to add a pull-up, pull-down, or resistive load to the signal pathway.
- All 8 generic signal pathways contain an 1812 sized pad to add a capacitive load to the signal pathway.
- All 8 generic signal pathways contain a 1206 sized pad to add a capacitive load to the signal pathway.
- 1 common 3-port terminal block for GND, VDD, and VSS power signals.
- 1 3-pin header to configure thermal pad voltage (GND for single supply, VSS for dual supply).




Figure 3-1. TMUX-8RQX-EVM Top Layout (Default + U1 Installed)




Figure 3-2. TMUX-8RQX-EVM Bottom Layout (Default)

4 TMUX-8RQX-EVM Setup

- 1. The default setup of the board has all 8 generic pathways grounded, with the IC set to single supply operation as the pad voltage is also set to ground. If dual operation is desired, then move to step 2. If not, then move to step 3.
- 2. If dual supply operation is desired, then locate J9 on the EVM. Move the shunt so that the pins labeled *PAD* and *VSS* are shorted together instead of the default *PAD* to *VDD* connection. This will ensure the PAD of the RQX package is exposed to the lowest potential in the system w.r.t. ground during dual supply operation.




Figure 4-1. Left Side Jumper (J1-J4) Configuration or Pinout




Figure 4-2. Right Side Jumper (J5-J8) Configuration or Pinout

- 3. All 8 generic signal pathway headers contain six pins. Figure 4-1 and Figure 4-2 show the generalized pinout of the headers for the left and right side of the board respectively. Please note that the orientation is based on J10 being on the top of the board.

For the left side header, pin 1 is at the top left corner pin (denoted as an *X*). The pin number increases counter-clockwise from 1 to 6. The right side header has pin 1 (denoted as an *X*), which is at the bottom right corner. The right side header pin number increases counter-clockwise from 1 to 6. Table 4-1 shows the jumper configurations. Note; *U1* refers to the signal pathway that connects to the U1 8-pin RQX footprint.

Check the device specific data sheet for the pin-out. For power (VDD or VSS) and ground (GND), lines connect shunts on the appropriate jumpers to short the U1 pin to the respective VDD, VSS, or GND line. For testing where control pins will not change state (such as the select or enable pin always being at a logic '1' for the duration of testing), shunts can be connected on the appropriate jumpers to short the U1 control pins to VDD or GND. For the remaining I/O pins (VDD, VSS, and GND), signals can be applied using shunts in the same manner as before or the shunt can be removed and an external signal can be applied to the jumper's 'U1' pin or its respective test point.

4. In cases where the tests requires pull-up or pull-down resistors versus directly attaching the source to the respective U1 pin, all 8 generic pathways contain 0603 resistor pads to add these components. Table 4-2 shows the ID's.

5. Now loads can be attached to the board. If a pull-down pad was unused, then this pad can now be used as a pad for a resistive load. There are also pads for capacitive loads for each of the 8 generic signal pathways that can also be utilized. Table 4-3 shows the corresponding pad and jumper ID's. Note: the 1812 sized capacitor pads are on the bottom side of the EVM.

6. Now that the loading is complete for the board, additional supply decoupling capacitance to ground can be added for the VDD or VSS lines. Table 4-4 shows the power supply decoupling capacitance for each VDD or VSS line. If the default capacitance is enough, then move on to step 7.

7. If testing with protection diodes is desired, then there are two protection diode pads (one for each VDD and VSS) on the bottom side of the board. The board was designed with the 5.0SMDJ100A protection diode's footprint. Table 4-5 shows the connections if it is desired to add them. If not, then move to step 8.

8. Finally, attach the supply signals (VDD, GND, or VSS) to the appropriate pins of the terminal block labeled J10. Power is now ready to be applied to the board. For test points, please see the next section.



5 TMUX-8RQX-EVM Test Points

1. There are multiple test points (26) on the board that can be used to either measure the associated trace or apply external signals to for testing purposes. Table 5-1 shows the test points for the 8 generic U1 connections. There are 2 test points per pin of the IC, which are colored blue. The test points with format TPX are farther from the U1 device than test points with the format TP10X.




Figure 6-1. Main Schematic - TMUX-8RQX-EVM All Components Shown






Figure 6-2. Main Schematic – TMUX-8RQX-EVM Defualt + U1 Pad Shown




Figure 6-3. Hardware Schematic - TMUX-8RQX-EVM Default Setup




Figure 7-1. PCB Top Layer TMUX-8RQX-EVM




Figure 7-2. PCB Bottom Layer TMUX-8RQX-EVM
