DAC80502-01 Evaluation Module



Description

The DAC80502-01EVM is an easy-to-use platform to evaluate the functionality and performance of the DAC80502 and DAC80501 devices. The DAC80502-01EVM has optional circuits and jumpers to configure the device for different applications. The DAC80502 and DAC80501 are both installed on the EVM.

DAC80501 is a single-channel, buffered, low-voltage-output digital-to-analog converter (DAC) in 16-bit resolution. DAC80502 is a dual-channel, buffered, low-voltage-output DAC in 16-bit resolution. The devices provide unipolar output voltage up to 5 V.

1 Evaluation Module Overview

1.1 Introduction

The DACx050x digital-to-analog converter (DAC) is a highly accurate, low-power device with voltage output. The DACx050x is specified monotonic by design and offer linearity of less than 1 LSB. These devices include a 2.5-V, 5-ppm/°C internal reference, giving full-scale output voltage ranges of 1.25 V, 2.5 V, or 5 V.

The DACx050x incorporates a power-on-reset (POR) circuit that makes sure the DAC output powers up at zero-scale or mid-scale, and remains at that scale until a valid code is written to the device. These devices consume a low current of 1 mA, and include a power-down feature that reduces current consumption to typically $15 \, \mu A$ at $5 \, V$.

The digital interface of the DACx050x can be configured to SPI or I²C mode using the SPI2C pin. In SPI mode, the DACx050x uses a versatile 3-wire serial interface that operates at clock rates of up to 50 MHz. In I²C mode, the DACx050x operates in standard mode (100Kbps), fast mode (400Kbps), and fast mode plus (1.0Mbps).

This user's guide describes the characteristics, operation, and recommended use cases of the DAC80502-01EVM. This document provides examples and instructions on how to use the DAC80502-01EVM board and included software. Throughout this document, the terms evaluation board, evaluation module, and EVM are synonymous with the DAC80502-01EVM. This document also includes schematics, the reference printed circuit board (PCB) layouts, and a complete bill of materials (BOM).

1.3 Specification

The EVM is intended to provide basic functional evaluation of the device. The layout is not intended to be a model for the target circuit, nor laid out for electromagnetic compatibility (EMC) testing. The EVM consists of a printed-circuit board (PCB), which has the DAC80501 and DAC80502 installed.

1.4 Device Information

Table 1-2 lists the devices supported by the DAC80502-01EVM. DACx050x is used as a generic name for these devices. This document focuses on the DAC80501 and DAC80502 that come pre-installed on the EVM.

2 Hardware

2.1 Hardware Setup

This section describes the overall system setup for the EVM. A computer runs software that communicates with the FTDI controller onboard using I²C or SPI protocols.

2.1.1 Hardware Theory of Operation




Figure 2-1. Theory of Operation Block Diagram

The DAC80502-01EVM is connected to the computer through the on-board FTDI digital controller using the USB cable that is supplied with the EVM. The evaluation board features connectors and test points for all communication lines, DAC outputs, and supplies. Figure 2-1 shows a block diagram of the DAC80502-01EVM.

The USB connection provides the 5-V supply to the EVM. Voltage regulators generate 3.3 V and 1.8 V from the USB 5-V supply. These 3.3-V and 1.8-V supplies are used to power the FTDI controller.

The DAC80501 and DAC80502 VDD supplies can use the on-board 5-V or 3.3-V supplies depending on the jumper J6 setting. By default, VDD is connected to the on-board 5-V supply. Alternatively, VDD can be supplied externally through banana jack J4. Remove the jumper connector on J6 before connecting external supplies to VDD.

The device reference voltage can be supplied by an onboard 2.5-V voltage regulator by shorting jumper J10 for DAC80502 and J12 for DAC80501, or from an external supply with SMA connector J9. Make sure that the internal reference is powered off before connecting any other voltage supply to the VREFIO pin.

Each of the DAC outputs have footprints available for capacitor and resistor loads that are unpopulated by default.

2.1.2 Jumper Definitions




Figure 2-2. DAC80502-01EVM Default Jumper Settings

The jumpers must be connected properly to operate the DAC80502-01EVM. Table 2-1 provides the details of the configurable jumper settings of the DAC80502-01EVM. Figure 2-2 shows the default jumper connections on the board.

2.2 Hardware Overview

This section details how to configure the EVM for voltage outputs using I²C and SPI. The following subsections provide detailed information on the EVM hardware and jumper positions for the two communication modes (see also Section 2.1.2).

2.2.1 Electrostatic Discharge Caution

CAUTION

Many of the components on the DAC80502-01EVM are susceptible to damage by electrostatic discharge (ESD). Customers are advised to observe proper ESD handling precautions when unpacking and handling the EVM, including the use of a grounded wrist strap at an approved ESD workstation.

2.2.2 Connecting the FTDI Digital Controller

To connect the FTDI digital controller on the EVM board to the computer, align and firmly connect the USB connector to the J3 connector. Verify the connection is snug; a loose connection can cause intermittent operation. A 100 mil header (J15) is available for external communication. Table 2-6 lists the J15 pin definitions. To use external communication, close jumper J1 to disable the connection to the FTDI controller. When using I²C, TI recommends to close the J8 and J11 jumpers in the I²C positions, as the jumpers connect the pull-up resistors R12 and R13 to the communication lines.




Figure 2-3. DAC80502-01EVM SPI Configuration




Figure 2-4. DAC80502-01EVM I²C Configuration

3 Software

3.1 Software Setup

This section provides the procedure for EVM software installation.

3.1.1 Software Installation

Note

Do not connect the EVM to the computer while the software is installing.

Download the latest version of the EVM graphical user interface (GUI) installer from the *Order and start development* subsection of the DAC80502-01EVM tool folder on TI.com. Run the GUI installer to install the DAC805xx GUI software on your computer. The software installation automatically copies the required LabVIEW™ software files and drivers to the computer.




Figure 3-1. Software Installation Path

When the DAC805xx GUI is launched, an installation dialog window opens and prompts the user to select an installation directory. If left unchanged, Figure 3-1 shows that the software location defaults to C:\Program Files (x86)\Texas Instruments\DAC805xxEVM.

The EVM software also installs the Future Technology Devices International Limited (FTDI) USB drivers using a separate executable file. Figure 3-2 shows the FTDI USB drivers installation window that is automatically launched after the DAC805xx software installation is complete.

3.2 Software Overview

This section discusses how to use the DAC8050xxEVM software.

3.2.1 Launching the Software

If installed in the default directory, then launch the DAC8050xxEVM software by searching for "DAC805xxEVM" in the Windows® *Start* menu.

Figure 3-3 shows the Device Setting configuration menu that is present when the GUI is launched. Select either the DAC80501 or DAC80502 device from the drop-down menu and click **CONFIG**. The software only supports one device at a time.




Figure 3-4. DAC8050xxEVM Interface Settings Menu

After a device is selected, the Interface Settings menu pops up. This menu is shown in Figure 3-4. From this menu, select the interface protocol, as well as the I²C address. Select the **CONFIG** button to save the current settings and launch the main GUI.




Figure 3-5. DAC805xxEVM GUI DAC80501 Selection at Launch




Figure 3-6. DAC805xxEVM GUI DAC80502 Selection at Launch

If the FTDI controller is not connected to the computer when the software is launched, then the GUI defaults to *demo* mode. Figure 3-7 illustrates the bottom-left corner of the GUI that shows the hardware connection status: DEMO MODE or CONNECTED. After the FTDI controller is properly connected to the computer, restart the DAC805xxEVM software to detect the device.

3.2.2 Software Features

The DAC805xxEVM GUI allows for I²C or SPI communication to the DAC80501 and DAC80502. Although the entire register map is available for use, some features have been abstracted into user controls in the High-Level Configuration page for easy operation.

3.2.2.1 Low Level Configuration Page




Figure 3-8. DAC80501 Low Level Configuration Page




Figure 3-9. DAC80502 Low Level Configuration Page

Figure 3-8 shows the Low Level Configuration page of the DAC805xxEVM GUI. This page allows direct access to all registers on the DAC80501. Figure 3-9 shows the Low Level Configuration page for the DAC80502.

The Register Map section in the center of the page lists all the registers. Directly above the Register Map section are four buttons that allow for read and write access to all registers.

Select a register on the Register Map list to show a description of the values in that register, as well as information on the register address, default value, size, and current value. Data are written to the registers by entering a value in the value column of the GUI.

3.2.2.2 High Level Configuration Page

The High Level Configuration page is used to set the configuration of the DAC805xxEVM GUI. The page is comprised of one tab: DAC80501 if the DAC80501 device was selected, or DAC80502 if the DAC80502 device was selected. These two tabs act as shortcuts to configure the DAC80501 and DAC80502 for basic functionality and testing.




Figure 3-10. DAC80501 Tab of the High Level Configuration Page

Figure 3-10 shows the DAC80501 tab of the High Level Configuration page. This tab is used to set the gain and output for the DAC. The internal reference and the reference division can also be powered on and off here.




Figure 3-11. DAC80502 Tab of the High Level Configuration Page




Figure 4-1. DAC80502-01EVM FTDI Schematic




Figure 4-2. DAC80502-01EVM DUT Schematic




Figure 4-3. DAC80502-01EVM PCB Top Layer Layout




Figure 4-4. DAC80502-01EVM PCB Mid Layer 1 Layout (Ground Plane)






Figure 4-5. DAC80502-01EVM PCB Mid Layer 2 Layout (Power Plane)




Figure 4-6. DAC80502-01EVM PCB Bottom Layer Layout
