## Description

The DAC80508-04EVM is an easy-to-use platform to evaluate the functionality and performance of the DACx0508 and DACx0504 family of devices. The DAC80508-04EVM has optional circuits and jumpers to configure the device for different applications. The DAC80508 is installed on the EVM. The user can replace the DAC80508 with the DAC80504.

The DAC80508 and DAC80504 are 16-bit buffered voltage-output digital-to-analog converters (DAC). The DAC80508 has 8 DACs, and the DAC80504 has 4 DACs. The devices includes a 2.5-V, 5-ppm/°C internal reference and a user-selectable gain configuration giving full-scale output voltages of 1.25 V, 2.5 V, or 5 V. The devices operate from a single 2.7-V to 5.5-V supply, is verified monotonic, and provides exceptional linearity of ±1 LSB INL.



# 1 Evaluation Module Overview

## 1.1 Introduction

The DACx050x is a pin-compatible family of low-power, multi-channel, buffered voltage output, digital to-analog converters (DAC). The DACx050x includes a 2.5-V, 5-ppm/°C internal reference, eliminating the need for an external precision reference in most applications. A users-selectable gain configuration provides full-scale output voltages of 1.25 V (gain =  $\frac{1}{2}$ ), 2.5 V (gain = 1) or 5 V (gain = 2). The device operates from a single 2.7-V to 5.5-V supply, is specified monotonic, and provides high linearity of ±1 LSB INL.

Communication to the DACx050x is performed through a serial interface that operates at clock rates up to 50 MHz. The VIO pin enables serial interface operation from 1.7 V to 5.5 V. The DACx050x flexible interface enables operation with a wide range of industry-standard microprocessors and micro-controllers.

The DACx050x incorporates a power-on-reset circuit that powers up and maintains the DAC outputs at either zero-scale or mid-scale until a valid code is written to the device. The devices consume low current of 0.6 mA/channel at 5.5 V, making the devices an excellent choice for battery-operated equipment. A per-channel power down feature reduces the device current consumption to 15  $\mu$ A.

This user's guide describes the characteristics, operation, and recommended use cases of the DAC80508-04EVM. This document provides examples and instructions on how to use the DAC80508-04EVM board and included software. Throughout this document, the terms evaluation board, evaluation module, and EVM are synonymous with the DAC80508-04EVM. This document also includes schematics, the reference printed circuit board (PCB) layouts, and a complete bill of materials (BOM).

## 1.3 Specification

The EVM is intended to provide basic functional evaluation of the device. The layout is not intended to be a model for the target circuit, nor laid out for electromagnetic compatibility (EMC) testing. The EVM consists of a printed-circuit board (PCB), which has the DAC80508 installed.

## 1.4 Device Information

Table 1-2 lists the devices supported by the DAC80508-04EVM. DACx050x is used as a generic name for these devices. This document focuses on the DAC80508, which comes pre-installed on the EVM, and the DAC80504.

# 2 Hardware

#### 2.1 Hardware Setup

This section describes the overall system setup for the EVM. A computer runs software that communicates with the FTDI controller onboard using SPI protocol.

#### 2.1.1 Hardware Theory of Operation




Figure 2-1. Theory of Operation Block Diagram

The DAC80508-04EVM is connected to the computer through the on-board FTDI digital controller using the USB cable that is supplied with the EVM. The evaluation board features connectors and test points for all communication lines, DAC outputs, and supplies. Figure 2-1 shows a block diagram of the DAC80508-04EVM.

The USB connection provides the 5-V supply to the EVM. Voltage regulators generate 3.3 V and 1.8 V from the USB 5-V supply. These 3.3-V and 1.8-V supplies are used to power the FTDI controller.

The VDD supply can use the on-board 5-V or 3.3-V supplies depending on the jumper J6 setting. By default, VDD is connected to the on-board 5-V supply. Alternatively, VDD can be supplied externally through banana jack J4. Remove the jumper connector on J6 before connecting external supplies to VDD.

The VIO supply can use the on-board 1.8 V or use the same voltage as VDD depending on the jumper J5 setting. By default, VIO is connected to VDD. Alternatively, VIO can be supplied externally through banana jack J8. Remove the jumper connector on J5 before connecting external supplies to VIO.

The device reference voltage can be supplied via an onboard 2.5-V voltage regulator by shorting jumper J12, or from an external supply with SMA connector J10. Make sure that the internal reference is powered off before connecting any other voltage supply to the REF pin.

Each of the DAC outputs have footprints available for capacitor and resistor loads that are unpopulated by default.



## 2.1.2 Jumper Definitions




Figure 2-2. DAC80508-04EVM Default Jumper Settings

The jumpers must be connected properly to operate the DAC80508-04EVM. Table 2-1 provides the details of the configurable jumper settings of the DAC80508-04EVM. Figure 2-2 shows the default jumper connections on the board.

#### 2.2 Hardware Overview

This section details how to configure the EVM for voltage outputs using SPI. The following subsections provide detailed information on the EVM hardware.

#### 2.2.1 Electrostatic Discharge Caution

CAUTION

Many of the components on the DAC80508-04EVM are susceptible to damage by electrostatic discharge (ESD). Customers are advised to observe proper ESD handling precautions when unpacking and handling the EVM, including the use of a grounded wrist strap at an approved ESD workstation.

#### 2.2.2 Connecting the FTDI Digital Controller

To connect the FTDI digital controller on the EVM board to the computer, align and firmly connect the USB connector to the J3 connector. Verify the connection is snug; a loose connection can cause intermittent operation. A 100 mil header (J15) is available for external communication. Table 2-6 lists the J15 pin definitions. To use external communication, close jumper J1 to disable the connection to the FTDI controller.

Additionally, the board has a dedicated 100 mil header for the DAC80504 digital pins. The DUT connects to this header with 0  $\Omega$  resistors, which are unpopulated by default. If the DAC80504 is used, then TI recommends to populate R29, R30, R31, and R32 to connect the GAIN, RSTSEL, REFDIV, and LDAC to the FTDI and digital header. Table 2-7 lists the pin definitions.

## 3 Software 3.1 Software Setup

This section provides the procedure for EVM software installation.

#### 3.1.1 Software Installation

**Note** Do not connect the EVM to the computer while the software is installing.

Download the latest version of the EVM graphical user interface (GUI) installer from the Order and start development subsection of the DAC80508-04EVM tool folder on TI.com. Run the GUI installer to install the DAC805xxEVM GUI software on your computer. The software installation automatically copies the required LabVIEW<sup>™</sup> software files and drivers to the computer.

When the DAC805xx GUI is launched, an installation dialog window opens and prompts the user to select an installation directory. If left unchanged, Figure 3-1 shows that the software location defaults to *C*:\*Program Files* (x86)\*Texas Instruments\DAC805xxEVM*.

## 3.2 Software Overview

This section discusses how to use the DAC805xxEVM software.

#### 3.2.1 Launching the Software

If installed in the default directory, then launch the DAC805xxEVM software by searching for DAC805xxEVM GUI in the Windows<sup>®</sup> Start menu.

Figure 3-3 shows the Device Setting configuration menu that is present when the GUI is launched. Select either the DAC80504 or DAC80508 device from the drop-down menu and click **CONFIG**. The software only supports one device at a time.

If the FTDI controller is not connected to the computer when the software is launched, then the GUI defaults to *demo* mode. Figure 3-6 illustrates the bottom-left corner of the GUI that shows the hardware connection status: DEMO MODE or CONNECTED. After the FTDI controller is properly connected to the computer, restart the DAC805xxEVM software to detect the device.

#### 3.2.2 Software Features

The DAC805xxEVM GUI allows for SPI communication to the DAC80508 or DAC80504 and control of the digital pins. Although the entire register map is available for use, some features have been abstracted into user controls in the *High-Level Configuration* page for easy operation.

#### 3.2.2.1 Low Level Configuration Page

Figure 3-7 shows the *Low Level Configuration* page of the DAC805xxEVM GUI with the DAC80504 device selection. This page allows direct access to all registers on the DAC80504. Figure 3-8 shows the *Low Level Configuration* page for the DAC80508.

The *Register Map* section in the center of the page lists all the registers. Directly above the *Register Map* section are four buttons that allow for read and write access to all registers.

Select a register on the Register Map list to show a description of the values in that register, as well as information on the register address, default value, size, and current value. Data are written to the registers by entering a value in the value column of the GUI.

## 3.2.2.2 High Level Configuration Page

The *High Level Configuration* page is used to set the configuration of the DAC805xxEVM GUI. The page is comprised of one tab: *DAC80504* if the DAC80504 device was selected, or *DAC80508* if the DAC80508 device was selected. These two tabs act as shortcuts to configure the DAC80504 and DAC80508 for basic functionality and testing.




Figure 3-9. DAC80504 Tab of the High Level Configuration Page

Figure 3-9 shows the *DAC80504* tab of the *High Level Configuration* page. This tab is used to set the gain and output for the DACs. The DAC80504 digital pins can also be controlled here. To use the digital pin GUI functionality, resistors R29, R30, R31, and R32 are required to be populated with 0  $\Omega$  resistors. These resistors connect the digital pins to the FTDI GPIO pins. By default, the GAIN, REFDIV, and RSTEL GPIOs are set to 0 V. If the GAIN, REFDIV, or RSTSEL options are changed, the DAC80504 needs to go through a power-on-reset for the changes to take effect. Do not unplug the USB cable to reset the power, as this resets the GPIO pins as well. The internal reference and the reference division can also be powered on and off here.





Figure 3-10. DAC80508 Tab of the High Level Configuration Page





Figure 4-3. DAC80508-04EVM PCB Top Layer Layout








Figure 4-5. DAC80508-04EVM PCB Mid Layer 2 Layout (Power Plane)




Figure 4-6. DAC80508-04EVM PCB Bottom Layer Layout
