# User's Guide DRV821xEVM and DRV8220EVM User's Guide



### ABSTRACT

This document is provided with the DRV82xx family customer evaluation modules (EVM) as a supplement to the DRV8210, DRV8212, and DRV8220 data sheets. This user's guide describes the hardware implementation of the EVM.

### CAUTION

DRV8210EVM and DRV8212EVM are rated for power supply voltages between 1.65 VDC and 11 VDC max. The DRV8210 can support peak output currents up to a maximum of 1.6 ADC and the DRV8212 can support peak output currents up to a maximum of 4 ADC. To maintain component temperatures below the 130°C rating of the printed circuit board material, TI requires that the continuous current of both channels be limited to **0.9 A-RMS** when operating for extended periods of time at an ambient temperature of 25°C.




Figure 1-1. PCB (Top 3-D View)




Figure 1-2. PCB (Assembly View)



# **1** Introduction

The DRV821x/8220EVM is a complete solution for evaluating the DRV821x/8220 H-bridge motor drivers. The evaluation module (EVM) can support the DSG, PDSG, and DRL package variants of the DRV8210/12/20 devices. However, only one component can be populated at a time since the input control signals (EN/IN1 and PH/IN2) are shared among the two components.

The EVM includes current sensing circuitry using a current sensing resistor and current sense amplifier (for additional details about the current sensing see Section 3). The EVM includes an MSP430<sup>™</sup> microcontroller that is preprogrammed to take input from two dedicated analog potentiometers for PWM speed control of one or two brushed DC motors. The jumper on the PMODE/nSLEEP pin (J2) allows the user to select the input control mode or the sleep state of the driver depending on which component is populated on the EVM (further details are provided in Section 2).

Power can be provided externally up to 11 V for the DRV8210/12 and 18V for the DRV8220 through the power header. To expand beyond the included firmware capability, the MSP430 MCU can be reprogrammed through the eZ-FET<sup>™</sup> emulation circuit found in most MSP430 Launchpads. We recommend the MSP-EXP430FR5969. Note that a four pin angled male header is required and must be soldered to J21 of this Launchpad from V+ pin to GND pin. We recommend a pin header with pin dimensions similar to 850-10-050-20-001000 (Digikey part number). The U1 MCU must be removed from the Launchpad.

# **2 Power Connectors**

The DRV821x/8220EVM uses a single header for power entry to the EVM board. Only a single power supply rail is necessary since an onboard 3.3-V regulator provides power to the MSP430. The minimum recommended VM voltage for the EVM is 1.65 V and the maximum is 18 V. For complete voltage range information of the driver itself, refer to the device.




Figure 2-1. MSP-EXP430FR5969 LaunchPad connected to EVM

As previously mentioned, the MSP430 comes preprogrammed to control basic DC motor operation. If changing the firmware via the external eZ-FET<sup>™</sup> emulation tool, do not supply power to the VM connector on the EVM. The eZ-FET<sup>™</sup> board provides the necessary power during programming when connected to the J6 connector. Note that a four-pin angled male header is required and must be soldered to J21 of this Launchpad from V+ pin to GND pin shown in Figure 2-1. We recommend a pin header with pin dimensions similar to the Digikey part number 850-10-050-20-001000. The U1 MCU must be removed from the Launchpad.

# 4 MODE/nSLEEP Jumper and Speed-Adjustment Potentiometers

The MODE/nSLEEP header (J2) and jumper allow the user to set the state of the MODE pin or nSLEEP pin depending on the device populated on the EVM. If the DRV821xDSG is populated, J2 allows the user to select from the input modes of PWM (GND), PH/EN (3.3 V), and independent half-bridge control (Hi-Z).

If the DRV821xPDSG is populated, J2 allow the user to set the device to a low-power sleep mode (GND) or to enable the device (3.3V). MODE is only applicable to the DRV821xDSG and DRV8220DSG. The inputs to the DRV821xDSG are EN/IN1 and PH/IN2. The functions of these inputs are IN1 and IN2 when the MODE is GND (PWM mode) or Hi-Z (independent half-bridge mode). When MODE is connected to 3.3 V (PH/EN control mode) the input function is a phase/enable (PH/EN) interface.

The MSP430 produces PWM signals for the EN/IN1 and PH/IN2 pins with duty cycles proportional to the voltage from the PWM potentiometers. The tables below show how to configure the potentiometers for each MODE configuration.





Figure 4-1. MODE /nSLEEP header and PWM Potentiometers



# 4.1 PH/EN Control Mode (MODE=Logic High)

When the MODE /nSLEEP pin is logic high on power up, the device latches into PH/EN mode (Figure 4-2). PH/EN control mode is only supported by the DRV821xDSG devices. PH/EN mode allows for the H-bridge to be controlled with a speed and direction type of interface. The truth table for PH/EN mode is shown in (Table 4-1). This method is best for bidirectional driving for one motor.



### Figure 4-2. MODE /nSLEEP jumper configuration for PH/EN



# 4.2 PWM Control Mode (MODE = Logic High, DRL, PDSG)

When the MODE pin is logic high on power up, the device latches into PWM mode (Figure 4-3). PWM is the standard control mode for the DRV82xxDRL and DRV82xxPDSG devices. PWM mode allows for the H-bridge to enter the Hi-Z state without taking the nSLEEP pin logic low. The truth table for PWM mode for the DSG variants is shown in Table 4-2 and for the PDSG variants in Table 4-3. This method is best for bidirectional driving for one motor.



# 4.3 Independent Half-Bridge Control Mode (MODE=Hi-Z)

When the MODE pin is Hi-Z on power up, the device is latched into independent half-bridge control mode. Independent half bridge control is only supported by the DRV821xDSG devices. This mode allows for each halfbridge to be directly controlled in order to support high-side slow decay or driving two independent loads. The truth table for independent half-bridge mode is shown in Table 4-4.

# **5 Current Sensing**




Figure 5-1. Current Sensing Schematic

The DRV821x/8220EVM comes with current sensing circuitry consisting of a low-side sense resistor and a current sensing amplifier. The current sensing capabilities can only be used with the DSG/PDSG devices. Figure 5-1 show the schematic for the current sensing circuity. The components enclosed by the red rectangles are the current sensing components. The sense resistor (R20) is connected between the GND pin of the device to the larger GND plane of the EVM. R20 is populated with a 0 $\Omega$  resistor on the EVM but can be replaced with another resistor value if the user desires to use it for current sensing. C11 is used for filtering noise at the GND pin of the device and is not populated on the EVM.

The user needs to populate C11 with a desired value. The current sense amplifier and the surrounding components (R17, R18, and C6) are not populated on the EVM. The user needs to populate the amplifier and the surrounding components to use the current sensing capabilities. The current sense amplifier is the TLV9051IDRL which can be ordered here. R17 and R18 set the closed loop gain of the amplifier and have to be chosen by the user.

The output of the current sense amplifier (AMP\_OUT) can be measured at the "ISENSE" pin on header J4. AMP\_OUT is connected to an ADC pin on the MCU to monitor the current and to create current sensing algorithms.

# 6 Operation of the EVM

# 6.1 Dual Motor Operation

This mode allows for up to two motors to be controlled independently. The DRV821xDSG are the only devices that can support dual motor operation.

Use the following steps to operate the EVM with up to two loads with single direction speed control:

- 1. Make sure only one driver is populated and no power is being supplied to the EVM.
- 2. Connect a DC motor across OUT1 and GND. If desired, connect an additional DC motor across OUT2 and GND. See Figure 6-2 below for a diagram.
- 3. Adjust the potentiometer, EN/IN1 PWM and PH/IN2 PWM, to minimum voltage by turning the wheel counterclockwise all the way. This minimizes the motor speed of the motor connected across OUT1. If using a second motor, perform this process with potentiometer IN2 PWM as well.
- 4. Remove the jumper from the MODE/nSLEEP header (J2) so the MODE pin is Hi-Z.
- 5. Apply power to J1 header.
- 6. Turn potentiometer, EN/IN1 PWM, clockwise and the motor connected across OUT1 will begin to turn. Continue adjusting, as desired, until the maximum speed is reached. If using a second motor perform this process with potentiometer PH/IN2 PWM as well.
- 7. The direction of the motor turning can be reversed by removing the connection from GND to the motor and connecting the motor to VM. If this is done, the potentiometer associated with controlling the motor will operate in reverse and thus should be turned all the way clockwise before powering on the board and then slowly turned counter-clockwise to speed up the motor.

Use the following steps to operate the EVM with outputs paralleled to decrease the overall RDS(on) by half and accommodate larger current requirements:

- 1. Make sure only one driver is populated and no power is being supplied to the EVM.





Figure 6-1. EN/IN1 and PH/IN2 pins shorted

- 2. Short EN/IN1 and PH/IN2 pins on J4 with a jumper. See Figure 6-1.




Figure 6-3. Half-bridge mode used as a high-side driver with outputs paralleled






Figure 6-4. Half-bridge mode used as a low-side driver with outputs paralleled

- 3. Short OUT1 and OUT2 at connector J3 with an unexposed small wire or short the OUT1 and OUT2 test points with a small cable with clips. Make sure the wire is low resistance and can support at minimum 4-A continous peak current. Connect one end of the motor or desired load on either OUT1 or OUT2 on connector J3 and the other end on either VM (for low-side driving) or GND (for high-side driving). See Figure 6-3 and Figure 6-4 for a block diagram.
- 4. Adjust the potentiometer, EN/IN1 PWM and PH/IN2 PWM, to minimum voltage by turning the wheel all the way counter-clockwise (if one end of the motor is connected to GND) or clockwise (if one end of the motor is connected to VCC). This minimizes the speed of the motor connected across OUT1 and OUT2.
- 5. Remove the jumper from the MODE/nSLEEP header (J2) so the MODE pin is Hi-Z.
- 6. Apply power to J1 header.
- 7. Turn potentiometer, EN/IN1 PWM, clockwise and the motor connected across OUT1 will begin to turn. Continue adjusting, as desired, until the maximum speed is reached. Make sure to not move PH/IN2 PWM potentiometer.
- 8. The direction of the motor turning can reversed by removing the connection from GND to the motor and connecting the motor to VM and vice-versa. If this is done, the potentiometer associated with controlling the motor will operate in reverse and thus should be turned all the way clockwise (if motor originally connected to GND) or counter-clockwise (if motor originally connected to VCC) before powering on the board and then slowly turning the EN/IN1 PWM potentiometer in the opposite direction to increase the motor speed.

### 6.2 Single Motor Operation

This mode allows for bidirectional control of one motor. Connect a DC motor across OUT1 and OUT2. Reversing direction is controlled by the potentiometer. This is described in detail in Section 4. Use the following steps to operate the EVM with a signal motor and bidirectional speed control:

- 1. Make sure only one driver is populated and no power is being supplied to the EVM.




Figure 6-5. DRV821xDSG PWM single motor operation

- 2. Connect a motor across OUT1 and OUT2. See Figure 6-5 for a block diagram of the DRV821xDSG.
- 3. If the DRV821xDSG is populated on the EVM, use a jumper to connect the MODE/nSLEEP header (J2) to 3.3 V or GND to set the input mode to PWM control mode or PH/EN mode respectively.
- 4. If the DRV8220DSG is populated on the EVM, use a jumper to connect the MODE/nSLEEP header (J2) to 3.3 V or GND to set the input mode to PWM control mode or PH/EN mode respectively. Also connect VCC\_DRV (J7) to 3.3V via a jumper to enable the device.
- If the DRV821xPDSG is populated, connect the MODE/nSLEEP header to 3.3V to set nSLEEP logic high and enable the device (The MODE pin becomes the nSLEEP pin for the PDSG devices). The DRV821xPDSG only supports PWM control mode.
- 6. If a DRV82xxDRL is populated, the state of the MODE/nSLEEP jumper is ignored and the control mode is set to PWM by default. The DRL devices only support PWM control mode.
- 7. Adjust the potentiometer, EN/IN1 PWM and PH/IN2 PWM, to minimum voltage by turning the wheel counterclockwise all the way. This minimizes the speed of the motor connected across OUT1 and OUT2.
- 8. Apply power to J1 header.
- 9. Turn potentiometer, EN/IN1 PWM, clockwise and the motor connected across OUT1 and OUT2 will begin to turn. Continue adjusting, as desired, until the maximum speed is reached.
- 10.Control the motor direction and speed by adjusting the potentiometers according to the tables in Section 4.

# 7 Removing and Installing Supported Motor Drivers

The EVM can support the DRV8210/8212/8220DSG, DRV8210/8212PDSG, and DRV8210/8212/8220DRL devices. The EVM contains two footprints that can support the devices listed above. Footprint U2 supports the DSG and PDSG devices and footprint U5 supports the DRL devices. U2 and U5 share the same output connector so only one of the two footprints should be populated at any time. Below are step-by-step instructions on how to remove and place different drivers on the EVM:

- 1. Disconnect power from the EVM.
- 2. Carefully de-solder the device from the PCB. Make sure to follow proper soldering and ESD protection procedures to prevent damage to the EVM.
- 3. Carefully solder the new device to the EVM. See Table 7-1 for further instructions. Visit ti.com or any authorized third party vendor to purchase the desired driver.




Figure 7-1. Device ID Resistors

- 4. The EVM uses a combination of resistors to identify the device that is populated on the board. Figure 7-1 show the resistors used for device identification. The MCU reads the values of ID1, ID2, and ID3 to determine the device that is installed on the EVM. The firmware will function slightly different depending on the device that is on the board. Each of the supported devices have unique values for ID1, ID2, and ID3 which are set by R5, R7, R8, R9, R13, and R14. After installing the new device, make sure to populate the appropriate resistors. Table 7-2 show the unique device ID for each supported device and the resistor combination to populate.
