

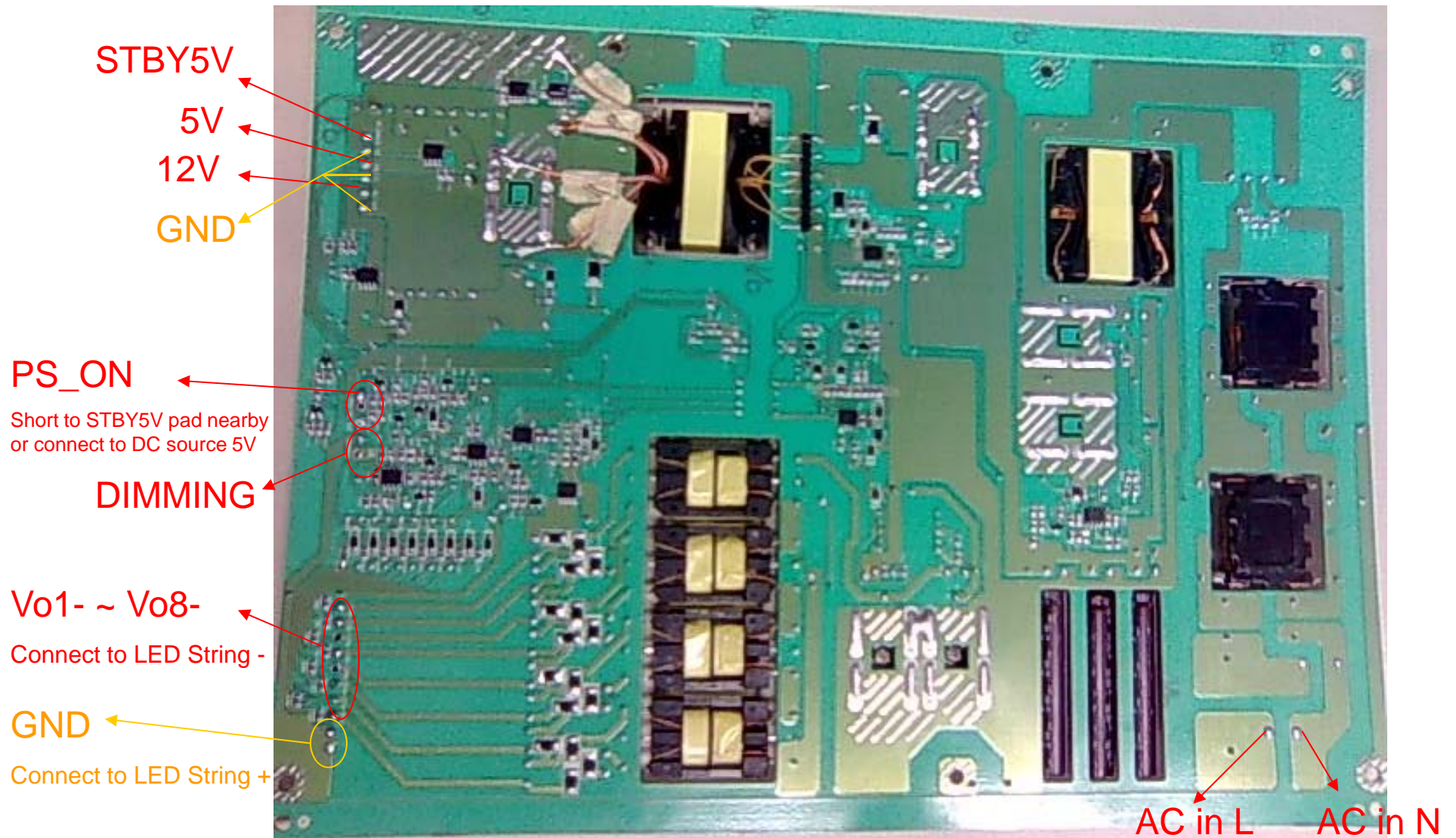
# **Multi-Transformer LED TV Power User Guide**

# Operation Range

- Input Range: 90Vac~264Vac 47Hz~63Hz
- Dimming Range: Reverse Signal 0V ~ 5V  
100Hz ~200Hz 1%~100%
- Output Range :STBY-5V 20mA~1A  
5V 0.5A~4A  
12V 0.1A~3A  
LED 8 String 120mA 70V~88V

# Load and Signal Connection



# Turn On Procedure

- Connect STBY 5V, 5V and 12V to load and **set to minima load**
- Connect LED string to LED output
- Connect dimming signal to dimming pad
- Connect power code to Input pad
- For STBY mode leave PS\_ON pad connect to nothing
- For normal mode PS\_ON pad connect to STBY pad nearby
- Turn AC input on
- 5V and 12V can only be full load after PFC is on

# Turn off Procedure

- Keep load on output
- Turn AC input off
- Load can discharge primary buck cap
- Do not touch board before STBY 5V is decreased to almost 0V

# Notice

- 5V/12V minima load is required when PS\_ON is high or normal mode because without minima load primary Vcc for UCC28051 and UCC25600 would be too low.
- 5V/12V can only add load to more than minima load when PFC is on.
- Do not touch the board before buck cap is discharged.
