TPS51386 Step-Down Converter Evaluation Module



ABSTRACT

This user's guide describes the characteristics, operation, and use of the Texas Instruments TPS51386 evaluation module (EVM). The TPS51386EVM is designed to help user easily evaluate and test the operation and functionality of the TPS51386. This user's guide includes the following:

1 Introduction

The TPS51386 is a single, D-CAP3[™] control mode, synchronous buck converter requiring a very low external component count. The TPS51386 provides an adjustable 0.6-V to 5.5-V, 8-A maximum output. Integrated low $R_{DS(ON)}$ power MOSFETs enable high efficiency and offer ease of use with a minimal external component count for space-constrained power systems. Features include the following:

- Accurate reference voltage
- · Fast load transient response
- · Auto-skip mode operation for light load efficiency
- OOA light load operation with > 25-kHz switching frequency
- D-CAP3 control mode with good line, load regulation, and no requirement for external compensation

The TPS51386 evaluation module (EVM) is a single, synchronous buck converter providing 5.1 V at 8 A from a 6-V to 24-V input. This user's guide describes the TPS51386EVM performance.

3 Output Voltage Setpoint

To change the output voltage of the EVM, change the value of resistor R4 (R_{upper}) and R6 (R_{lower}). The value of R4 and R6 for a specific output voltage can be calculated using Equation 1.

$$V_{OUT} = 0.6 \times (1 + \frac{R_{UPPER}}{R_{LOWER}})$$

4 Test Setup and Results

This section describes how to properly connect, set up, and use the TPS51386EVM. The section also includes test results typical for the evaluation modules.

4.1 Input and Output Connections

The TPS51386EVM is provided with input and output connectors and test points as shown in Table 4-1. Connect a power supply capable of supplying 8 A to J1 through a pair of 20AWG wires. The load must be connected to J2 through a pair of 20AWG wires. The maximum load current capability is 8 A. Minimize wire lengths to reduce losses in the wires. Test point TP2 provides a place to monitor the V_{IN} input voltages with TP9 providing a convenient ground reference. TP5 is used to monitor the output voltage with TP12 as the ground reference.

4.2 Start-Up Procedure

TP19

1. Make sure that the jumper at JP2 (Enable High Control) is covered to connect VIN to pin 1 of JP3. Also make sure JP3 (Enable Control) pin 2 and 3 are covered to shunt EN to GND to disable the output.

GND monitor point

- 2. Apply appropriate input voltage to VIN (J1-1) or TP1 and GND (J1-2) or TP8. Note that the board cannot support hot plug-in. The input lines must be connected between J1 and an external power source first before turning on the power source.
- 3. Move the jumper at JP3 (Enable Control) from pin 2 and 3 (EN and OFF) to pin 2 and 1 (EN and ON) and make sure JP2 pin 1 and pin 2 are covered. Then, the output can be enabled.
- 4. Apply the loading to VOUT (J2-2) or TP4 and GND (J2-1) or TP10.




Figure 4-1. Start-Up Relative to EN, I_{OUT} = 0.1 A




Figure 4-2. Start-Up Relative to EN, I_{OUT} = 8 A




Figure 4-3. Shutdown Relative to EN, $I_{OUT} = 0.1 A$




Figure 4-4. Shutdown Relative to EN, $I_{OUT} = 8 A$




Figure 4-5. TPS51386EVM Output Voltage Ripple, I_{OUT} = 10 mA, PSM Mode




Figure 4-6. TPS51386EVM Output Voltage Ripple, I_{OUT} = 10 mA, OOA Mode




Figure 4-7. TPS51386EVM Output Voltage Ripple, $I_{OUT} = 8 A$

5 Board Layout

This section provides a description of the TPS51386EVM, board layout, and layer illustrations.

5.1 Layout

The following figures show the board layout for the TPS51386EVM. TPS51386EVM is with four layers. The top layer contains the main power traces for VIN, VOUT, and GND. Also on the top layer are connections for the pins of the TPS51386 and a large area filled with ground. Most of the signal traces are also located on the top side. The input decoupling capacitors, C3, C4, C5, and C6 are located as close to VIN pins and PGND pins of the IC as possible. The input and output connectors, test points, and all of the components are located on the top side. The bottom layer is a ground plane along with signal ground copper fill and the feedback trace from the point of regulation to the top of the resistor divider network. Two inner layers are ground plane.




Figure 5-1. Top Assembly




Figure 5-2. Top Layer




Figure 5-3. Inner1 Layer




Figure 5-4. Inner2 Layer




Figure 5-5. Bottom Layer




Figure 6-1. Top View of TPS51386EVM




Figure 6-3. TPS51386EVM Schematic Diagram
