1 Introduction

In light-load conditions, the TPS563203 operates in eco-mode to enable higher efficiency by varying the switching frequency, the TPS563206 operates in FCCM to maintain constant switching frequency. The main difference is at light loading, but the other behaviors are similar. This user's guide mainly introduces the TPS563203 and includes some TPS563206 features that are different from the TPS563203.

The TPS56320x is a single, adaptive on-time, D-CAP3[™] control mode, synchronous buck converter that requires a very low external component count. The D-CAP3 control mode circuit is optimized for low-ESR output capacitors such as POSCAP, SP-CAP, or ceramic types and features fast transient response with no external compensation. The switching frequency is internally set at a nominal 600 KHz. The high-side and low-side switching MOSFETs are incorporated inside the TPS56320x package along with the gate-drive circuitry. The low drain-to-source on resistance of the MOSFETs and fast switching slew rate allow the TPS56320x to achieve high efficiency and help keep the junction temperature low at high output currents. The TPS56320x DC/DC synchronous converter is designed to support up to a 3-A continuous current from an input voltage source of 4.2 V to 17 V. The output voltage range is from 0.6 V to 7 V. Rated input voltage and output current ranges for the evaluation module are given in Table 1-1.

The TPS56320xEVM evaluation module (EVM) is a single, synchronous buck converter providing 1.05 V at 3 A from 4.2-V to 17-V input. This user's guide describes the TPS56320xEVM performance.

2 Performance Specification Summary

A summary of the TPS563203EVM performance specifications is provided in Table 2-1. Specifications are given for an input voltage of V_{IN} = 12 V and an output voltage of 1.05 V, unless otherwise noted. The ambient temperature is 25°C for all measurement, unless otherwise noted.

3 Output Voltage Setpoint

The output voltage of the EVM can be selected by changing the value of resistor R_4 (R_{UPPER}) and R_6 (R_{LOWER}). The value of R_4 for a specific output voltage can be calculated using Equation 1. The output voltage is set with a resistor divider from the output node to the FB pin. TI recommends using 1% tolerance or better divider resistors. Start with a 10 k Ω or 30 k Ω for R6 (R_{FBB}) and use Equation 1 to calculate R4 (R_{FBT}). To improve efficiency at light loads, consider using larger value resistors. If the values are too high, the regulator is more susceptible to noise and voltage errors from the FB input current are noticeable.

4.1 Input, Output Connections




Figure 4-1. TPS563203EVM Connectors and Jumpers Placement

The TPS563203EVM is provided with input, output connectors and test points as shown in Table 4-1. Figure 4-1 shows connectors and jumpers placement on TPS563203EVM board.

A power supply capable of supplying 3 A must be connected to J1 through a pair of 20-AWG wires. The load must be connected to J2 through a pair of 20-AWG wires. The maximum load current capability is 3 A. Wire lengths must be minimized to reduce losses in the wires. Test point TP2 provides a place to monitor the V_{IN} input voltages with TP6 providing a convenient ground reference. TP3 is used to monitor the output voltage with TP10 as the ground reference.

4.2 Start-Up Procedure

- 1. Verify that the jumper at JP1 (Enable control) pins 1 and 2 are covered to shunt EN to GND, disabling the output.
- 2. Apply appropriate input voltage to VIN (J1-2) and GND (J1-1).
- 3. Move the jumper at JP1 (Enable control) pin 2 and 1 (EN and GND) to enable the output.

4.3 Efficiency




Figure 4-2. TPS563203EVM Efficiency




Figure 4-3. TPS563206EVM Efficiency




Figure 4-4. TPS563203EVM Load Regulation




Figure 4-5. TPS563206EVM Load Regulation




Figure 4-6. TPS563203EVM Line Regulation




Figure 4-7. TPS563206EVM Line Regulation




Figure 4-8. TPS563203EVM Load Transient Response, 10% to 90% (0.3 A to 2.7 A) Load Step




Figure 4-9. TPS563206EVM Load Transient Response, 10% to 90% (0.3 A to 2.7 A) Load Step




Figure 4-10. TPS563203EVM Start-Up Relative to V_{IN}




Figure 4-11. TPS563206EVM Start-Up Relative to EN




Figure 4-12. TPS563203EVM Shutdown Relative to V_{IN}




Figure 4-13. TPS563206EVM Shutdown Relative to EN




Figure 4-14. TPS563203EVM Output Voltage Ripple, $I_{OUT} = 3 A$




Figure 4-15. TPS563203EVM Output Voltage Ripple, I_{OUT} = 0.01 A




Figure 4-16. TPS563206EVM Output Voltage Ripple, I_{OUT} = 0.01 A

5 Board Layout

This section provides a description of the TPS56320XEVM, board layout, and layer illustrations.

5.1 Layout

Figure 5-1, Figure 5-2, and Figure 5-3 show the board layout for the TPS563203EVM. The top layer contains the main power traces for VIN, VOUT, and ground. Connections for the pins of the TPS563203 and a large area filled with ground are also on the top layer. Most of the signal traces are also located on the top side. The input decoupling capacitors C2, C3, and C4 are located as close to the IC as possible. The input and output connectors, test points, and all of the components are located on the top side. The bottom layer is a ground plane along with the signal ground copper fill and the feedback trace from the point of regulation to the top of the resistor divider network. Both the top layer and bottom layer use 2-oz copper thickness.

Figure 5-4 and Figure 5-5 are the TPS563203EVM board top view and bottom view, respectively.




Figure 5-1. TPS563203EVM Top Assembly




Figure 5-2. TPS563203EVM Top Layer




Figure 5-3. TPS563203EVM Bottom Layer




Figure 5-4. TPS563203EVM Board (Top View)




Figure 5-5. TPS563203EVM Board (Bottom View)




Figure 6-1. TPS563203EVM Schematic Diagram
