## Description


The LM74930-Q1 Evaluation Module (LM74930Q1EVM) helps designers evaluate the operation and performance of the LM74930-Q1 ideal diode controller with power path ON/OFF control, overcurrent, short-circuit and overvoltage protection. The wide input supply of LM74930-Q1, 4V to 65V, allows protection and control of 12-V and 24-V automotive battery powered ECUs. The LM74930-Q1 can drive back-to-back external N-Channel MOSFETs connected in common source topology to realize surge stopper functionality. With first MOSFET in the power path, the device allows load disconnect (ON/OFF control) in case of overcurrent and surge/overvoltage events using HGATE control. An integrated ideal diode controller (DGATE) drives the second MOSFET to replace a Schottky diode for reverse input protection and output voltage holdup.

# **1 Evaluation Module Overview**

## 1.1 Introduction

This user's guide describes the LM74930Q1EVM evaluation module for evaluating the performance of the LM74930-Q1 ideal diode controller devices. The LM74930-Q1 ideal diode controller drives and controls external back to back N-Channel MOSFETs to emulate an ideal diode rectifier with power path ON/OFF control, as well as overcurrent, short-circuit, and overvoltage protection. This document provides EVM configuration information and test setup details for evaluating the LM74930-Q1 device. The EVM schematic, board layout, and bill of materials (BOM) are also included.

### **1.4 Device Information**

LM74930-Q1 is an ideal diode with surge stopper, circuit breaker, overvoltage protection and fault output. The LM74930-Q1 ideal diode controller drives and controls external back to back N-Channel MOSFETs to emulate an ideal diode rectifier with power path ON/OFF control with overcurrent and overvoltage protection. The wide input supply of 3 V to 65 V allows protection and control of 12-V and 24-V automotive battery powered ECUs. The device can withstand and protect the loads from negative supply voltages down to -65 V.

# 2 Hardware

## 2.1 Test Points and Connectors

Table 2-1 lists the LM74930Q1EVM evaluation board input and output connector functionality. Table 2-2 and Table 2-3 describe the test point availability and the jumper functionality.

### 2.2 Test Equipment and Setup

#### 2.2.1 Power Supplies

One adjustable power supply with 0-V to 60-V output and 0-A to 10-A output current limit.

#### 2.2.2 Meters

One DMM minimum needed.

#### 2.2.3 Oscilloscope

A DPO2024 or equivalent, 3 × 10 voltage probes, and a DC current probe.

#### 2.2.4 Loads

One resistive load or equivalent that can tolerate up to 50-A DC load at 60 V and capable of the output short.

### 2.3 Test Setup and Procedures

Make sure the evaluation board has default jumper settings as shown in Table 2-4.




Figure 2-1. LM74930Q1EVM Setup With Test Equipment

Use the following instructions before starting any test and repeat again before moving to next test.

- 1. Set the power supply output VIN to 0 V.
- 2. Turn ON the power supply and set the power supply output VIN to 12 V and current limit of 10 A.
- 3. Turn OFF the power supply.
- 4. Set the jumper setting on EVM to default position as shown in Table 2-4.

#### 2.3.1 Power-up and Power-down with Input Voltage

Use the following instructions to capture the precharging current profile.

- 1. Set the input supply voltage VIN to 12 V and current limit of 10 A.
- 2. Verify that the J5 jumper setting is set to 1-2.
- 3. Turn ON the input power supply.
- 4. Observe the start-up profile of charge pump voltage V<sub>CAP</sub>, HGATE, DGATE and output voltage.
- 5. Turn OFF the input power supply.
- 6. Observe the shutdown profile of charge pump voltage ( $V_{CAP} V_{VS}$ ), output voltage, HGATE, and DGATE.




Figure 2-2. LM74930-Q1 Start-Up With VIN - HGATE, DGATE and VOUT

Figure 2-2 shows an example of power-up with EN profile captured on the LM74930Q1EVM evaluation board.




Figure 2-3. LM74930-Q1 Start-Up With VIN - VS, CAP and HGATE



#### 2.3.2 Unsuppressed Load Dump 200 V - Output Clamp

Use the following instructions to verify the overvoltage protection feature of LM74930-Q1.

- 1. To test 200 V Unsuppressed Load Dump, the LD200N or similar equipment is needed as the input power supply.
- 2. Make sure the J8 jumper setting is set to 2-3.
- 3. Set the input supply voltage VIN to 24 V and current limit of 5 A.
- 4. Turn ON the power supply and observe start-up of output voltage.
- 5. Now apply 200 V Unsuppressed Load Dump using LD200N equipment.
- 6. Observe OVCLAMP operation of LM74930-Q1 when input voltage is above OV threshold.




Figure 2-4. Unsuppressed Load Dump 200 V - Output Clamp (OVCLAMP = GND)



## 2.3.3 Overcurrent Protection Test

Use the following instructions to perform the overcurrent test on the LM74930Q1EVM.

- 1. Set the input supply voltage VIN to 12 V and current limit of 10 A.
- 2. Turn ON the power supply and observe start-up of output voltage, HGATE, and DGATE.
- 3. By default the EVM is configured for 4-A overcurrent protection.
- 4. Apply 4-A load at the output with rheostat or electronic load and gradually increase the load current to 6 A.
- 5. Observe the overload behavior of LM74930-Q1.




Figure 2-5. Overcurrent Response of LM74930-Q1 for a Load Step From 3.8 A to 6 A With 4-A Overcurrent Protection Setting






Figure 2-6. Auto-Retry Response of LM74930-Q1 for an Overcurrent Fault

Figure 2-5 and Figure 2-6 show test waveforms for an overcurrent fault.

### 2.3.4 Output Hot-Short Test

Use the following instructions to perform output the hot-short test.

- 1. Set the input supply voltage VIN to 12 V and current limit of 10 A.
- 2. Turn ON the power supply and observe start-up of output voltage, HGATE, and DGATE.
- 3. Short the output to GND. That is, VOUT to GND with a cable and observe the short-circuit response of LM74930-Q1 using an oscilloscope.





Figure 2-7. Output Hot-Short Response of LM74930-Q1 Device

Figure 2-7 shows hot-short response of LM74930-Q1 on LM74930Q1EVM evaluation board.






Figure 3-2. LM74930Q1EVM Board Top Overlay




Figure 3-4. LM74930Q1EVM Board Top Layer




Figure 3-3. LM74930Q1EVM Board Bottom Overlay




Figure 3-5. LM74930Q1EVM Board Bottom Layer




Figure 3-6. LM74930Q1EVM Board Inner Layer 1




Figure 3-7. LM74930Q1EVM Board Inner Layer 2
