The TPS23881B1EVM features the 8-channel, TPS23881B1 and IEEE 802.3bt compliant PoE PSE controller. The EVM consists of a motherboard (BOOST-PSEMTHR-007) and a daughterboard (TPS23881B1EVM-024) containing one TPS23881B1 device. The TPS23881B1EVM provides a multi-port base platform interface for TPS23881B1EVM-024, MSP-EXP430FR5969 (LaunchPad™), and USB2ANY (USB Interface Adapter).



1 Evaluation Module Overview

1.1 Introduction

This user's guide describes the evaluation modules (EVM) for the TPS23881B1 (TPS23881B1EVM-024 and BOOST-PSEMTHR-007). The EVM contains evaluation and reference circuitry for the TPS23881B1. The TPS23881B1 is a Power-over-Ethernet (PoE) device for power sourcing equipment (PSE).




Figure 1-1. TPS23881B1 Device Block Diagram

1.4 Device Information

The TPS23881B is an 8-channel power sourcing equipment (PSE) controller engineered to insert power onto Ethernet cables in accordance with the IEEE 802.3bt standard. The eight individual power channels can be configured in any combination of 2-Pair (1-channel) or 4-Pair (2-channels) PoE Ports. The PSE controller can detect powered devices (PDs) that have a valid signature, complete mutual identification, and apply power.

The TPS23881B improves on the TPS2388 with reduced current sense resistors, selectable autonomous operation, SRAM programmability, programmable power limiting, capacitance measurement, and compatibility with TI's FirmPSE system firmware. Programmable SRAM enables in-field firmware upgradability over I2C to verify IEEE compliance and interoperability with the latest PoE enabled devices. Dedicated per port ADCs provide continuous port current monitoring and the ability to perform parallel classification measurements for faster port turn on times. A ±2.5% accurate programmable port power limit provides the ability to expand the maximum power sourced from 90W to upwards of 125W.

The $200m\Omega$ current sense resistor and external FET architecture allow designs to balance size, efficiency, thermal and design cost requirements.

2.5 Quick Start

2.5.1 Input Power

2.5.1.1 Input Power (Labeled VPWR)

The DC input voltage is provided through J1 (screw jack). A DC power supply or wall adapter with sufficient current capacity can power the EVM.

CAUTION

Reverse voltage protection is not provided; make sure that the correct polarity is applied to J1.

This DC input is labeled *VPWR* in the schematics and is used for port VBUS as well as for the TPS23881B1 devices. The VPWR connections to the PoE ports are not fused. Each two-pair port is capable of furnishing at least 30 W and each four-pair port can furnish 90 W.

The minimum PSE port voltage is 44 VDC for type 1, 50V for type 2 and type 3, and 52V for type 4. During evaluation, choose the appropriate DC power supply for different environments.

2.5.1.2 Local 3.3V (Labeled 3.3V)

Local 3.3V for local devices (labeled as 3.3V) is provided by the onboard LM5019 buck converter. The LM5019 provides a basic power-on sequence and provides a well-controlled and consistent start-up. In addition to 54V, the TPS23881B1 requires 3.3V for the digital circuitry and this is routed up to TPS23881B1EVM-024 over the connector interface. The current consumption is 6mA typical and 12mA maximum.

2.5.1.3 External 3.3V (Labeled 3.3 V_USB)

The BOOST-PSEMTHR-007 provides galvanic isolation between the PoE power side and host side using digital isolators (ISO7241CD). The host side power is provided either from J2 (from USB2ANY) or J5 (from MSP-EXP430FR5969).

CAUTION

Do not use USB2ANY and LaunchPad simultaneously.

2.5.2 PoE Port Interfaces

The TPS23881B1 device must be configured through the host to become operational if the device is not configured to autonomous mode (described in section 2.4). This EVM provides two ways to control the TPS23881B1: TPS238x EVM GUI (with USB2ANY) and MSP-EXP430FR5969 LaunchPad.

2.5.2.1 IEEE802.3bt 2-Pair Ports

Four 2-pair ports are provided at J19, J20, J8, and J7 for 2-pair ports 1, 2, 3, and 4, respectively. The power furnished is according to alternative A with MDI-X polarity.

2.5.2.2 IEEE802.3bt 4-Pair Ports

Two 4-pair high power ports are provided at J21 and J9 for 4-pair ports 1 and 2, respectively. The power furnished is according to alternative A with MDI-X polarity and alternative B with S polarity on a single port connector. A single- or dual-signature PD can be powered by the 4-pair ports with proper port configuration (enabling 4-pair mode).

2.5.3 I²C Interfaces

Two I²C interfaces to the TPS23881B1 are provided on the EVM.

2.5.3.1 USB2ANY

J2 provides an interface with the USB2ANY adapter when using a PC and GUI.

2.5.3.2 MSP-EXP430FR5969

J3, J4, and J5 provide an interface with the MSP-EXP430FR5969 when using a PC to develop custom system software.

2.5.4 Basic Test Setup Using Autonomous Mode

The TPS23881B1 supports autonomous mode, which means The TPS23881B1 can operate without any host control. During power up the resistance on the AUTO pin is measured and the device is preconfigured according to the jumper configuration on J5 of the daughter board. All ports are configured with the same power level. Due to the hardware configuration on the mother board, only 2-pair ports are interoperable with PDs when auto pin resistor is set to 15W and 30W; only 4 pair ports are interoperable with PDs when auto pin resistor is set to >30W.

To test with autonomous mode, install a jumper on the pins of J5 corresponding to the desired power level and power on the board without the USB2ANY or MSP-EXP430FR5969 connected.

2.5.5 Basic Test Setup Using USB2ANY for I^2C Interface (Auto Mode or Semi-Auto Mode Operation with I^2C Monitoring)




Figure 2-1. Basic Setup Using USB2ANY

An I^2C interface is provided through J2 to the TPS23881B1 devices on the TPS23881B1EVM-024. The USB2ANY adapter (not included) can be used with any TI GUI which uses USB2ANY to read and write over an I^2C bus. Figure 2-1 illustrates the basic setup using USB2ANY.

CAUTION

If a jumper is installed on J5, DC power supply needs to be on before turning on TPS2388xEVM GUI and starting I2C communication.

2.5.6 Advanced Test Setup Using MSP-EX430FR5969 LaunchPad




Figure 2-2. Advanced Setup Using LaunchPad

The LaunchPad (not included) running a custom software program can communicate with the TPS23881B1 devices on the TPS23881B1EVM-024. Figure 2-2 shows the advanced setup using LaunchPad.

If a jumper is installed on J5, DC power supply needs to be on before connecting MSP430 LaunchPad to PC and starting I2C communication.

2.6 TPS23881B1 Autonomous Operations

The TPS23881B1 supports autonomous mode, which means the TPS23881B1 can operate in standalone mode without any host control. To enable this function, a pulldown resistor is needed on AUTO pin. During power up, the resistance on the AUTO pin is measured, and the device is preconfigured according to Table 2-6 and all ports are configured with the same power application.

If the AUTO pin resistor is selected for 2-pair operation, due to the hardware configuration on the mother board, only 2-pair ports (J19, J20, J8, J7) are interoperable with PDs. If AUTO pin resistor is selected for 4-pair operation, only 4-pair ports (J21,J9) are interoperable with PDs.

3 Software

3.1 TPS23881B1EVM GUI Setup

3.1.1 TPS23881B1EVM GUI Installation

TI's TPS23881B1EVM GUI is used with the TPS23881B1EVM to control the port and provide real-time feedback on port telemetry. Download the TPS23881B1EVM GUI from the TPS23881 product folder in the Software Development section.

Follow the onscreen instructions to complete the installation. The TPS23881B1 GUI uses the USB2ANY as an interface between the PC USB port and the BOOST-PSEMTHR-007 J2 connector (I2C interface). Before starting the TPS23881B1 GUI, make sure the USB2ANY is properly connected to TPS23881B1EVM and the EVM is supplied with a 44V to 57V power supply as shown in Figure 2-1.

3.1.2 TPS23881B1EVM GUI Operation




Figure 3-1. TPS23881B1EVM GUI Start-up Window

Start the TPS23881B1EVM GUI by double-clicking the GUI icon. A window similar to Figure 3-1 comes up.

The default device address in the GUI is set to 0x20 which matches the default configuration of the EVM (J4 on the daughter card is installed with jumpers). The GUI sets the TPS23881B1 in configuration B mode (see the GENERAL MASK Register section of the data sheet for details). The address can be programed through the A1 to A4 pins and the I2C address setting in the GUI needs to match the hardware configuration. See the *Pin Status Register* section of the data sheet for details. The *Startup* page contains links to the EVM user's guide, TPS23881B1 data sheet, E2E forum and MSP430 reference code. Four popular PD end-equipment images are connected to the PSE switch. Links to the recommended PD device for each end equipment are also provided.

The TPS23881B1 is intended to be operated without loading firmware. If the user wants to load different version of firmware, then click *Load Firmware* and choose SRAM code as desired.




Figure 3-2. TPS23881B1EVM GUI Load Firmware 1




Figure 3-3. TPS23881B1EVM GUI Load Firmware 2

Once firmware is successfully loaded and *Device Connected* displays and port configuration type is selected, click *Engineering View*.




Figure 3-4. Device Configuration and Port Telemetry Page

On the page displayed in Figure 3-4, each port can be configured separately by clicking each RJ45 connector. By default, the TPS23881B1 is configured in OFF Mode. Each port can be configured by clicking the RJ45 icon. Clicking the SET ALL PORTS TO STANDARD button sets all port to standard configurations (configuring ports in Semi-Auto mode, enabling OSS, power policing, and DC disconnect). Clicking the SET ALL PORTS TO AUTO MODE button enables Auto Mode for all ports.

The status of each port is shown on the configuration and telemetry page. The configuration of the ports can also be edited on this page by clicking the RJ45 connector.

If the port is configured in *Auto Mode*, then the port turns on automatically by the PSE device after connecting a valid PD. If not configured in *Auto Mode*, then a port enable command is required (*4P Enable* for 4 pair ports and *2P Enable* for 2-pair ports). The port can be turned on only when the PD has valid detection and classification results.




Figure 3-5. Register Map

3.1.3 MSP-EXP430FR5969 Details

The TPS23881B1EVM accepts the MSP-EXP430FR5969 evaluation module when the application requires management of the TPS23881B1 devices with an external controller.

- 1. Install MSP-EXP430FR5969 onto BOOST-PSEMTHR-007 and make sure that the USB2ANY ribbon cable is not installed into J2.
- 2. Connect the PC to the LaunchPad as shown in Figure 2-2.
- 3. The source code was developed for the MSP430 LaunchPad Development Kit (MSP-EXP430GFR5969) using the Code Composer Studio™ (CCS) version 7.2.0 development environment. The target MSP430 can be programmed within this environment.
- 4. Once CCS is installed, use the basic set of instructions listed in Section 3.1.3.1 to import, build, and run the project. CCS version 7.2.0 is used in the following examples. Note that a terminal program such as HyperTerminal or Teraterm is required to view the output from the EVM when running.

3.1.3.1 Basic CCS and Terminal Setup

Use the following steps for basic CCS and terminal setup:

- Launch the CCS program on the PC: Start → Texas Instruments → Code Composer Studio 7.2.0 → Code Composer Studio 7.2.0.
- 2. OK the workspace location and CCS starts.
- 3. Import the project: Project→ Import CCS Projects (make sure you are in CCS Edit mode).
- 4. Navigate to the project location, then click the *Finish* button.
- 5. Build the project by clicking the hammer symbol.
- 6. Launch the debug session from CCS to activate the current project: Run, Debug (or F11).
- 7. Run the active project: Run, Resume (or play button, F8).
- 8. Determine the PC COM port connected to the LaunchPad by going into the *Device Manager Ports* (COM and LPT) section. Launch the terminal program.
- 9. Once the terminal program is properly connected to the LaunchPad running the PoE firmware, then text similar to the following image appears.




Figure 3-6. Program Started




Figure 3-7. Terminal Response With Connected Ports

10. The TPS23881B1EVM is now waiting for a PD load to be installed. As ports are installed, the system automatically detects, classifies, and powers up the port as shown in Figure 3-7. Port status is updated on the screen approximately every 10 seconds.

3.1.4 MSP430 Reference Code

3.1.4.1 Overview

There are two versions of MSP430 reference code published on ti.com. One is for basic applications and the other is focused on multi-port power management applications. The reference code for multi-port power management applications is discussed in detail since the code has more flexibility and complexity.

The system software supports the following features:

- IEEE802.3bt PoE specification
- · Device detection, connection check, and classification
- Automatic power on (standard 2-pair and 4-pair PDs)
- DC disconnect
- · Port telemetry updates
- · Multi-port power management

The MSP430 communicates with the PC through UART, reporting the parameter and status of the port.

3.1.4.2 Auto Mode




Figure 3-8. Auto Mode System Software Structure

Auto mode operation is demonstrated in the MSP430 reference code and Figure 3-8 shows the flow chart. Basically, after configuration, the TPS23881B1 handles port detection, classification, turn on, and faults and there is no control needed from the host.

3.1.4.3 Semi Auto Mode




Figure 3-9. Semi Auto Mode System Software Structure

Operation, the semi auto mode reference code is interrupt based. When MSP430 receives an interrupt from the INT pin of the PSE, the code checks interrupt the register and event registers to proceed with actions accordingly. The flowchart of semi auto mode code is shown in Figure 3-9.




Figure 4-1. BOOST-PSEMTHR-007 (Motherboard) Schematic: Control




Figure 4-2. BOOST-PSEMTHR-007 (Motherboard) Schematic: Power Ports






Figure 4-3. TPS23881B1EVM-024 (Daughterboard) Schematic




Figure 4-4. BOOST-PSEMTHR-007 (Motherboard) Top Side Assembly




Figure 4-5. BOOST-PSEMTHR-007 (Motherboard) Top Side Routing






Figure 4-6. BOOST-PSEMTHR-007 (Motherboard) Layer 2 Routing




Figure 4-7. BOOST-PSEMTHR-007 (Motherboard) Layer 3 Routing




Figure 4-8. BOOST-PSEMTHR-007 (Motherboard) Bottom Side Routing




Figure 4-9. TPS23881B1EVM-024 (Daughterboard) Top Side Assembly




Figure 4-10. TPS23881B1EVM-024 (Daughterboard) Top Side Routing






Figure 4-11. TPS23881B1EVM-024 (Daughterboard) Bottom Side Routing




Figure 4-12. TPS23881B1EVM-024 (Daughterboard) Bottom Side Assembly

TPS23881B1EVM-024 Rev B does not have a 10nF capacitor on AUTO. This will be added to Rev C.

4.2.1 Layout Guidelines

4.2.1.1 Supply Voltage Decoupling

Provide power supply pin bypass to the TPS23881B1 device as follows:

- 0.1µF, 100V, X7R ceramic at pin 28 (VPWR)
- 0.1µF, 50V, X7R ceramic at pin 1 (VDD)

4.2.1.2 Port Current Kelvin Sensing

KSENSA is shared between SEN1 and SEN2, while KSENSB is shared between SEN3 and SEN4. To optimize the accuracy of the measurement, the PCB layout must be done carefully to minimize the impact of PCB trace resistance. Refer to Figure 4-10 as an example.

4.2.1.3 Ground Plane Spacing and Isolation (GND, GND1, and EARTH Nets)

Appropriate spacing must be provided between the GND, GND1, and EARTH nets as shown in Figure 4-6.
