# LMX8410LEVM User Guide

The Texas Instruments LMX8410LEVM evaluation module helps designers evaluate the operation and performance of the LMX8410L device (a high-performance, wideband demodulator with integrated synthesizer). The evaluation module routes the critical signals from the LMX8410L to SMA connectors at the board edges, which allows testing the full functionality of the device. Included with the EVM is a programming module that connects to the computer through USB. The LMX8410LEVM has an on-board TPS7A8801 device to help provide 5-V and 3.3-V rails from just one power source. An on-board 100-MHz oscillator is also running by default to allow users to quickly evaluate the internal synthesizer without needing to provide a reference input source.

#### 1 Introduction

#### 1.1 **Evaluation Kit Contents**

- LMX8410LEVM
- USB2ANY (contains 10-pin programming cable, programming module, USB cable)

#### 1.2 Recommended Lab Test Equipment

- Signal Generator 1: •
  - Used to generate RF input signal.
  - Able to provide 4 to 10 GHz output.
- Signal Generator 2 (optional):
  - Used to generate external LO signal.
  - Able to provide 4 to 10 GHz output.
- Spectrum Analyzer:
  - Used to detect IF output.
  - Able to detect up to 1.5GHz signal.
- Power Supply:
  - Default option (on board LDO): 5.3V supply voltage and up to 1A current.
  - Split supply option (bypass LDO): Two channels are required. The 5V channel draws about 0.14 A and the 3.3V channel draws up to 0.65A depending on mode options.

#### 2 Hardware Setup




Figure 1. Setup Diagram for LMX8410L in Internal LO Mode




Figure 2. Setup Diagram for LMX8410L in External LO Mode

If you choose to evaluate the LMX8410LEVM with its internal synthesizer (internal LO mode), see Figure 1. If you choose to evaluate the LMX8410LEVM with an external LO signal (external LO mode), refer to Figure 2.

- 1. USB2ANY programmer:
  - a. Connect the USB2ANY module through USB cable to computer.
  - b. Then connect the 10-pin cable from USB2ANY module to LMX8410LEVM header (J13).
- 2. Power supply:
  - a. Single supply option (default):
    - Set current limit to 1 A. •
    - Set voltage to 5.3 V.
    - Connect the power supply output to SMA connector J1.
  - b. Split supply option (bypassing LDO):
    - Bypass the LDO by moving R36 to the position of R37 (R36 is 0 Ohm resistor).
    - Remove R42 and R43 so the LDO outputs are disconnected.
    - Connect the 3.3 V power supply output to the SMA connector J2.
    - Connect the 5 V power supply output to the SMA connector J1.



- 3. RF input:
  - a. Connect RF input signal to port J11.
  - b. For two-tone measurements such as IP2 and IP3, it is recommended to use -10dBm RF input and 17MHz tone separation. IF the RF input level is too high, non-linearity may occur and results can be inaccurate; if RF level is too low, the spurs can easily be buried below noise floor. For the choice of tone separation, avoid using multiple of OSCin for internal LO mode because on-board coupling with OSCin may add flickering behaviors.
- 4. LO modes:
  - 1. Internal LO mode:
    - There is an on-board oscillator (Y1), which provides 100 MHz reference for the LMX8410L internal synthesizer.
    - To accurately measure the positions of spurs, bypass the on-board oscillator by moving R23 and R24 to the positions of R21 and R22 (R23 and R24 are 0 Ohm resistors) and removing R27. Then use 10 MHz reference output from Signal Generator as OSCin (reference for internal synthesizer). Inject the OSCin signal through ports OSCINP (J3) and OSCINM (J4). Synchronize the signal generator and spectrum analyzer.
  - 2. External LO mode:
    - Connect the LO signal input to connectors LO\_M (J5) and LO\_P (J6) through a balun.
    - Make sure that there are no pull-up resistors at the positions of R54 and R55. (If you never modified the board then don't worry about it.)
  - 3. To see the VCO output of internal LO:
    - In order to see the output of internal synthesizer, two 50 Ohm pull-up resistors are needed at the positions of R54 and R55.
    - The output can then be detected from connector J5 and J6.
- 5. IF output:
  - a. J7 and J8 are I channel IF differential outputs; J9 and J10 are Q channel IF differential outputs. Keep in mind that it is critical to evaluate differential outputs using baluns. If you evaluate singleended IF outputs, you won't get correct results. For example, the noise figure measured through single ended output will be higher because noise from IF\_P and IF\_M are not all uncorrelated.
  - b. Note that IF gain bandwidth is DC to 1350MHz. Complex bandwidth is 2700MHz. The performances vary with IF frequency. Refer to typical performance plots in datasheet for more information.

# 3 Software Setup


- 1. Click Request and download the TICS Pro software from this link: http://www.ti.com/tool/ticspro-sw
- 2. Run the TICS Pro software.
- 3. From the top menu bar click "Select Device"  $\rightarrow$  "Demodulator"  $\rightarrow$  "LMX8410L"
- 4. From the top menu bar click "Default configuration"  $\rightarrow$  Default mode.
- 5. Go to "LO" tab in the navigation pane on the upper left.
  - For internal LO mode, go to "Main Setup". In the drop-down box select either "Internal LO Poly to Mixer" or "Internal LO Div2 to Mixer". Go to "LO (MHz)", type in the LO frequency you want (4 to 10 GHz), then hit Enter. The correct internal LO configurations will automatically be set up. Note that the default reference frequency for integrated synthesizer is 100MHz. If you modified the board and use other OSCin frequency, say 10MHz, then put down the correct number below "Fosc (MHz)".
  - For external LO mode, inject your own LO signal then go to "Main Setup". Select "External LO to Mixer".
  - To view VCO output of internal synthesizer, follow the instructions in Section 2. Then go to "Main Setup". Select "internal LO only" and enter the desired LO frequency below "LO (MHz)"
- 6. Go to the "Mixer" tab in the navigation pane to configure the IF amplifier common mode voltage, DC offset correction, and IMRR calibration. For more instructions on these topics refer to the datasheet.

**NOTE:** Check out the register descriptions in the bottom left pane of TicsPro.




Figure 4. Top Layer (Composite View)






Figure 5. Ground (Mid Layer 1)




Figure 6. Mid Layer 2






Figure 7. Mid Layer 3




Figure 8. Mid Layer 4






Figure 9. Bottom Layer (Composite View)

For clarification, any software or software tools provided with the EVM ("Software") shall not be subject to the terms and conditions set forth herein but rather shall be subject to the applicable terms that accompany such Software
  - 1.2 EVMs are not intended for consumer or household use. EVMs may not be sold, sublicensed, leased, rented, loaned, assigned, or otherwise distributed for commercial purposes by Users, in whole or in part, or used in any finished product or production system.
- 2 Limited Warranty and Related Remedies/Disclaimers:
  - 2.1 These terms do not apply to Software. The warranty, if any, for Software is covered in the applicable Software License Agreement.
