

This user's guide describes the characteristics, operation, and use of the LMP92064EVM evaluation board. It also discusses how to set up and configure the software and hardware for a typical operation. Throughout this document, the terms *evaluation board*, *evaluation module*, and *EVM* are synonymous with the LMP92064EVM. This user's guide also includes printed circuit board (PCB) layout drawings, an electrical schematic, and a bill of materials for the EVM.

1 Overview

The Texas Instruments LMP92064EVM evaluation module (EVM) helps designers evaluate the operation and performance of the LMP92064. The LMP92064 is a precision, low-side, digital current sensor and voltage monitor with a digital SPI interface. The LMP92064 features a current sense and a voltage sense channel, which are sampled simultaneously by independent 12-bit ADC converters.

1.1 LMP92064EVM Kit Contents

Table 1 lists the contents of the LMP92064EVM kit and Figure 1 shows all the included hardware. The EVM board contains one LMP92064 device in a low-side configuration for current sensing and voltage monitoring. The EVM comes pre-assembled with a 0.05Ω sense resistor (0.5W), bypass capacitors, test points and connection terminals. The USB2ANY board and the adaptor are required to communicate with the EVM from a PC running the evaluation software.

This section describes the connectors, components and test points used for the proper operation of the LMP92064EVM board.

2.1 Analog Power Supply Input - VDD and AGND

The analog supply pin of the device is connected to the VDD terminal of the EVM and the analog ground plane of the EVM is connected to the AGND terminal. These turrets should be used to connect an external voltage source to power the analog circuitry. There is a 10 μ F tantalum capacitor and two ceramic capacitors with values of 0.1 μ F and 10 pF on the VDD line. The analog supply should be operated between 4.5V and 5.5V.

2.2 Digital Power Supply Input – VDIG and DGND

The digital supply pin of the device is connected to the VDIG terminal of the EVM and the digital ground plane of the EVM is connected to the DGND terminal. These turrets should be used to connect an external voltage source to power the digital circuitry. There is a 10µF tantalum capacitor and two ceramic capacitors with values of 0.1 µF and 10 pF on the VDIG line. The digital supply should be operated between 4.5V and 5.5V.

2.3 Current Sense Resistor and Sense Terminals

The EVM board has placeholders for a current sense resistor, providing options for either through-hole or surface mount resistors. The large pads are bare copper to allow mounting various sizes and shapes of resistor, as well as providing heat dissipation. The board comes pre-assembled with a 0.05Ω sense resistor (0.5W).

The larger inner holes are for optional pin socket receptacles to allow easy swapping of through-hole resistors for prototyping.



For off-board current sense resistors, the sense lines can be connected to the SENSE+ and SENSEterminals (removing the on-board sense resistor). It is recommended for these wires to be twisted to prevent noise and electromagnetic interference (EMI) pickup.

Load ground currents should be kept off the board. Load current should be returned directly to the power supply terminals and not through the evaluation board grounds.

2.4 Voltage Sense Resistors and Terminals

The EVM provides two resistors, R11 and R12, as means of sensing the voltage on a bus connected to the BUS+ terminal. The resistor values of R11 and R12 should be selected according to the voltage on the bus that is to be monitored, considering the maximum input range of the Voltage Sensing Channel, which is 2.048V.

$$(INVP - INVG) = V_{BUS} \times \frac{R11}{R11 + R12} \le 2.048V$$

The EVM comes pre-assembled with values of R11 = $2k\Omega$ and R12 = $30 k\Omega$.

2.5 Optional Input Filtering

The optional R1, R2, R3 and R4 resistor pads are provided to add, in conjunction with C1 and C2, EMI/noise filtering to the input. Series resistors or series inductors can optionally be connected to these pads. To maintain a continuous solid copper path between the shunt and the inputs of the amplifier, the resistor pads have shorting traces across them. To use these pads, the shorting traces must be cut before installing the resistors.

To maintain accuracy, these resistors should be of equal value and well matched, as they are in series with the device's internal resistors and will affect the device's specifications. The values of these resistors should be kept as low as possible and should not exceed a few hundred ohms.

Pads C1 and C2 are provided for optional EMI rejection. For RF/EMI protection, values in the 10 pF to 100 pF range are recommended. It is also possible to use the resistor pairs R1/R2 and R3/R4 with the capacitors C1 and C2 to create a first-order low-pass filter in the signal path.

Keep in mind that, creating an AC filter of reasonable cut-off frequency with resistor values below a few hundreds of ohms, the capacitor values will become quite large.

2.6 Input Sense Test Points – TP4 and TP5

These standard 0.1" headers allow probing the input signals or applying test voltages. TP4 is connected to the Current Sensing Channel and TP5 is connected to the Voltage Sensing Channel.

2.7 Reference Test Point – REF TP6

There is a test point connected to the reference pin of the LMP92064. The reference pin is not intended to drive other circuitry.

2.8 Reset Switch – SW1

This switch is used to perform a hardware reset on the LMP92064. The combination of R10 and C10 is used to smoothen the falling edge of the reset pulse generated when releasing the switch.

2.9 Serial Peripheral Interface (SPI) Bus Test Point – DEBUG TP8

This standard 0.1" header allows probing the SPI bus. The SPI bus consists of an active-low chip select (CSB) line, a serial clock (SCLK) line, a serial data output (SDO) line and a serial data input (SDI) line. There is an additional reserved line (RSV) that is not part of the SPI interface.

2.10 SPI Series Resistors

Resistors are placed in series with the CSB, SCLK, SDI and SDO digital lines to clean the edges of the fast transitions and prevent the digital signals from creating noise that can affect sensitive internal analog nodes. Refer to the Schematic for the component values. The value of these resistors should be limited to below a few hundred ohms, otherwise the digital communication may become unreliable.

2.11 Interface Connector – J8

J8 is used to connect the LMP92064EVM to the USB2ANY board. The interface is used to access the device registers and to read the conversion data from the LMP92064. An adaptor board is required between the EVM and the USB2ANY board.

2.12 Ground Test Points – GND TPx

There are ground (GND) test points distributed around the board for ease of probing: TP1, TP2, TP3, TP7 and TP9.

3 LMP92064EVM Software Installation

The latest software version for the LMP92064EVM can be downloaded from the Texas Instruments website at http://www.ti.com/product/Imp92064. You must install the software before you connect the LMP92064EVM via the USB2ANY board to your PC.

To install the LMP92064EVM software:

- 1. Navigate to http://www.ti.com/product/Imp92064, scroll down to the "Software" section and download the latest LMP92064 Evaluation Software.
- 2. Unzip the downloaded file into a known directory and run the "setup.exe" file located in [Unzip location]\LMP92064EVM_Software_vXX\Installer\Volume\
- 3. Follow the on-screen instructions by clicking the "Next" button to install the software.
- 4. When the installation is finished, click the "Finish" button.
- Before launching the LMP92064EVM software, connect the USB2ANY board to a USB port of your PC. Go to your computer's "Device Manager" and find "MSP430-USB Example" (see Figure 12). Right-click on it and choose "Update Driver Software".

 In the next screen, select the "Browse my computer for driver software" option. Navigate and select the Driver folder located in the directory where the LMP92064 evaluation software was decompressed.

7. If prompted with a warning window, select "Install this driver software anyway" for Windows to proceed with the installation.

 Close the installation window when it is completed. The device manager should now display an "MSP430 Virtual COM Port" item followed by a COM port number. Take note of this port number as it will be required to connect to the device from the LMP92064EVM Software.

CAUTION

Do not exceed the power rating of the sense resistor. For the pre-assembled 0.05Ω sense resistor, keep the load current below 3A at all times.

4.1 Required Equipment

- 1. 1x Power supply (20V, >1A)
- 2. 1x Power supply (5V, >25 mA)
- 3. 2x Digital multi-meter (4.5 digit or better)
- 4. 1x 20Ω power resistor (>25W) or a programmable load sinking 1A
- 5. Misc. test clamps for connections

4.2 Connections

- 1. With the output disabled, connect the positive terminal (+) of the first power supply (V_{S1}) to the load and the negative terminal (–) to the SENSE- terminal of the EVM. Configure the supply's output to 20V and the current limit to 1.01A.
- 2. Additionally, connect the positive (+) terminal of the first power supply to the BUS+ terminal of the EVM.
- 3. Connect the other end of the load to the SENSE+ terminal of the EVM.
- 4. With the output disabled, connect the positive terminal (+) of the second power supply (V_{s2}) to the VDD and VDIG terminals of the EVM and the negative terminal (–) to AGND and DGND. Configure its output to 5V and the current limit to 20mA.
- 5. Connect the positive (+) terminal of the first digital multimeter (DMM1) to **incp** on TP4; connect the negative terminal (–) to **incn.**
- Connect the positive (+) terminal of the second digital multimeter (DMM2) to invp on TP5; connect the negative terminal (-) to invg.
- 7. Insert J8 into the adaptor and into the USB2ANY board's connector (do not plug the USB cable to the PC yet). See Figure 16 for reference.

4.3 Power-up Sequence

- 1. Enable the output of V_{S2} (previously configured to 5V).
- 2. If using a programmable current load, configure it to sink 1A and enable its output.
- 3. Enable the output of V_{S1} (previously configured to 20V).
- 4. Connect the USB cable from the USB2ANY board to the PC.

NOTE: Heating of the load and sense resistors may cause drift between measurements.

- 5. Read the voltage from DMM1; ideally the voltage should be around 50mV, depending on the accuracy of the load and the tolerance of the 0.05Ω sense resistor.
- 6. Read the voltage from DMM2; ideally the voltage should be around 1.25V, depending on the accuracy of the voltage divider of R11 and R12.



4.4 Launching and Running the Software

The LMP92064EVM GUI can be run from the Start Menu; by default, it is located in a folder called LMP92064. Launching the software will take you to the main window of the GUI.

1. Enter the serial port number found previously in the "Device Manager" (e.g. COM3) and click on the CONNECT button. If the EVM is found, the GUI returns a "Connect Successful!" message.

2. Go to the "**Graph**" tab and click on the "**Start Graph**" button to begin capturing and plotting data. By default, the Y-axis units are set to Output Code.

- 3. Click on "Stop Graph" to stop capturing and plotting data.
 - (a) Voltage Channel: For a 1.25V input, the ideal output code of the Voltage Channel is 2500 (decimal). The output code of the voltage channel can be calculated as:

$$INV_{CODE} = (invp - invg) \times \frac{4096}{V_{REF}}$$

Where $V_{REF} = 2.048V$.

(b) Current Channel: For a 50 mV input, the ideal output code of the Current Channel is 2500 (decimal). The output code of the current channel can be calculated as:

$$INC_{CODE} = (incp - incn) \times \frac{4096 \times Gain}{V_{REF}}$$

4.5 Power-down

- 1. Go back to the "**Main**" tab and click on the "**STOP**" button to disconnect the COM port and stop the execution of the GUI. Close the application. Disconnect the USB cable from the PC (or from the USB2ANY board).
- 2. Disable the output of V_{S1} (the 20V power supply).
- 3. If using a programmable load, disable its output.
- 4. Disable the output of V_{S2} (the 5V power supply).

5 Other Software Features

5.1 Registers Tab

The "**Registers**" tab provides access to the registers of the LMP92064 to execute read and write commands. Refer to the latest datasheet for details about each register.

Note that register 0x0000 - CONFIG_A is a buffered register. Writing a value to this register moves the data into a buffer, and in order to move this data to the real register location, a write to the 0x000F - REG_UPDATE register is required.

5.2 Graph Tab

The "**Graph**" tab allows capturing and displaying data from the Voltage and the Current channel simultaneously. By default, the Y-axis scale is set to ADC Codes, but it can be configured to display the data in milli-volts (mV) by enabling the "**Y-axis in mV**" check-box. This is an ideal analog-to-digital conversion assuming no accuracy errors.

A data capture is started clicking on the "**Start Graph**" button and is stopped by clicking on the "**Stop Graph**" button. The data can be saved into a comma-separated value (CSV) file by enabling the "**Save to File**" check-box. When starting the data capture, you will be prompted to select a location and filename to save the data. Data is always saved as ADC output codes in HEX format.

The data capture software uses an internal time trigger, collecting blocks of 10 current and voltage data samples every 500µs. An external trigger can be used with a slight modification:

- 1. Connect a 2 kHz or slower clock (3.3V compliant) on the RSV pin of TP8.
- 2. Enable the "External Trigger" check-box and start the data capture.

Data is captured at every falling edge of the trigger pulse.
