LP5813-12 Evaluation Module



Description

The LP5813/12 Evaluation Module showcases all the features of the LP5813 and LP5812 4 × 3 matrix RGB LED driver with autonomous control. The difference between 2 devices is with or without synchronous boost function. Both LP5813 and LP5812 are placed on 1 board, please select the device which is needed to be evaluated by USB2ANY connector and jumper setting. And please select the right EVM version according to different package (WSON/WCSP). The graphical user interface or GUI called LP581x GUI is used to interface with USB to the EVM by the USB2ANY interface adapter.



1 Evaluation Module Overview

1.1 Introduction

The LP5813/LP5812EVM can be converted for testing the LP5811/LP5810, which are from the same device family, by removing the factory-installed device (U1/U2) and replacing with the LP5811/LP5810 counterpart. When testing the LP5811 device, select the direct mode jumper setting and corresponding tag from the menu on the GUI start page to start evaluation.

This user's guide describes the characteristics, setup, and usage of the LP5813/LP5812 evaluation module (EVM). The LP5813/LP5812EVM helps the user evaluate the features of the Texas Instruments LP5813 synchronous boost 4 × 3 matrix RGB LED driver and LP5812 4 × 3 matrix RGB LED driver, which integrate autonomous control.

1.2 Kit Contents

The LP5813/12EVM kit includes the following materials and is illustrated in Figure 1-1.

- LP5813/LP5812 evaluation module
- USB2ANY interface adapter with ribbon cables and USB cable

1.3 Specification

The evaluation module provides several inputs. The inputs are I2C signal input and power supplies for Vin. Vin is provided by an external power supply or a USB2ANY interface adapter.

1.4 Device Information




Figure 1-2. LP5813 Simplified Schematic

The LP5813-12EVM is used to evaluate the characteristics, operation, and usage for LED driver LP5813/ LP5812. The LP5813 device is a high-performance and small-size device, which integrates synchronous boost and autonomous engine, with time-cross-multiplexing (TCM) structure. LP5813 can drive up to 12 LED dots with only 4 output pins. The difference between LP5813 and LP5812 is that LP5812 does not have boost function. Typical application for LP5813 is shown in Figure 1-2.

2 Hardware

2.1 Setup

This section describes how to set up the LP5813-12EVM properly. Items from the following list are required to begin evaluating the LP5813/LP5812:

- Computer
- LP5813-12EVM
- USB2ANY interface adapter




Figure 2-1. Hardware Connection

In the default jumper setting, the board can be evaluated by USB2ANY power directly and does not need an external power supply. Setup connection is demonstrated in Figure 2-1. The setup procedure is as follows:

- 1. Connect the USB2ANY with the LP5813-12EVM using the ribbon cable.
- 2. Make sure all jumpers are properly set under the appropriate operating conditions. See more details in Jumper Information.
- 3. Plug the USB cable into the USB port on the computer.

2.2 Jumper Information

Note

Only one device can be evaluated at a time. Select LP5813/LP5812 by the USB2ANY connector and jumper setting.

If LP5813 is under test, then please plug ribbon cable to USB2ANY 13 connector.

If LP5812 is under test, then please plug ribbon cable to USB2ANY 12 connector.

On the default jumper setting, users can evaluate LP5813 under the conditions below:

- Vin is provided by 3.3V from USB2ANY(Don't need external power supply).
- Synchronous boost is enabled.
- 4-SCAN TCM mode (Drive 12 LED dots with 4 outputs).




Figure 2-2. Default Jumper Setting




Figure 2-3. LP5813 Direct Mode and Enable Boost without External Power Supply

Figure 2-3 shows the jumper setting for LP5813 in Direct mode and enable boost function without external power supply.

Under this condition, the device needs to be powered by Vout instead of Vin.




Figure 2-4. LP5813 4-SCAN TCM Mode and Disable Boost with External Power Supply




Figure 2-5. LP5812 4-SCAN TCM Mode without External Power Supply




Figure 2-6. LP5812 Direct Mode without External Power Supply

Note




Figure 2-7. 3-SCAN Mix-Drive Mode

If the user wants to evaluate LP5813, then please connect J13-J16 and disconnect J33-J36. Each output from LP5813/LP5812 cannot be connected to both J5 and J1. For example, if the user wants to use Mix-Drive mode with 3-SCAN, and chose OUT3 as direct drive, then please connect OUT3 to J1 and OUT0/OUT1/OUT2 to J5. Please see Figure 2-7 for more details.

2.3 Power Supply

If the input current need to be measured, then an external VIN/VCC supply is recommended during evaluation.

- 1. Connect the USB2ANY to the LP5813-12EVM using the ribbon cable.
- 2. Connect a 1.8-5.5V external power supply to the VIN_EXT/VCC_EXT terminal (TP1 for LP5813/TP5 for LP5812) and connect the switching jumper (J2/J4) to VIN_EXT.
- 3. If the user wants to evaluate LP5813 but disable the boost function, then please provide power supply from Vout instead of VIN.
- 4. Plug the USB cable into the USB port on the computer.




Figure 3-1. Gallery Page

After the Gallery page, click the *download* button to install the offline version to the user's computer. See Figure 3-1.




Figure 3-2. Setup Wizard

Follow the setup wizard to install the LP581XEVM-GUI successfully. See Figure 3-2.

3.3 Graphical User Interface (GUI) Guidance




Figure 3-3. Status Bar

The LP581x GUI is a convenient tool to control and evaluate all functions of LP581x family. Open the LP581x.exe file and plug the USB cable into the USB port of the computer. The GUI automatically connects with the LP5813-12EVM. Figure 3-3 illustrate the status bar showing the connection status at the bottom of GUI. Hardware Connected shows in the status and the indicator in the USB2ANY stops blinking when successfully connected. Click the *connection* button to connect or disconnect the LP5813-12EVM with the GUI.

If the USB2ANY has been used to evaluate other EVMs and updated by other firmware version (such as, 2.8.2.0), then the correct firmware version must be updated into USB2ANY. Follow the instructions shown in the GUI when plugging in the USB cable to update the firmware successfully. See Figure 3-4.

If the USB2ANY has not been previously used to evaluate any EVM before, then an unknown version firmware is detected by GUI. When the update firmware notification shows up, follow these steps.

- 1. Unplug the USB cable (do not click the UPDATE button).
- 2. Press the BSL button inside USB2ANY, then plug in the USB cable.
- 3. Click UPDATE button.

Start Page




Figure 3-5. Start Page

Different device variants in the LP581x family are selected from the *Start Page*. The default setting of EVM is for LP5813, so to begin evaluation, select the *LP5813* tab then click the *EXPLORE* button to begin evaluation. See Figure 3-5.




Figure 3-6. Hardware Setup Page

After clicking *EXPLORE* button, the GUI helps navigate users to the *Hardware Set-up* page. Click *FINISH* button when the hardware has been set properly. See Figure 3-6.

Home Page




Figure 3-7. Home Page

Figure 3-7 shows the I2C address selected in the Home page. Click the Configure & Connect button to connect the USB2ANY with the LP5813-12EVM. The I2C protocol with broadcast chip address is the default. Users can also choose the I2C independent address depending on the IC which is under evaluation. For example, the default jumper setting is used for LP5813A, so choose 0x14 as the independent I2C address or use broadcast mode.

Click the START button below the DRIVE MODE & LED CONTROL block to enter the Drive Mode Page while every individual register is configured in the REGISTER MAP page.




Figure 3-8. Drive Mode Page

In the Drive Mode page, users can configure the scan mode for LP5813/LP5812, and the jumper setting for the scan mode configuration is shown on the preview window. See Figure 3-8.

Mode Select Page




Figure 3-9. Mode Select Page

Set the operation mode for every LED pixel in the LED mode select page. See the details in this page in Figure 3-9.

- 1. Chip Enable button: Click this button to enable device at the beginning of evaluation.
- 2. Update Command: Click this button to update all the Device Configuration Register values.
- 3. LED Select: Before setting operation mode for LEDs, one or multiple LEDs (Shift + select for multiple LED selections) must be selected first.
- 4. Mode Selection: This part includes LED enable/disable, LED operation mode (manual/auto), PWM dimming scale (linear/exponential), PWM phase align (forward/middle/backward).




Figure 3-10. Device Configuration Page

- 5. Device Configuration: Click this button to navigate to the Device configuration page. See Figure 3-10.




Figure 3-11. Manual Mode Configuration Page

Set the analog dimming (dot current) and PWM dimming (manual PWM) value for every LED which is configure to manual mode. See Figure 3-11.

After the manual mode LED brightness are configured, click *NEXT* button to navigate to Auto Mode Configuration page.




Figure 3-12. Animation Engine Pattern

This page is used to configure the animation engine of each device. One animation engine pattern is defined as shown in Figure 3-12. Three animation engine units (AEU) and two animation pause units (APU) compose the animation engine pattern. Users can also see more details about the animation engine in data sheet.




Figure 3-13. Auto Mode Configuration Page

All the parameters in the animation engine related register have random value when power up the device, so configure all the parameters before running the animation engine. Figure 3-13 shows the Auto Mode Configuration page.




Figure 3-14. Preview Mode

Users can preview the LED animation pattern by enabling the Preview Mode and click the *SIMULATE* button. See Figure 3-14.




Figure 3-15. Dimming Curve Preview

The dimming curve is also shown under the configuration page. See Figure 3-15.

After making sure all the configurations have been set properly, click the *START* button in the AEU configuration section. The device starts to generate the animation effect desired.

Fault Detection




Figure 3-16. LED Fault Report

The LP5813/LP5812 continually detects the status for every LED dot. Once an open or short failure is detected, the fault status is also be monitored on the GUI. Clicking the fault summary at the right-top of the GUI shows the summary for all fault status (see Figure 3-16). The Clear Short LED and Clear open LED buttons are used to clear related fault flags when the failures are removed.

To have precise detection results, the PWM must be set above 25.




Figure 4-1. Schematic of LED Driver Module




Figure 4-2. Schematic of LED Load Module




Figure 4-3. Schematic of USB2ANY Connector




Figure 4-4. LP5813-12WCSPEVM Top Layer




Figure 4-5. LP5813-12WCSPEVM Bottom Layer
