The LP5861T Evaluation Module showcases all the features of the LP5861T LED matrix driver. The graphical user interface or GUI called LP586x GUI is used to interface with USB2ANY to the EVM. The EVM has SPI and I2C inputs through the USB2ANY interface adapter.

1 Evaluation Module Overview

1.1 Introduction

This user's guide describes the characteristics, setup, and usage of the LP5861T evaluation module (EVM). The LP5861TEVM helps the user evaluate the features of the Texas Instruments LP5861T LED linear driver, which integrates 18 constant current sinks. This user's guide includes hardware setup instructions, graphical user interface (GUI) instructions, printed-circuit board (PCB) layout drawings, a schematic diagram, and the bill of materials.

The LP5861TEVM is used to evaluate the characteristics, operation, and usage for LED linear driver LP5861T. The LP5861T device is a high performance and small-size device, which integrates 18 constant current sinks to drive up to 18 LED dots or 6 RGB LEDs. Every LED dot is supported by 8-bit analog dimming and 8-bits or 16-bits configurable PWM dimming methods, which enable smooth and audible-noise-free dimming control.

This document covers the following topics:

- How to set up the LP5861TEVM hardware
- How to use the LP586x GUI to illuminate LEDs
- Design resources for the LP5861TEVM

The LP5861TEVM can be converted for testing the LP5861, which are from the same device family, by removing the factory-installed device (U1) and replacing with the LP5861 counterpart. When testing the LP5861 device, select the corresponding tag from the menu on the GUI start page to start evaluation.

1.2 Kit Contents

The LP5861TEVM kit includes the following materials and is illustrated in Figure 1-1.

- LP5861T evaluation module
- USB2ANY interface adapter with ribbon cables and USB cable

Full functions for the LP5861T, the performance with RGB LEDs, and some simple animation effects can be easily verified through this kit.

1.3 Specification

The evaluation module provides several inputs. The inputs are I2C, SPI, Vsync, EN, IFS signal input and power supplies for VCC, VLED. External power supply is needed when total current is larger than 400 mA.

1.4 Device Information

The LP5861TEVM showcases the hardware and software capabilities of the LP5861T 18-Channel High-Current LED Driver with 8-Bit Analog and 8-Bit or 16-Bit PWM Dimming. This module can be used for evaluation and for system development utilizing the LP586x GUI application.



2 Hardware

This following chapters describe how to set up the LP5861TEVM properly. Items from the following list are required to begin evaluating the LP5861T:

- Computer
- LP5861TEVM
- USB2ANY interface adapter

2.1 Hardware Setup

In the default jumper setting, the board can be evaluated by USB power directly and does not need an external power supply. Setup connection is demonstrated in Figure 2-1. The setup procedure is as follows:

- 1. Connect the USB2ANY with the LP5861TEVM using the 30-pin ribbon cable.
- 2. Plug the USB cable into the USB port on the computer.

Figure 2-2 shows the default jumper settings.

If maximum current is set above 20 mA, then an external VLED supply is recommended during evaluation since the USB can only provide around 400-mA current. The setup procedure is as follows:

- 1. Connect the USB2ANY to the LP5861TEVM using the 30-pin ribbon cable.
- 2. Connect a 5-V external power supply to the VLED_EXT terminal (see Figure 2-3) and connect the switching jumper (J1) to another side.
- 3. Plug the USB cable into the USB port on the computer.

3 Software

The following sections describe how to set up the GUI properly. Items from the following list are required to begin evaluating the LP5861T:

LP586x GUI software

3.1 Software Setup

Download the LP586x GUI installation package (SNVC245) from the LP586x *GUI download link* and all the LP586x family devices can be evaluated by the LP586x GUI. Follow the setup wizard to install the LP586x GUI successfully, see Figure 2-4.

3.2 Graphical User Interface (GUI) Guidance

The LP586x GUI is a convenient tool to control and evaluate all functions of LP586x family. Open the LP586x.exe file and plug the USB cable into the USB port of the computer. The GUI automatically connects with the LP5861TEVM. Figure 3-1 illustrate the status bar showing the connection status at the bottom of GUI. *Hardware Connected* shows in the status and the indicator in the USB2ANY stops blinking when successfully connected. Click the connection button to connect or disconnect the LP5861TEVM with the GUI.

If the USB2ANY has been used to evaluate other EVMs and updated by other firmware version (like 2.8.2.0), then the correct firmware version must be updated into USB2ANY. Following the instructions showed in the GUI when plugging in the USB cable can update the FW successfully, see Figure 3-2.

If the USB2ANY has not been previously used to evaluate any EVM before, an unknown version firmware is detected by GUI. When the update firmware notification shows up, 1) Unplugging the USB cable (do not click the *UPDATE* button); 2) Pressing the BSL button inside USB2ANY, then plug in the USB cable; 3) Clicking *UPDATE* button, see Figure 3-3.

3.2.1 Start Page

Different device variants in the LP586x family are selected from the *Start Page*. To begin evaluation, because we only have LP5861 option in the start page, considering LP5861 and LP5861T have same register configuration, so select the LP5861 tab then click the *EXPLORE* button to begin evaluation, see Figure 3-3.

Note

The difference between LP5861 and LP5861T is LP5861T has larger output current than LP5861 at same MC configuration, so please chose the related value when select maximum current. See more details in Device Configuration.

3.2.2 Home Page

Figure 3-4 shows the interface protocol selected in the *Home* page. Click the *Configure & Connect* button to connect the USB2ANY with the LP5861TEVM. The I2C protocol with 0x10 chip address is the default. Other addresses with 0x11, 0x12, and 0x13 and SPI are also available.

Click the *START* button below the *LED CONTROL* block to set current and PWM for every individual LED. Other configurable functions can also be set through graphical buttons in this page. Predefined animations are performed with the *PATTERN* page while every individual register is configured in the *REGISTER MAP* page.

3.2.3 LED Control Page

Set the color and brightness for every RGB LED pixel in the LED control page. To illuminate one LED with default configuration, use the following procedure and see Figure 3-5.

- 1. Click the *Enable* button to enable the LP5861 in the software.
- 2. Select the LED you want to control.
- 3. Set a color for this LED.
- 4. Click the Set Brightness button to upload PWM value into the device.
- 5. Click the VSync button to active this LED (The default is Mode 3 so the SYNC signal is necessary).

Device Configuration

To improve performance under different applications, first configure some key settings. Select the *DEVICE CONFIGURATION* button to show the detail setting slide, which is illustrated in Figure 3-6. Maximum current (MC) is set here.

Note If LP5861T is under test, then the Global Maximum Current setting is different from the value which is shown on the GUI Device Configuration page. Please select the related value from Table 3-1.

If a high maximum current is set, then an external VLED supply is recommended. The *Data Refresh Mode* settings determine whether a SYNC signal is required to synchronize the PWM change for every LED dot. The *Max Scan Lines* controls select how many scan lines are active. For more information on the functions for other settings, see the *LP5861T 18-Channel High-Current LED Driver with 8-Bit Analog and 8-Bit or 16-Bit PWM Dimming*.

Note

For LP5861T/LP5861, only one scan line is available.

Evaluating de-ghosting and low brightness compensation are configured here.

Custom LED Setting

Before setting color and brightness for RGB LED, one or multiple LEDs (Shift + select for multiple LED selections) must first be selected. In the *CUSTOM* tag, set the color in color selector on the right side, see Figure 3-7. Brightness is used to adjust the PWM for all 3 dots in one RGB LED. For some high requirement applications, dot current can adjust white balance for every RGB LED.

Note

If the LP5861T is under test, then the actual output current (IOUT) for each channel is calculated by formula below:

 $IOUT = (MC_LP5861T / MC_LP5861) \times Iout$

For the MC_LP5861T and MC_LP5861 value, please see details in Table 3-1.

Software

Global and Group Setting

Figure 3-8 illustrates the *GLOBAL* tab where color current for RGB groups and global PWM for all LED dots are set. Figure 3-9 illustrates the GROUP tab where every LED dot can be configured to three groups arbitrarily, while the PWM for the same group can be changed synchronously.

Fault Detection

The LP5861T continually detects the status for every LED dot. Once an open or short failure is detected, the fault status is also be monitored on the GUI. Clicking the warning bar near an abnormal LED shows the fault details, as illustrated in Figure 3-10. Clicking the fault summary at the right-top of the GUI shows the summary for all fault status (see Figure 3-11). The *Clear Short LED* and *Clear open LED* buttons are used to clear related fault flags when the failures are removed.

To have precise detection results, the current for every LED dot must be set above 0.5 mA and the PWM must be set above 25%, due to the parasitic capacitor induced from the LED. A current that is too small leads to abnormal LSD results.

3.2.4 Pattern Page

Six predefined patterns can be performed in pattern page, see in Figure 3-12. Select one pattern and click the *Play* button to display the animation. Speed and color are set at the right side. Before evaluating the patterns, first reset the LP5861TEVM board if some values are already set in LED control page.

3.2.5 Register Map Page

Figure 3-13 illustrates how all registers are displayed in the register map page, where register address, value, and description are provided. Modify every register value by writing a HEX value directly into the *Value* column, or by double-clicking the corresponding single bit in the *Bits* column to flip the value. The modified value is effective immediately if *Immediate Write* is selected from the drop-down menu at the top right. When *Deferred Write* is selected, the modified value does not take effect until the user clicks the *WRITE REGISTER* button.

When *Auto Read* is enabled, the value of all registers is read automatically and the interval for every read cycle can also be set. When *Auto Read* is off, click *Read Register* to read the value from the selected register, and click *Read all Registers* to read all registers manually.
