

## ***SGI EVM Hardware Manual***

---

### **ABSTRACT**

This document describes the hardware architecture of the SGI Evaluation Module (EVM) (Part # TMDSSGI-EVML138) that is based on the Texas Instruments OMAP-L138 processor.

The SGI platform is designed for development and test of smart grid applications including: data concentrator, power protection/monitoring, power analytics, industrial circuit breaker and proprietary/broadband power line communication markets. It is intended to provide reference software and hardware components to engineers and help speed up the development process of smart grid applications. The SGI platform is based on the Texas Instruments OMAP-L138 DSP+ARM Multicore System-on-Chip (SOC) processor that includes the ARM9™ processor, a floating/fixed-point C674x DSP, and peripherals integrated in a single system-on-chip (SoC).
